Meanwhile, there are some issues that are both important and urgent. One day longer is one too much. Meanwhile, there are some issues that are both important and urgent. One day longer is one too much. They have the potential to anger or inflame the people they affect—sentiments that can translate into strong opinion in the poll surveys, or in the polls.

One such issue is the water shortage now being experienced in Metro Manila. That there could be a shortage is not far-fetched. After all, summer has crept in, and we are told the El Niño phenomenon promises considerable damage not only to lifestyles but livelihoods.

What most Metro Manilans were surprised about, however, was the sudden—unannounced—drop in the water level at the La Mesa Dam. As of Monday morning, that level has dropped to 68.93 meters Monday morning, lower than the 69.02 meters the previous day, and the lowest it has gone in 12 years. Normal water level is 79.30 to 79.60 meters.

This led to unannounced water service interruptions across the metro, leaving residents desperate—and angry.

Presidential Spokesman Salvador Panelo says the government will swiftly act to address the problem, possibly through cloud seeding over the affected areas, and marvels at how nobody but him seems to have thought of this.

But more than the inducing rain, the government must take charge of the situation by providing information to residents on projected water levels, service interruption schedules, and regularly fielding water trucks to help restore a semblance of normalcy and predictability to affected communities.

It should hold the water service providers accountable for their failure to act in a timely manner to help residents deal with the shortage.

Water is not just any product or commodity. It is as intimately linked with daily life, perhaps more than any other utility. If water stops flowing from people's taps, it won't be long before patience drains, as well.

GUN-FOR-HIRE KILLED IN ENCOUNTER WITH POLICE

Camp Vicente Lim, Laguna - A gun-for-hire and a high-value target drug suspect in the province of Laguna was killed in an armed encounter with the police Tuesday morning.

Laguna Provincial Director Sr Supt Rleazar Matta in his report to CALABARZON Regional Director Chief Supt Edward Carranza identified the suspect as Ali Basher Adiong alias Boss Tan and a resident of Happy Valley in Canlubang, Calamba City.

Matta said with coordination with the Philippine Drug Enforcement Agency (PDEA), the operation was conducted by the drug enforcement unit of Calamba City Police Station at the residence of rhe suspect.

During the drug transaction, the suspect sensed that he was transacting with a police officer who posed as poseur-buyer and drew his firearm and shot the police poseur-buyer which caused the latter to fall on the ground.

This prompted other officers to return fire.

The police poseur-buyer and the suspect were brought to Global Hospital for immediate medical attention; however, Adiong was declared dead on arrival.

On the other hand, PO1 Mark Anthony Burgos did not sustain an injury or gunshot wound due to the bulletproof vest worn during the operation.

Senator Win Gatchalian has urged government agencies involved in the planning and implementation of the Duterte administration's Build, Build, Build (BBB) program to extend greater transparency on foreign loan agreements the government entered into to bankroll the various infrastructure

The Gatchalian-led Senate Committee on Economic Affairs opened an inquiry into the status, sustainability, and risk of the multi-billion projects under the BBB program by scrutinizing the complete terms and conditions of loans entered into by the government.

During the hearing, Gatchalian called the attention

To DOF, NEDA: Extend greater transparency on infra loans

"I'm putting myself on the shoes of a common person who wanted to understand not only about the projects, but also how the projects came about, how the loans were evaluated, and what are the thought processes that went through the loans," he said.

The lawmaker stressed that greater transparency is proper, especially at a time when "there are lots of allegations flying here and there" on the supposed preferential treatment and one-sided provisions for a certain group or country.

"We hope to see that the principle of responsible lending and borrowing have been observed, not just to correct public perception but to further strengthen our economic partnership with our development partners," he said.

The DOF, for its part, assured Senator Gatchalian that the loans agreements that the government signed went through rigorous vetting process. Contrary to reports, Finance Assistance Secretary Maria Edita Tan informed the Senate Committee on Economic Affairs that the government has secured more loans from Japan than in China.

Data from the DOF shows that at least five ongoing, big-ticket infrastructure projects are being financed through loans secured from Japan. On the other hand, China and South Korea are each financing two on-going infrastructure projects under the BBB program of the Duterte administration.

Meanwhile, the NEDA reported that it had identified and approved at least 75 Infrastructure Flagship

Projects (IFPs) out of the thousands of projects listed in the Public Investment Program (PIP). Out of the 75 projects, the NEDA said 59 IFPs are funded by the Official Development Assistance.

In terms of project cost, the largest allocation goes to Japan/Asian Development Bank with P628 billion, equivalent to 30 percent. China meanwhile constitutes 25 percent of the total project cost or equivalent to P515 billion.

Before the hearing ended, Gatchalian requested both the DOF and NEDA to submit several documents, including complete copies of the loan agreements and simulation of the debt to GDP ratio, among

That's why I want to urge NEDA and DOF to really practice greater transparency. I know that there is an FOI directive, but it doesn't bar us from practicing greater transparency beyond what the FOI requires. This is to really make the public appreciate that everything that is being done here is for the greater interest of our constituents," he said.

Miguel Aquintey, the police community precinct (PCP) commander, sleeping while on duty while Patrolman Mark Capili was spotted not wearing the proper uniform. Duty Police Non-Commissioned Officer Patrolwoman Lauren Digo Lubigan was absent from her post during the inspection.

PETITONER, through undersigned counsel, unto this Honorable Court, most respectfully alleges that:

- 1. Petitioner, Eleazar A. Del Rosario, is a Filipino citizen, of legal age, married, and a resident of 81 Toclong II-A, Imus, Cavite for more than six (6) months until to this date. He may be furnished with processes of the Honorable Court at said address.
- 2. Respondent, Ma. Mignon Mendoza, is a legal age, married and a resident of Blk. 6, Lot 2, Phase 4, Soldier Hills 4, Molino, Bacoor, Cavite where she may be served with notices and processes of this Honorable Court.
- 3. Petitioner and Respondent met sometime in 1988 when Respondent visited her mother (who was known to Petitioner as Ate Lulu and will be referred here by the same name for brevity) who was then working at Philippine Tourism Authority (PTA for brevity). Petitioner who likewise worked at the same agency saw the Respondent when the latter once visited Ate Lulu and he immediately got attracted to her. It was love at first sight.
- 4. About June of 1988, Ate Lulu was able to help Respondent get a job at PTA as a timekeeper in one of the projects of the office which was the renovation of the Multi-purpose Hall. This gave Petitoner a window of opportunity to woe the heart of herein Respondent.
- 5. The Petitioner and Respondent immediately hit it off and soon enough, they became sweethearts. However, their relationship was kept secret because the Respondent did not want her mother to know. Her mother was very strict and did not want her to settle down immediately.
- 6. They have kept their relationship secret from the prying eyes and gossipy lips of the people around them. Not long enough, on or about November of 1989, Respondent proposed to Petitioner that they get married secretly. The latter agreed since he loved Respondent so much that he was willing to their marriage kept secret.
- 7. Since they were no longer minors, they were able to secure the necessary requirements for marriage. And so they got married on January 5, 1990 at Imus, Cavite.

- 8. On the day of their marriage, none of their family members were present as desired by the Respondent. They only had their close friends to witness their marriage. Their parents and family members were alienated to the fact of their marriage.
- 9. Since no one in their families knew of the marriage, they both went to their respective homes after tying the knot.
- 10. This marriage was however discovered by the mother of Respondent, Ate Lulu. It happened when the parties applied for the housing loan and Ate Lulu learned that Petitioner was Respondent co-Maker. Ate Lulu inquired from the Parties how they were able to secure a loan from GSIS with Petitioner as co-maker of her daughter if they were not married.
- 11. Realizing that lying further would be pointless, Petitioner and Respondent admitted to Ate Lulu that they had a secret marriage. The latter cried in disappointment.
- 12. The Parties then moved into the house they bought and lived together as husband and wife. They lived happily together at first and soon, they were blessed with

their first daughter whom they named as Marielle Ysabel M. Del Rosario. She was born on August 1, 1991.

- 13. Then on April 1, 1996, they were again blessed with their second child, Juan Miguel Mendoza Del Rosario.
- Attached herein as **Annex "C"** is a copy of the Certificate of Live Birth of Juan Miguel Mendoza Del Rosario.
- 14. Petitioner and Respondent then worked at the same agency but in different departments. They always went to the office back home together except when Respondent had a meeting outside of their work.
- 15. Their relationship was plagued with different problems and that included Petitoner's concern that Respondent was too friendly with men. When confronted, Respondent would always counter that she has no brother so she was close to boys.
- 16. The Respondent brought her work at home even on weekends and spent meager amount of time with her family and that forced them to hire a nanny to take care of their children. It even appeared to Petitioner that Respondent preferred work than her children and him.
- 17. The Petitioner also sometimes had to do the household chores such as going to the wet market, cooking, and taking care of their children because the Respondent did not have time to those. Petitioner patiently tried to understand Respondent's choices but still, thse decisions and traits of the latter sparked arguments between them.
- 18. The only aspect where Respondent was very much willing to share equally is in the expenses of their family; as to time, she obviously had more for her work.
- 19. In the year 1997, the attitude of the Respondent or her lack of time for the family worsened when he was assigned as Project Engineer in the Boracay Environmental Infrastructure Project. During this time, Petitioner suspected that Respondent was having an affair.
- 20. The Respondent always had out-of-town meetings after office hours and spent more time travelling than to be with her family. The Petitioner once talked to the respondent about this problem but the Respondent did not want to discuss
- 21. In 1999, the Parties were blessed with their third child, Eins Miguel Mendoza Del Rosario.

- 22. Before the birth of their third child, the Petitioner asked the Respondent to resign from her work so she can look after their children but she did not agree. She insisted if she stops working, it will be hard for them to support their children. The Petitioner did not buy this excuse because he believed he could provide for the family.
- 23. It frustrated the Petitioner that Respondent did not have time for their children and yet, she would use more of her time off work to meet and travel with her college schoolmates. One time, Respondent told the Petitioner that she and her college friends planned to go to Hong Kong. The Respondent asked the Petitioner to go with them but the Petitioner declined the offer and explained that he would rather spend the money for their children instead of this travel expenses.
- 24. The Respondent still went to Hong Kong. When Petitioner picked her up at the airport when she returned, she was alone. He asked the Respondent where her friends were and she said that they are already left but the Petitioner had a bad feeling about it.
- 25. One day, while the Petitioner was alone in their house, he went through Respondent's documents. That was when the Petitioner found out that the Respondent was with her ex-boyfriend when she went to Hong Kong and even stayed in the same hotel room together. Since the Petitioner did not want to ruin their family, he kept to himself whatever he discovered including his hurt feelings. It was then that Petitioner also realized that for a while now, Respondent been passive and cold towards him.
- 26. Respondent is used to making decisions without consulting the Petitioner which frustrated the latter such as when she decided that she would go to the US. She applied for a US Visa but got denied twice until she was able to ask from someone she met at work in Boracay for a letter of recommendation. She was given a Visa with multiple entry for ten (10) years.
- 27. One day, the Petitioner received a call from a wom-

an who introduced herself as a wife of Jose Junsay, Respondent's ex-boyfriend and the man who she was with when she went to Hong Kong. The woman told the Petitioner that her husband and the Respondent always met in secret in Boracay before and so pleaded with the Petitioner to do something to stop the Respondent and Jose's affair. This fact learned by Petitioner even made him doubt whether their third child is his.

- 28. Unable anymore to contain his hurt feelings, Petitioner confronted the Respondent who was already giving him cold treatments. This started frequent fights between the Parties which they tried to hide from their children because they did not want their children to be affected by it. The Petitioner hoped that the Respondent would stop her wrong doings but she still continued her affair with Jose.
- 29. In 2006, the Petitioner's father suffered from stroke which prompted the former to stay at his parent's house so he can take care of his father. He explained to his kids why he could not go home yet. When Petitioner's father died in May 24, 2006, he still stayed in his parent's house to be with his mother. Despite his failure to stay at their house during those times, he always fetched his children every Saturdays so he can have time with and brought them back to their mother on Sundays.
- 30. The Respondent went back to America on or about 2006 and 2007. Petitioner was surprised when their family friend, Agnes Bocar, asked the Petitioner one time if he would sign a divorce paper should Respondent send one. He simply said yes as he was already tired of Respondent's unfaithfulness. After some months, Agnes Bocar asked again the Petitioner if he would let Mimi take all their children to America and he said yes if that is what the children wanted.
- 31. Petitioner was not surprised anymore when the divorce paper came. This confirmed his suspicion that the Respondent had been seeing or living with her ex-boyfriend Jose Junsay everytime she goes to the United States and had in fact planned on settling down there. He knew that he could no longer do anything to change Respondent's mind so he signed it reluctantly. Then the State of Nevada granted the Divorce Decree.

Attached herein as **Annex "E"** is a copy of the Divorce Decree

- 32. The Petitioner did his best to keep his family together but the Respondent had her plans with another man. Despite signing the divorce paper, Petitioner still hoped that Respondent would return to him and their children. He was however disappointed.
- 33. Prior to the filling of this Petition, Petitioner consulted psychiatrist in the name of Dra. Ma. Bernadette Arcena for the psychiatric evaluation which was made into writing.

Attached herein is a copy of the Psychiatric Evaluation as Annex 'F"

- 34. Based on the psychiatric evaluation, both Petitioner and Respondent were found to be suffering from psychological incapacity which makes their marriage void ab initio or void from the beginning.
- 35. According to Dra. Arcena, the Petitioner met criteria of a person with both narcissistic and obsessive-compulsive personality traits. Quoting the report from psychiatric evaluation as to Petitioner's narcissistic trait:
- "Petitoner has a grandiose sense of self-importance. He expects the respondent to condone with him and to be more superior than she was. He requires constand admiration and affirmations that he was the more dominant partner. He wanted the respondent to automatically comply with his expectations and demanded her to comply with him.

The petitioner lacks empathy and could not identify with the hurts and the pains that the respondent had gone through because of his narcissistic attitude. He showed arrogant and haughty behavior toward his wife."

"The petitioner is preoccupied with mental and interpersonal control, is excessively devoted to work and productivity and showed rigidity and stubbornness and inflexibility.

His obsessive-compulsive personality disorder had its antecedence of having a harsh discipline during his childhood years.

The root causes of the petitioner's personality disorder are the problems that lie on having a strict paternal figure, rigid parental-child relationship which created confusion that lead to his dominance, his narcissistic need and his preoccupation to interpersonal control, showing rigidity and stubbornness.

The obsessive-compulsive personality traits came also from having a and a rigid environment in their growing up vears."

- 36. The Respondent likewise was found to have a personality disorder and Dra. Arcena said in her report that:
- "..the following symptoms were met by the respondent: having unstable relationships with the petitioner, impulsivity, ambivalence, unstable self-images and difficulty in controlling anger."
- 37. Accordance to Dra. Arcena, the personality disorder of the petitioner existed prior to the onset of the marriage. It is characterized with a lifetime course, poor prognosis and outcome. It has no treatment modalities and has no cure. Such disorder is deeply rooted in Petitioner's psyche with its existence during childhood stage and carried on until the present time.
- 38. Further, Dra. Arcena found that "the personality disorder of the petitioner run a long-lasting, lifetime and permanent course. It is a grave and chronic enough such that it created a disastrous outcome of the marriage of the petitioner and the respondent. The personality disorder of the petitioner made him incapacitated to comply with his marital obligations to his wife.
- 39. Based on the report, "the PERSONALITY DIS-ORDERS of the petitioner and the respondent destroyed their marriage. Both were unable to fulfill their marital obligations because of their personality disorders." As such, the Psychiatrist recommended that the marriage of the petitioner and the respondent be annulled.
- 40. Hence, Petitioner filed this Petition for Nullity of Marriage under Article 36 of the Family Code which states that:
- 'ART. 36. A marriage contracted by any party who, at the time of the celebration, was psychologically incapacitated to comply with the essential marital obligations of marriage, shall likewise be void even if such incapacity becomes manifest only after its solemnization."
- 41. The parties have no properties owned in common and all of their children are already of majority age.

PRAYER

WHEREFORE, Petitioner most respectfully pray of this Honorable Court to render judgment declaring null and void ab initio the marriage of the Parties, on the ground that the Petitioner and/or the Respondent is/are Psychologically Incapacitated to perform the essential marital obligations which makes their marriage void ab initio.

Other reliefs just and equitable under the premises are likewise prayed for.

DOF Economic Bulletin on Foreign Direct Investment

Net FDI in 2018 amounted to US\$9.8 billion, US\$200 million short of the US\$10 billion mark and 4.4% lower than the net long-term capital inflows in 2017. The increase in debt instruments moderated the impact of the decline in equity and reinvestment of earnings.

Equity investments fell by 33.3%, reversing the surge of 31.1% it registered in 2017, the rise and fall of which, in turn, comes from the electricity sector. On the one hand, the rise in inflows to the electricity in 2017 is explained by the US\$1.3 billion investment made by a consortium of foreign investors in Energy Development Corporation (EDC), an operator of geothermal fields. On the other hand, in 2018 San Miguel Corporation acquired Masinloc Group's power assets for US\$1.9 billion.

The FDI decline in the Philippines in 2018 mirrors the global FDI decline during the past two years. In 2017, it dropped 6.5% to US\$1.9 trillion. In the first half of 2018, it dropped by a heftier 44% to just US\$432 billion. This is due to slowdown in the world economy brought about by US-China

trade war, Brexit, and slowdown in worldwide growth. (Table 2)

· A regression analysis on determinants of FDI flows to the country confirms that FDI is sensitive to world GDP, Philippine real GDP growth and real US Treasury Bond rate. The drop in world GDP by 13.8 bps shaved

Philippine FDI flows by 0.1% of GDP. Likewise, the 35 bp increase in the US T-Bond rate reduced Philippine FDI by 0.44% of GDP. Without these two negative factors, Philippine FDI would have grown by an estimated 0.24% of GDP (or US\$790 million).

This Pancitan does not only cater to the stomach but it also caters to the heart. Alip shares that the Pancitan is part of the institution's efforts to eradicate poverty in the Philippines. "This is our way of creating a market for our microfinancing clients, bybringing together our clients' resources and skills for them to generate more income and eventually save and plan for their future," said Alip.

The raw materials of all the pancit recipes available at MLNI's Food Park come's from the microfi-

nance clients of CARD MRI. "From the noodles to vegetables to the meat being used are produced or being sold by the clients of CARD," said Alip, adding that they always ensure that the services and products available in every microfinance clients of CARD are maximized and given the chance to be promoted in wider scale markets.

- A World Bank study shows that foreign capital should be attracted to enhance more competition and efficiency in the economy.
- The drop in 2018 FDI is just a temporary phenomenon brought about by the uncertain world economic environment. FDI flows will recover when world conditions are better. Meanwhile, the Philippines should implement reforms for a better investment environment.
- More red tape should be drastically cut. In this regard, TradeNet.ph, among other digital infrastructure, should already be implemented. This will facilitate exports of manufactures.
- · Foreign ownership restrictions should be eased. The Philippines has one of the most restrictive investment regimes in Asia.

For example, the Public Service Act (PSA) should be amended to redefine public utilities and enhance competition to bring down costs.
