## **EDITORYAL:**

# **Vater accountability**

President Rodrigo Duterte has every reason to get mad at the top officials of the Metropolitan Waterworks and Sewerage System and the two private concessionaires in Metro Manila. He has threatened to fire regulators for failing to anticipate and do something about the water supply problem in Metro Manila, and terminate the contracts of the two concessionaires in the capital region.

Some 1.2-million households in the east zone of Metro Manila served by Manila Water Co. Inc. have suffered service interruptions for the last two weeks that the company blamed on low water levels at the La Mesa Dam as a result of the El Niño phenomenon. Customers of Maynilad Water Services Inc. in the west zone, in contrast, experienced no interruptions. President Duterte, perhaps, should start dismissing the key executives of the MWSS, which has taken the responsibility of providing new water sources to augment the supply from Angat and Ipo Dam in Norzagaray in Bulacan province. The government agency did nothing to correct the situation. It knew very well that relying on a single water system was risky and

President Duterte must appoint more competent officials at the MWSS, preferably those with engineering and management backgrounds, to deal with the water deficit woes. MWSS administrator Reynaldo Velasco should be blamed for his inaction and failure to identify a new water source since taking over the chief post of the water agency. The MWSS chief has also shown his early bias for the China-funded Kaliwa Dam project over the proposal of a Japanese company. He readily declared that Kaliwa Dam would be cheaper than an alternative Japanese proposal, without acknowledging the social costs cited by the indigenous residents of General Nakar and Infanta towns in the province of Quezon.

Local government units, in the meantime, should implement the Rainwater Collector and Springs Development Act of 1989, which requires the construction of rainwater collectors in every barangay to prevent flooding and ensure the supply of clean water during dry seasons. Rainwater harvesting is done successfully in other countries and there is no reason

The landmark Philippine Innovation Act, once signed into law, will soon enhance the global competitiveness of micro, small, and medium enterprises, Senator Win Gatchalian said

Gatchalian issued the statement after the bicameral conference committee convened to iron out the disagreeing provisions of Senate Bill No. 1355 and House Bill No. 8715.

"In the Philippines, where 99.6 percent of businesses are considered MSMEs, the role of innovation cannot be overemphasized. Unlike large companies that have ready access to funding and resources, MSMEs are at a disadvantage because of their size and problems of access to resources and markets. Innovation will enhance the global competitiveness of these MSMEs," said Gatchalian, who sponsored the measure as chairman of the Senate Committee on Economic Affairs

The Philippine Innovation Act states that the State "shall place innovation at the center of its development policies, guided by a clear and long-term set of goals that will

take into consideration the key advantages of the country and the opportunities in the regional and global economic arena. As such, it shall harness innovation efforts to help the poor and the marginalized and to enable MSMEs to be a part of the domestic and global supply chain."

The proposed law also provides for the creation of a National Innovation Council (NIC), chaired by the President, to develop the country's innovation goals, priorities, and long-term national strategy.

the President, to develop the country's innovation goals, priorities, and long-term national strategy.

"May the future National Innovation Council, using a whole-of-government approach, develop a National Innovation Agenda and Strategy Document that will deepen and accelerate inclusive innovation programs that target the poorest of the poor. May this Council faithfully administer the National Innovation Fund, with the end in view of changing the rules of the game: a Filipino with an innovative idea that will benefit the poorest of the poor will no longer have to look elsewhere for funding or support," Gatchalian said.

Gatchalian added that the Philippine Innovation Act "will steer the adoption of a clear and inspiring long-term view of the country's innovation vision, improve the governance framework for innovation, and mandate key reform areas toward building a thriving and inclusive national innovation ecosystem."

Moreover, the lawmaker said the landmark legislation was inspired by the vision to put innovation at the center of the country's national development policies, and make innovation a major driver of economic development that will build the foundation of a more inclusive future.

"It is my hope that the Philippine Innovation Act will compel us to place innovation at the center of our development policies to enable the country to move as a coherent whole. I hope that it will be implemented to develop a thriving and growth-fueling national innovation system, cure our highly fragmented innovation governance system, and mobilize and strengthen partnerships between and among all the actors in the innovation system." he said.

Gatchalian previously called on the government to develop a culture of innovation in order to boost the country's economic competitiveness following the Philippines' rise in ranking in the latest Global Competitiveness Report of the World Economic Forum.

PETITONER, through undersigned counsel, unto this Honorable Court, most respectfully alleges that:

- 1. Petitioner, Eleazar A. Del Rosario, is a Filipino citizen, of legal age, married, and a resident of 81 Toclong II-A, Imus, Cavite for more than six (6) months until to this date. He may be furnished with processes of the Honorable Court at said address.
- 2. Respondent, Ma. Mignon Mendoza, is a legal age, married and a resident of Blk. 6, Lot 2, Phase 4, Soldier Hills 4, Molino, Bacoor, Cavite where she may be served with notices and processes of this Honorable Court.
- 3. Petitioner and Respondent met sometime in 1988 when Respondent visited her mother (who was known to Petitioner as Ate Lulu and will be referred here by the same name for brevity) who was then working at Philippine Tourism Authority (PTA for brevity). Petitioner who likewise worked at the same agency saw the Respondent when the latter once visited Ate Lulu and he immediately got attracted to her. It was love at first sight.
- 4. About June of 1988, Ate Lulu was able to help Respondent get a job at PTA as a timekeeper in one of the projects of the office which was the renovation of the Multi-purpose Hall. This gave Petitoner a window of opportunity to woe the heart of herein Respondent.
- 5. The Petitioner and Respondent immediately hit it off and soon enough, they became sweethearts. However, their relationship was kept secret because the Respondent did not want her mother to know. Her mother was very strict and did not want her to settle down immediately.
- 6. They have kept their relationship secret from the prying eyes and gossipy lips of the people around them. Not long enough, on or about November of 1989, Respondent proposed to Petitioner that they get married secretly. The latter agreed since he loved Respondent so much that he was willing to their marriage kept secret.

Ate Lulu inquired from the Parties how they were able to secure a loan from GSIS with Petitioner as co-maker of her daughter if they were not married.
- 11. Realizing that lying further would be pointless, Petitioner and Respondent admitted to Ate Lulu that they had a secret marriage. The latter cried in disappointment.
- 12. The Parties then moved into the house they bought and lived together as husband and wife. They lived happily together at first and soon, they were blessed with

- 14. Petitioner and Respondent then worked at the same agency but in different departments. They always went to the office back home together except when Respondent had a meeting outside of their work.
- 15. Their relationship was plagued with different problems and that included Petitoner's concern that Respondent was too friendly with men. When confronted, Respondent would always counter that she has no brother so she was close to boys.
- 16. The Respondent brought her work at home even on weekends and spent meager amount of time with her family and that forced them to hire a nanny to take care of their children. It even appeared to Petitioner that Respondent preferred work than her children and him.
- 17. The Petitioner also sometimes had to do the household chores such as going to the wet market, cooking, and taking care of their children because the Respondent did not have time to those. Petitioner patiently tried to understand Respondent's choices but still, thse decisions and traits of the latter sparked arguments between them.

- 20. The Respondent always had out-of-town meetings after office hours and spent more time travelling than to be with her family. The Petitioner once talked to the respondent about this problem but the Respondent did not want to discuss

- 23. It frustrated the Petitioner that Respondent did not have time for their children and yet, she would use more of her time off work to meet and travel with her college schoolmates. One time, Respondent told the Petitioner that she and her college friends planned to go to Hong Kong. The Respondent asked the Petitioner to go with them but the Petitioner declined the offer and explained that he would rather spend the money for their children instead of this travel expenses.
- 24. The Respondent still went to Hong Kong. When Petitioner picked her up at the airport when she returned, she was alone. He asked the Respondent where her friends were and she said that they are already left but the Petitioner had a bad feeling about it.
- 25. One day, while the Petitioner was alone in their house, he went through Respondent's documents. That was when the Petitioner found out that the Respondent was with her ex-boyfriend when she went to Hong Kong and even stayed in the same hotel room together. Since the Petitioner did not want to ruin their family, he kept to himself whatever he discovered including his hurt feelings. It was then that Petitioner also realized that for a while now, Respondent been passive and cold towards him.
- 26. Respondent is used to making decisions without consulting the Petitioner which frustrated the latter such as when she decided that she would go to the US. She applied for a US Visa but got denied twice until she was able to ask from someone she met at work in Boracay for a letter of recommendation. She was given a Visa with multiple entry for ten (10) years.
- 27. One day, the Petitioner received a call from a wom-

an who introduced herself as a wife of Jose Junsay, Respondent's ex-boyfriend and the man who she was with when she went to Hong Kong. The woman told the Petitioner that her husband and the Respondent always met in secret in Boracay before and so pleaded with the Petitioner to do something to stop the Respondent and Jose's affair. This fact learned by Petitioner even made him doubt whether their third child is his.

- 28. Unable anymore to contain his hurt feelings, Petitioner confronted the Respondent who was already giving him cold treatments. This started frequent fights between the Parties which they tried to hide from their children because they did not want their children to be affected by it. The Petitioner hoped that the Respondent would stop her wrong doings but she still continued her affair with Jose.
- 29. In 2006, the Petitioner's father suffered from stroke which prompted the former to stay at his parent's house so he can take care of his father. He explained to his kids why he could not go home yet. When Petitioner's father died in May 24, 2006, he still stayed in his parent's house to be with his mother. Despite his failure to stay at their house during those times, he always fetched his children every Saturdays so he can have time with and brought them back to their mother on Sundays.
- 30. The Respondent went back to America on or about 2006 and 2007. Petitioner was surprised when their family friend, Agnes Bocar, asked the Petitioner one time if he would sign a divorce paper should Respondent send one. He simply said yes as he was already tired of Respondent's unfaithfulness. After some months, Agnes Bocar asked again the Petitioner if he would let Mimi take all their children to America and he said yes if that is what the children wanted.
- 31. Petitioner was not surprised anymore when the divorce paper came. This confirmed his suspicion that the Respondent had been seeing or living with her ex-boyfriend Jose Junsay everytime she goes to the United States and had in fact planned on settling down there. He knew that he could no longer do anything to change Respondent's mind so he signed it reluctantly. Then the State of Nevada granted the Divorce Decree.

Attached herein as **Annex "E"** is a copy of the Divorce Decree

- 32. The Petitioner did his best to keep his family together but the Respondent had her plans with another man. Despite signing the divorce paper, Petitioner still hoped that Respondent would return to him and their children. He was however disappointed.
- 33. Prior to the filling of this Petition, Petitioner consulted psychiatrist in the name of Dra. Ma. Bernadette Arcena for the psychiatric evaluation which was made into writing.

Attached herein is a copy of the Psychiatric Evaluation as Annex 'F"

- 34. Based on the psychiatric evaluation, both Petitioner and Respondent were found to be suffering from psychological incapacity which makes their marriage void ab initio or void from the beginning.
- 35. According to Dra. Arcena, the Petitioner met criteria of a person with both narcissistic and obsessive-compulsive personality traits. Quoting the report from psychiatric evaluation as to Petitioner's narcissistic trait:
- "Petitoner has a grandiose sense of self-importance. He expects the respondent to condone with him and to be more superior than she was. He requires constand admiration and affirmations that he was the more dominant partner. He wanted the respondent to automatically comply with his expectations and demanded her to comply with him.

The petitioner lacks empathy and could not identify with the hurts and the pains that the respondent had gone through because of his narcissistic attitude. He showed arrogant and haughty behavior toward his wife."

"The petitioner is preoccupied with mental and interpersonal control, is excessively devoted to work and productivity and showed rigidity and stubbornness and inflexibility.

His obsessive-compulsive personality disorder had its antecedence of having a harsh discipline during his childhood years.

The root causes of the petitioner's personality disorder are the problems that lie on having a strict paternal figure, rigid parental-child relationship which created confusion that lead to his dominance, his narcissistic need and his preoccupation to interpersonal control, showing rigidity and stubbornness.

The obsessive-compulsive personality traits came also from having a and a rigid environment in their growing up years."

- 36. The Respondent likewise was found to have a personality disorder and Dra. Arcena said in her report that:
- "..the following symptoms were met by the respondent: having unstable relationships with the petitioner, impulsivity, ambivalence, unstable self-images and difficulty in controlling anger."
- 37. Accordance to Dra. Arcena, the personality disorder of the petitioner existed prior to the onset of the marriage. It is characterized with a lifetime course, poor prognosis and outcome. It has no treatment modalities and has no cure. Such disorder is deeply rooted in Petitioner's psyche with its existence during childhood stage and carried on until the present time.
- 38. Further, Dra. Arcena found that "the personality disorder of the petitioner run a long-lasting, lifetime and permanent course. It is a grave and chronic enough such that it created a disastrous outcome of the marriage of the petitioner and the respondent. The personality disorder of the petitioner made him incapacitated to comply with his marital obligations to his wife.
- 39. Based on the report, "the PERSONALITY DISORDERS of the petitioner and the respondent destroyed their marriage. Both were unable to fulfill their marital obligations because of their personality disorders." As such, the Psychiatrist recommended that the marriage of the petitioner and the respondent be annulled.
- 40. Hence, Petitioner filed this Petition for Nullity of Marriage under Article 36 of the Family Code which states that:
- 'ART. 36. A marriage contracted by any party who, at the time of the celebration, was psychologically incapacitated to comply with the essential marital obligations of marriage, shall likewise be void even if such incapacity becomes manifest only after its solemnization."
- 41. The parties have no properties owned in common and all of their children are already of majority age.

#### PRAYER

WHEREFORE, Petitioner most respectfully pray of this Honorable Court to render judgment declaring null and void ab initio the marriage of the Parties, on the ground that the Petitioner and/or the Respondent is/are Psychologically Incapacitated to perform the essential marital obligations which makes their marriage void ab initio.

Other reliefs just and equitable under the premises are likewise prayed for.

#### Strong PHL-China ties to help both countries defy economic headwinds

BEIJING-Finance Secretary Carlos Dominguez III has said here the heightened cooperation between the Philippines and China, which both displayed resilience in

the face of global challenges to growth, will help the two countries defy threats to sustained economic expansion in the years ahead.

Dominguez said that like China, the Philippines is well-positioned to maintain its high growth trajectory "long into the future," such that the government has retained as its fighting target a gross domestic product (GDP) expansion rate of 7 percent for 2019 despite adverse trends in the global economy.

The source of the Philippines' growth, he said, is its increasing shift from consumption to investments, which is well supported by a growing domestic market as well as more intensive regional integration among Southeast Asian

Dominguez said that on the part of China, it is preparing to overcome the forecast of slower global growth this year by a policy mix that includes an expansionary monetary policy and boosting domestic consumer demand.

"The economies of our two countries are leading the region in growth. Both our economies demonstrated resiliency in the face of global challenges. With our increased cooperation, we can better defy the adverse developments at the global level and continue our rapid expansion to benefit our peoples," said Dominguez, who delivered the keynote speech during the Philippine Economic Briefing (PEB) held at the Shangri-La Hotel.

He said with "the rest of the region depending much on China's impressive growth, we are confident this great nation will continue its remarkable economic transformation."

This PEB event, which aims to showcase the Philippines' strong economic performance and its myriad investment opportunities, brought together some 500 investors and infrastructure players based in China. A previous PEB was held in

Shanghai in 2017.

Dominguez said the Philippines has as a "secret weapon" to offset the effects of the expected global economic slowdown its US\$170 billion "Build, Build, Build" infrastructure program, which has numerous multiplier effects, such as creating new jobs and new businesses as well as lowering the costs of transporting goods and people across its islands.

For this ambitious infrastructure program of President Duterte, he said the Philippines has China to thank for its generous support that has "greatly helped push our infrastructure projects forward.&duot:

According Dominguez, the "Build, Build, Build" program "works in concert" with China's much larger and broader Belt and Road Initiative (BRI), a program spearheaded by Chinese President Xi Jinping that aims to strengthen infrastructure, trade and investment links across the region.

"Improved interconnections between the economies in this part of the world will raise all ships. We look forward to a seamless network for the flow of goods, the exchange of best practices and boundless cooperation in the coming years," Dominguez said.

He said that on top of a tax reform program that has already provided increased spending power for Filipinos and improved revenue flows for the government to help finance its infrastructure program, the Philippines is also banking on its greatest asset—a very young and skilled workforce—to power its economy over the long term.

"Our median age is 24. This is significantly lower than the median ages in the more mature economies of Northeast Asia. A large wave of skilled workers enters the workforce over the next few years," Dominguez said. "We have invested heavily in our education system to prepare young Filipinos to be globally competitive. Last year, we passed a law granting free tuition fee in state-owned colleges and universities.

Aside from this "unspoken factor," Dominguez said the Philippines has several other positive developments working in its favor to ensure the economy's long-term high and inclusive growth.

These include sustained foreign direct investment (FDI) inflows, which have reached a combined US\$20.1 billion in 2017 and 2018: the rest of the Duterte administration's tax reform packages, including the reforms in corporate taxation and the rationalization of fiscal incentives; the government's high expenditure effort; aggressive infrastructure spending that is expected to reach 7 percent FROM PAGE 1

of GDP by 2022; a strong fiscal position with manageable debt and high international

reserves: and game-changing policy reforms to eliminate red tape, improve the ease of doing business and encourage more investments

"I invite all our friends here in Beijing and [across] China to take a closer look at how things have improved in the Philippines. Examine the many opportunities for investment," Dominguez said.

He cited the increased bilateral trade between the Philippines and China totaling US\$43 billion in 2018: the high number of Chinese tourist arrivals to the Philippines

at 1.38 million last year; China's rising investments of US\$479 million, which made it the Philippines' second largest source of FDIs in 2018; the success of the Philippines' maiden issue of renminbi-denominated "Panda" bonds last year: and an agreement between 13 Philippine commercial banks and the Bank of China on the creation of a Philippine Renminbi Trading Community as among the developments that demonstrate the heightened cooperation between the two countries.
