**EDITORIAL:**

**The least it could do**

When they receive their bill in April, customers of Manila Water will find that they will not be charged for their first 10 cubic meters of water consumption in March. Manila Water president and CEP Ferdinand dela Cruz announced this at a press conference Tuesday as he sought to quiet the anger of those in the East service zone that experienced a water shortage in the past few weeks. Severely affected customers will not be charged at all, Dela Cruz said. "Severely affected" is defined as those which had 24-hour water supply interruptions for seven days or more. Dela Cruz acknowledged that he can never fully pay back customers who were inconvenienced by the shortage. But it was more than inconvenience—it was financial or productivity loss as well. For instance, some water-dependent commercial establishments were

not able to operate, or people were not able to work in the same level because they were agitated by the loss of water in the area. The apology and the gesture of waiving charges are most welcome. After all, the bright executives of Manila Water should always be mindful that the business of water is not just any other business. It's a public utility without which individuals, households and industries will not be able to function effectively. Consumers deserve every centavo of the money they will not pay Manila Water next month—they do not owe anybody profuse thanks. It's a penalty that the company has rightfully imposed upon itself. But what customers deserve even better is seamless service regardless of adverse weather patterns or plain poor planning. The summer months loom long and large, compounding the need for reliable water from the tap. Here's hoping there will no longer be a repeat of the nightmarish scenarios that those from the East Zone encountered this month.

Senator Win Gatchalian has reiterated the importance of a sound policy and regulatory framework for electric vehicles (e-vehicles) to usher in the uptake of electric vehicles in the country.

During the Senate Committee on Energy hearing on Senate Bill No. 2137 or the Electric Vehicles and Charging Stations Act, Gatchalian quizzed the Department of Energy's (DOE) long term plan to ensure the promotion of the adoption of electric vehicles and the sustainability of the e-vehicle ecosystem in the long run.

Gatchalian, who chairs the committee, noticed that while the DOE has been promoting the use of e-vehicles, the agency has produced or released only a few policy instruments to support the growth of e-vehicles in the country.

He urged the DOE to craft a roadmap for e-vehicle adoption in the country, in coordination with the Department of Transportation (DOTr), Land Transportation Office, Land Transportation Franchising and Regulatory Board, Metropolitan Manila Development Authority, and other relevant

government agencies.

"Moving forward, we want to see research. Of course, this will not be without opposition. There will be opposition, let's expect that. But we have to clearly explain the advantages of promoting e-vehicles. I expect the DOE – which is a much larger organization – should have that data. Hindi naman ho tayo puwede mag-promote nang wala ho tayong basis," the lawmaker pointed out.

"Iyong advantages ng [e-vehicles], it should be quantifiable, or else, it's very difficult to convince people that this is actually beneficial," he told the DOE.

SBN 2137, in a nutshell, seeks to address the challenges to the development of the electric vehicle industry by instructing the DOE to create an Electric Vehicle Roadmap and distribution utilities to incorporate a Charging Infrastructure Development Plan in their Power Development Plan.

Through his proposed measure, Gatchalian hopes to solve the entire supply chain of e-vehicles, including one of the most important components: the charging stations.

The measure seeks to require private

and public buildings and establishments to have dedicated parking slots with charging stations and mandates open access for the installation of charging stations in gasoline stations.

SBN 2137 also expands non-fiscal incentives – such as exemption from number coding and prioritization in registration – and institutionalizes time-bound fiscal incentives for manufacturers and importers of electric vehicles.

Gatchalian believes that by promoting the use of e-vehicles in the country, the Philippines will become less dependent on oil importations.

"At the same time we would reduce dollar outflows, mitigate greenhouse gas emissions, create more jobs for Filipinos," he said.

The lawmaker pointed out that at present, the transport sector was the biggest contributor to the country's total energy consumption, accounting for more than one-third or 37.2 percent. Data from the DOE shows that the transport sector is also a major consumer of petroleum products, consisting of 25.72% of the total 75,370.50 barrels that were consumed in 2016.

Meanwhile, data provided by the Philippine Statistics Authority (PSA) show that 99.48 percent or 8,039,233 out of 8,081,224 of motor vehicles in the country are run by diesel and gasoline.

## BIR Strike ...

A special team formed recently by the Bureau of Internal Revenue (BIR) to crack down on the illicit tobacco trade will work closely with other government agencies to further step up the Department of Finance (DOF)'s campaign against perpetrators of this scheme.

In a report to Finance Secretary Carlos Dominguez III, the BIR said its Strike Team and other concerned offices of the bureau will actively coordinate with other government agencies "to curtail further the proliferation of the illicit cigarette trade."

BIR Deputy Commissioner Arnel Guballa said at a DOF executive committee (Execom) meeting that as part of these efforts, the BIR Regional Investigation Division assisted a team led by the Bureau of Customs (BOC) last Feb. 9 in seizing and apprehending several unregistered cigarette-making machines and fake stamps inside an illegal cigarette manufacturing facility in Tacloban City.

Guballa also said that at a recent hearing conducted by the Senate ways and means committee, senators had proposed that the BIR be provided with funds to assist the Strike Team in gathering intelligence against illicit tobacco traders.

"They (senators) noticed that we have conducted several raids and apprehensions, and I told the committee that we do not have funds for intelligence (gathering). And

they are willing that, if this universal health care (bill) will be passed, they will give to the BIR some funds for the equipment and the warehouse (for storing seized machines and goods)," Guballa said during the Execom meeting.

In response, Dominguez said that because the BOC is the main investigating body against these illegal activities, the agency should also be given a share of the funding proposed by the senators, because their goal is to strengthen the government's operations against smuggling and tax evasion.

Dominguez has underscored the need for heightened government vigilance against the illicit manufacture and sale of tobacco products, given that the increase in "sin" taxes has incentivized illegal traders to increasingly resort to smuggling and tax evasion.

He said the destruction last January of several machines used in the manufacture of illicitly traded cigarettes forms part of the Duterte administration's relentless campaign against manufacturers of these products as effectively demonstrated in 2017 when the DOF, through the BIR and of BOC, cracked down on the "biggest fish," namely Mighty Corp.

Taking down Mighty Corp. for using counterfeit excise tax

stamps led to the biggest tax settlement ever in the country's history amounting to about P30 billion, forcing the company to get out of the cigarette business.

Moreover, after Japan Tobacco Inc. (JTI) took over Mighty, tobacco excise tax collections increased by at least P2 billion a month.

The contraband destroyed last Jan. 18 in Porac, Pampanga included units and parts of three filter maker machines, two packaging machines, and a cigarette-making machine, along with 484 master cases of various finished cigarette brands, and raw materials used in making cigarettes such as filter rods, tipping papers, packaging foil, acetate tow, and other supplies.

With a single cigarette-making machine capable of producing 20,000 sticks per minute, which is equivalent to about 9.6 million sticks during an eight-hour shift or 480,000 packs per day, the government has effectively blocked attempts of being defrauded of as much as P16.8 million per day of much-needed revenues for human capital development and the "Build, Build, Build" program by destroying these confiscated machines and products, Dominguez said.

## World-class 'urban garden' opens in Dasmariñas City

DASMARIÑAS CITY, Cavite - What used to be an unassuming idle land by the river, measuring more than two hectares in area along Mangubat Avenue here, has now transformed to a world-class "Promenade Des Dasmariñas", a public park where city residents can enjoy, relax, unwind and exercise.

Red Robins Alano, head of city tourism and information office, said Thursday that the park, which opened to Dasmariñas public Tuesday, is now sprawling with landscaped garden, a fountain, cabanas/gazebo and an eye-catching cascading waterfall where each part is "selfie" worthy or "intragamable" -- as how the generation now refers to beautiful places worthy of their self-portrait for sharing in social media.

This "urban" garden aims to bring back the old "promenade" concept, thus the name where people can take a leisurely public walk, bike ride, to

meet or be seen by others, Alano said.

It is open to public from 5 a.m. to 12 midnight every day "ideally for Dasmariñenos for now," and equipped with high definition close circuit television (CCTVs) and with six security personnel making rounds from 6 p.m. to 12 midnight to ensure the public's safety.

"The park will encourage and inculcate to the visitors the virtue of discipline as there will be no trash bins placed within the park premises "so the CLAY GO (Clean As You Go) will be strictly observed and enforced," Alano said.

Bathing in the fountain area is also prohibited. This public park reconfirms anew the unparalleled leadership of Mayor Elpidio "Pid" Barzaga Jr. and his equally hardworking wife, Cavite 4th District Rep. Jennifer "Jenny" Barzaga, whose efforts continue to make the city landmark of progress and excellence in nation-building. (PNA)

# ODA financing on Kaliwa dam project to benefit consumers with cheaper project, financing cost

The use of highly concessional Official Development Assistance (ODA) financing to construct the New Centennial Water Source-Kaliwa Dam Project will benefit Filipino consumers more with cheaper project and financing costs rather than if the project were to go through the Public-Private Partnership (PPP) route, which would entail additional charges passed on to water users so whoever the private proponent will be can recoup its investments, Department of Finance (DOF) Assistant Secretary Antonio Joselito Lambino II has said.

Lambino pointed out that even if going through the PPP route to build the Kaliwa Dam would be at “no cost to the government,” it does not mean “no cost to consumers.”

“The higher project and financing costs of a solicited PPP would have been borne by users, eventually,” Lambino said during a press briefing. “There’s no such thing as free water.”

Lambino recalled that in January 2014, the then-Investment Coordination Committee (ICC) restructured the project components of the Kaliwa Dam and changed the mode of financing from ODA to PPP with an estimated project cost of P18.7 billion. This amount was subse-

quently slashed to P12.25 billion when the National Economic and Development Authority (NEDA)-ICC approved the recommendation of the Metropolitan Waterworks and Sewerage System (MWSS) to revise the project’s funding component. This approval was subsequently confirmed by the NEDA Board, which is chaired by President Duterte.

An ICC document from 2014 stated that under a PPP mode for the Kaliwa Dam project, “amortization payments will be financed through the imposition of a Water Security Charge as a separate line item in the water bill of the consumers,” Lambino said.

Lambino said that when the Duterte administration took over and decided to undertake the project through ODA, the project cost went down from P18.7 billion under a PPP scheme to P12.2 billion. Even if fees and interest payments are taken into account in completing the project through ODA, the cost would still be significantly lower at P14.5 billion compared to the estimated price tag of P18.7 billion under a PPP scheme, he added.

“The ODA has helped us ensure faster implementation and has allowed us to finance the project at rates

lower than the private sector would be able to get,” said Lambino.

As for the unsolicited proposal of the Japan-based Global Utility Development Corp. (GUDC), Lambino noted that it only involved the construction of the Kaliwa intake weir, which is just a portion of the whole project.

“A weir would have made the project incomplete and unable to address the long term needs and the water shortage problems we will continue to face into the future,” Lambino said.

Besides being incomplete, the PPP Center also informed the MWSS leadership in March 2017 that the GUDC’s unsolicited proposal was ineligible under Section 10.3 of the implementing rules and regulations (IRR) of the Build-Operate-Transfer (BOT) law, which states that priority projects shall not be eligible to be accepted as unsolicited proposals, unless involving a new concept or technology, Lambino said.

Moreover, the BOT law also states that any component of an approved project shall not be eligible for any unsolicited proposal, he added. In this case, the ICC already approved the bigger New Centennial Water Source-Kaliwa Dam project in 2014.

According to Lambino, GUDC has been pushing its unsolicited proposal for a mere intake weir as early as 2008, but the government has, since 2013, opted for the construction of a complete dam.

MWSS consultant Engr. Noel Ortigas explained that unlike dams, weirs are dependent on the water flowing from the source, such as a river. “It will only get what is flowing in the river at a particular time. Hence, if the flow rate is low, then the flow of water into the weir is also low,” he said.

The GUDC proposal, which involves building a 7-meter high weir, is also susceptible to the effects of both droughts and flooding, Ortigas added.

In contrast, the 60 meter-high Kaliwa Dam can provide adequate water even during low-flow seasons because it can store water.

Unlike a weir where water has the possibility to overflow, a dam’s overflow is channeled into a spillway to prevent flooding, Ortigas explained.

Moreover, the proposed Kaliwa Dam, he said, conforms to international safety standards, with its design able to withstand an earthquake of “probable maximum magnitude.” (DOF.GOV)

## Construction of CALAEX begins

IMUS CITY, Cavite – The construction of the 27-km. Cavite segment of the 45-km. Cavite-Laguna Expressway (CALAEX) began after the groundbreaking at Alapan II-B village here Wednesday.

Envisioned as the “most advanced” expressway in the country, the Cavite seg-

ment, with an estimated project cost of PHP12 billion, will ensure a safe, efficient and seamless travel for motorists from Kawit town (in Cavite) to the South Luzon Expressway (SLEX) – Mamlasan Interchange. It is expected to cut travel time from 2.5 hours to less than 45 minutes and help decongest approximately 50,000 cars.

At the groundbreaking ceremony, Public Works Secretary Mark Villar said the project is part of the Duterte administration’s masterplan to connect Luzon from north to south, to be called the “Luzon Spine Expressway Network” (LSEN), to increase the current 300-km. high-speed expressway to 1,000 km. by 2022, the end of President Rodrigo R. Duterte’s term.

“We will deliver not just on our promise to solve traffic, but to bring development to our provinces,” Villar said.

The high-speed expressways are not just expected to reduce travel time but, once completed, create a new period of development for the provinces of Cavite and Laguna.

Cavite is now the biggest in terms of population among the country’s provinces, with an estimated 4.1 million people, 2016 data from the Philippine Statistics Authority show.

As Region 4-A (Calabarzon) now accounts for almost 20 percent of the country’s Gross Domestic Product (GDP), the most productive region.

Cavite Governor Remulla

said this “speaks volumes about the dynamism of the government and its private partner.” He said the expressway will connect Laguna and Cavite, and decongest the South Luzon Expressway (SLEX).

The Laguna segment of the CALAEX project is now in full swing which, according to Metro Pacific Tollways Corp. (MPTC) president and Chief Executive Officer, Rodrigo Franco, is expected to open the first section during the third quarter or as early as July this year.

“In two years’ time, we hope the province of Cavite will have a brand new expressway that will connect the existing Cavite Expressway, which is also operated by the Metro Pacific Group,” Franco added.

CALAEX will employ some 1,200 personnel for its Laguna segment and close to 1,300 more for site and office personnel as its Cavite segment progresses. It is part of the network of toll roads that the MPTC is constructing and developing, which will connect to Cavite and the C5-South Link and will make transfers from Laguna, Cavite, Las Piñas, Parañaque, and CP Garcia Ave. seamless.

Other projects under the MPTC’s portfolio are the recently opened Harbor Link Segment 10, North Luzon Expressway (NLEX), Subic - Clark -Tarlac Expressway (SCTEX), and the Cebu-Cordova Link Expressway in the Visayas. (PNA)
