Unravel the passport mess

Filipinos renewing their pre-2010 passports must now present their birth certificates as an extra requirement because the contractor that produced passports "took all the data" when the government terminated its contract, Foreign Affairs Secretary Teodoro Locsin Jr. said last week.

Locsin disclosed the data loss last week on Twitter, after a user on the social media network asked him why he needed to present a birth certificate to renew his passport.

"Because previous contractor got pissed when terminated it made off with data," Locsin replied in his post. "We did nothing about it or couldn't because we were in the wrong. It won't happen again. Passports pose national security issues and cannot be kept back by private entities. Data belongs to the state."

Locsin's post suggested that the contractor that took the data, a reputable French company, was terminated because government officials at the time wanted to make kickbacks

"What I heard and there are so many stories in the affected department they sued us for wrongful termination. In fact it was the most respectable company, foreign, French even. So why? Kaching, Kaching, Kaching, Kaching, Kaching."

"And by the way, why was the previous contractor terminated? New technology? Then demand it to acquire the new technology but leave the job to it. Di ba? But that means no kickback. In short, people made money by changing contractor. Ano pa (What else)? S**t," he said.

While Locsin did not name the French company, news reports say Oberthur Technologies of France won the contract to produce e-passports in 2008. The DFA transferred the production of the passports to APO Production Unit, one of the three government-authorized printers in October 2015.

Jumping to conclusions, opposition Senator Risa Hontiveros

wrongly pinned the blame for the data loss on the Duterte

administration, ignoring the fact that the contract with the French contractor was terminated during the term of

President Benigno Aquino III, with whom she is allied.
She is correct, however, in saying that the data must be retrieved "with the highest sense of urgency" and that the people responsible for such a gross display of incompetence should be held fully resonsible.

The loss of the data, after all, not only inconveniences the

public, but represents a major violation of the privacy of the affected passport holders.

Locsin's response so far has been inadequate.

"I just want it fixed and not repeated," he tweeted. "Redundancy of data was promised by previous contractor but not fulfilled or just denied us. We have no knowledge whatsoever if it has been corrected. Like a cuckolded husband, we are always the last to know."

Beyond tweeting similes, Locsin's job as DFA chief is not only to fix the problem, but to unravel the passport mess: Find out precisely how it came about and who were responsible for it-so we will never again be the last to know.

Senator Win Gatchalian has reiterated his call for the immediate passage of the bill which would require prospective vehicle owners to present proof that they have a parking space for the new vehicle.

Gatchalian, author of Senate Bill No. 201 (SBN), also known as the Proof-of-Parking Space Act, made the call as he threw his support behind the initiative of the Metro Manila Development Authority (MMDA) to impose heftier fines on illegally parked vehicles. The MMDA has recently raised the fine for attended illegally parked vehicles from its original price of P200 to P1,000. Drivers of unattended illegally parked vehicles, on the other hand, will now have to pay P2,000.

The senator believes that the MMDA's initiative to decongest the already crowded streets of Metro Manila will be greatly complemented with the enactment of the Proof-of-Parking Space Act.

Proof-of-Parking Space Act pushed as MMDA hikes illegal parking penalties

"The MMDA's move to impose higher penalties may now prompt motorists to think twice before parking their cars along the streets. However, I believe that we still need a law that will instill a culture of responsible vehicle ownership among Filipinos." the lawmaker said.

"Isinusulong ng SBN 201 or Proof-of-Parking Space Act para maging responsible ang bawat may-ari ng sasakyan. Layunin ng batas na ito na siguraduhin na bago tayo bumili ng sasakyan ay dapat mayroon tayong sariling parking space," he added.

Under the Proof-of-Parking Space Act, individuals and businesses based within Metro Manila would only be allowed to purchase vehicles after the execution of an affidavit confirming that they have acquired, either through purchase or lease, a parking space for the vehicle sought to be purchased.

According to LTO records, the numbers of registered motor vehicles from the year 2015 until 2017 were 10,410,814. There are an estimated 1,000 registrations each day, 600 of which are for newly-purchased vehicles.

The bill also mandates the Land Transportation Office, the Metro Manila Development Authority, and local government units to conduct frequent ocular inspections of major and minor thoroughfares across the National Capital Region to remove illegally parked vehicles and to punish vehicle owners who refuse to comply with the law.

In October, the Senate Committee on Trade, Commerce, and Entrepreneurship created a technical working group to further refine the provisions of the bill.

"With this bill, we hope to make the National Capital Region a more livable place by decongesting the roads of our nation's capital, taking a modest step toward solving Manila's perennial traffic crisis in the process," Gatchalian said.

Go vows...

assured city and village folks
on the speedy reconstruction
of the collapsed 56-year-old
dilapidated Sta. Ana Bridge,
which he has brought to
the attention of President
Rodrigo Duterte and the
Department of Public Works
and Highways (DPWH).

Go on Sunday inspected the damaged bridge with Mayor Loreto Amante, Laguna Gov. Ramil Hernandez, Vice-Gov. Karen Agapay, former Board Member Angelica Jones Alarva and barangay leaders.

"Ayusin natin ito. Kung gusto ninyo overpass ilagay natin (Let's fix this. If you want, we can put an overpass)," Go said in jest, eliciting applause from city and village folks after talking with local officials on putting up a new bridge and not just repair the collapsed structure.

He said construction "as soon as possible" of the bridge is important as this would normalize transportation and mobility of residents in the three barangays and commuters, including the delivery of basic services.

Go also told the city and provincial officials that he would talk to his former colleague in the Cabinet, DPWH Secretary Mark Villar, for project funding by the national government.

Earlier estimates by the local engineering district disclosed that the bridge, which Go said serves as

"Tulay sa Pangulo" (the President's Bridge), would cost around PHP36 million.

He vowed that the President's "Build, Build, Build, Build" project would trickle down to the countryside to speed up inclusive growth and development.

"Rest assured po na iyan ay aking tutukan na magkaroon ng fair share ang Laguna sa "Build Build Build projects" kung sakaling palarin man ako (rest assured that I will focus on Laguna's fair share in the "Build, Build, Build, Build" projects, if I would be fortunate (in my Senatorial bid)," Go said.

He said the President's concern in ensuring the "Build, Build, Build" projects would be in place and "sufficient and equally divided" among the Calabarzon provinces of Cavite, Laguna, Batangas, Rizal and Quezon.

"I'm sure a lot or projects are earmarked in Laguna province. And for my part, I would serve as link to the President whether in a private or public office to help constituents who are in need," Go said, citing his priority agenda to put up several "Malasaki Centers" across the country, if elected to the Senate.

In a media interview, Sta. Ana Barangay Councilor Edwin Gavino said the bridge was constructed in 1963, and this connects the city's three far-flung barangays of San Isidro (Balagbag) and Santisimo Rosario for 56 years now.

He said they have been reporting to the local

engineering office on the dilapidated stage of the bridge until its collapsed last Jan. 6, splitting the bridge in two when a truck loaded with around 36 tons of sand crossed it

He also expressed hope that engineering personnel would expedite the construction as the bridge serves as vital link for transport of agricultural products, passengers and commuters of vehicles plying the route from the city proper to the remote barangays.

Meanwhile, 37-yearold lady guard Baby Cortez, with two children in tow after crossing the bridge, told the Philippine News Agency that village folks hope for government agencies to repair the bridge and ease the daily hassle and hazards they have to go through in crossing the collapsed

"Tulungan ninyo po kami. Grabe and hirap na dinadanas namin. Sana bago mag-eleksiyon, maumpisahan na (please help us, it is so difficult for the daily ordeal we have to go through. We hope the construction would start before the elections)," she appealed.

Cortez cited the affected school children, workers, laborers and commuters whose livelihood, trading of agriculture and farm products and office work have been affected for more than a week now. (PNA)

BACOOR CITY, Cavite -- Bantay Dagat volunteers arrested on Wednesday afternoon two fishermen who allegedly used explosives to catch fish in Bacoor Bay off the waters of Barangay Talaba in this city.

Bantay Dagat is a civilian fisheries patrol force made up of volunteers that keep watch on coastal waters up to 15 kilometers from shore line of coastal communities.

S u p t . V i c e n t e Cabatingan, Bacoor City chief of police, identified the arrested suspects as Jayson Pacleta Reyes, 31 and Gerry Nugid Tulipas, 28, both residents of La Huerta, Paranaque City.

The two suspects were spotted around 3:40 p.m. Wednesday by Bantay Dagat operatives Maximo Cabanag Cadavis Jr. and

Melchor Escario Daigo who decided to make a citizen's arrest. They later turned over the suspects to police authorities.

Reyes and Tulipas who were charged with violation of Republic Act 10654 Section 92A or "Illegal fishing using explosives" are now detained at the city police jail in Barangay Talaba while facing charges for violation of Republic Act 10654. Section 92 of RA 10654 prohibits fishing through the use of explosives, noxious or poisonous substances, or electricity. (Dennis Abrina/ PNA)



MOU for Silang green energy project signed

SILANG, Cavite -- Waste management will no longer be a problem for this municipality after its local government signed a memorandum of agreement (MOU) with Trashtalk Phil. (Waste Management and Green Solution Inc.) for the implementation of a green energy project.

Under the MOU forged on Tuesday, the investor Trashtalk will put up waste-to-energy facilities in Barangay Biluso for the biodegradable-to-energy plant that can be used by households, the national grid or independent power suppliers.

"It's a big help to our town. It will address the pressing waste problem of our town and the whole nation, as well," Mayor Lourdes 'Omil' Poblete said in an interview.

"We want the municipality of Silang to be the first local

IMUS CITY, Cavite --The city's public hospital, Ospital ng Imus (ONI), would be fully operational by Jan. 24.

An advisory from the city mayor's office said the hospital would start admitting patients to its 22 wards and 19 private rooms with 130 beds.

The PHP300 million, three-story hospital, which stands on a donated 4,000 square meter lot, had its soft launch on October 12 last year, with services limited to emergency and outpatient care.

ONI, a level 1 hospital

with major and minor operating capabilities, provides ancillary services such as laboratory, x-ray, and ultrasound.

The new state-of-the-art hospital, the first public hospital in the district, aims to provide quality, affordable and accessible healthcare.

Dr. Edgardo Figueroa, hospital chief, will lead a team of at least 20 doctors, 25 nurses and 15 consultants, including specialists on its services.

There are also plans to construct a Medical Arts Building worth PHP35 million near the hospital. (PNA)

If an individual's highly unfit vision is hindering him from performing tasks, he can register for a PWD ID at the city hall. Applicants are required to bring a recommendation or a certificate of functional limitation due to vision impairment from ophthalmologist to verify the status of being a having a disability.

Under Republic Act 9442, also known as "Magna Carta for Disabled Persons and for other purposes" and also Republic Act 10754, known as "An Act of Expanding Benefits and Privileges of Persons with Disability," the PWDs shall submit an identification card issued by the city or municipal mayor or the barangay captain of the place where the persons with disability resides, the passport of the persons with disability concerned OR their

tation discount fare Identification Card (ID) issued by the National Council for the Welfare of Disabled Persons (NCWDP).

As a PWD, the benefits include:

- 1. Discount and VAT exemption on products and services;
- 2. Educational assistance:
- 3. Express Lane or a special area designated for PWDs;
- 4. Incentives for those taking care of PWDs. Carmen Reyes

Go bats empowerment of barangay tanods vs. drugs, crimes

CAVITE — Former Special Assistant to the President (SAP) Christopher Lawrence "Bong" Go on Tuesday cited the need to empower barangays by allowing them to hire more tanods (village watchmen) as they need.

"Minsan, kulang talaga ang tanod para mapanatili ang kapayapaan at kaavusan sa isang lugar, lalong-lalo na sa mga malalaking barangay at sa mga lugar na sadyang mas maraming kaso ng droga at krimen," Go said during the Ugnayan sa Barangay event held at Queens Barangay Row Central in Bacoor City, Cavite.

For barangay workers and officials, Go said they deserve to have the same benefits that other government employees receive.




