EDITORYAL:

Project of the Century'

The government this week finally broke ground on the P350-billion, 36-kilometer Metro Manila Subway Project, the first-ever underground railway system in the **Philippines**

Nobody will contest the claim of the Department of Transportation that the proposed subway is the project of the century in the Philippines. Its total cost is unparalleled for a single infrastructure project so far. The technology to be used for the project is also unprecedented—tunnel boring machines are being tapped to excavate tunnels using a circular cross-section mechanism.

The subway project is one of the railways being put up in Metro Manila to decongest traffic in the national capital region. The DOTr says it will transform the economic and social landscape of Metro Manila. For one, about 370,000 passengers will benefit from the subway's first year of full operations by 2025. Real estate consultancy Colliers International, meanwhile, said the ground-breaking for the subway's first three stations would benefit the Quezon City property sector over the near to medium term. "In our opinion, the subway should play an important role in dictating private developer strategies in Metro Manila," Colliers said.

A flagship project under the government's 'Build, Build, Build' program, the subway rail is being constructed with a loan from the Japan International Cooperation Agency.

Once completed, it will have 15 stations from Quirino Highway in Quezon City to Naia Terminal 3 in Pasay City and FTI in Taguig City, crossing seven local governments and passing through three Metro Manila's business districts. With a speed of up to 80 kilometers per hour, travel time from Quezon City to Naia Terminal 3 is expected to be reduced to 30 minutes the Transportation department said. The Duterte administration deserves the credit for pushing this type of project as one way of solving the gridlock in Metro Manila. The subway project is a step closer to modernizing the transportation system in Metro Manila and in making the capital region at par with other modern cities in Asia.

Senator Win Gatchalian wants to dig deeper into the operations of underperforming distribution utilities (DUs) in the country amid persistent complaints of rolling brownouts in

several areas in the country.

Gatchalian, chair of the Senate Committee on Energy, recently filed Senate Resolution No. 1022, which directs the conduct of an inquiry, in aid of legislation, on the operations of underperforming DUs in the country and the remedies to hold them accountable.

For the lawmaker, it is high time for Congress to assess whether or not non-performing DUs should continue operating using their franchise by looking at their respective performances

'Various hearings of the Senate Committee on Energy has brought to light the issues surrounding DUs, such as non-compliance with the system loss caps, System Average Interruption Duration Index (SAIDI), System Average Interruption Frequency Index (SAIFI), financial liabilities, in the case of electric cooperatives; and failure to electrify areas within their respective franchises – thereby resulting in

the prejudice of consumers," Gatchalian said in the resolution.

'Given the foregoing shortcomings of DUs, there has been no policy or procedure for DOE (Department of Energy) or ERC (Energy Regulatory Commission) to determine underperforming DUs, whose franchise will be recommended for revocation," he added.

Gatchalian said he received numerous complaints regarding the underperformance of several DUs across the country. Palawan, for example, had experienced an average of 126 power interruptions in 2017, which, according to the lawmaker, was beyond the NEA standard of 25 interruptions per consumer per year.

Citing data from the DOE, Gatchalian also pointed out that 72.6 percent or 449,410 out of 618,600 households in the Autonomous Region in Muslim Mindanao (ARMM) remain without power as of December 31, 2017, making it the top "unelectrified" region in the country.

The DOE and ECs locked horns last month after the former submitted a letter to Speaker Gloria Macapagal-Arroyo recommending the cancellation of the legislative franchises of at least 17 ECs. In its December 2018 report, the National Electrification Administration (NEA) revealed at least 10 of the underperforming ECs are in Luzon while seven others are in Mindanao.

However, the energy department backpedaled on January 30 after it received reports from these electric cooperatives that they had already addressed the issues against them.

Gatchalian said that while he fully supports holding distribution utilities accountable in their services to consumers by reviewing their technical and financial performance, he stressed the need to have a clear policy and procedure on the recommendation for revocation before actually submitting the recommendation to Congress.

"The situation above highlights the necessity for a clear policy and procedure on how DUs can be held accountable for their duties and responsibilities under the EPIRA (Electric Power Industry Reform Act of 2001), through the recommendation of DOE or ERC for the revocation of their franchise, all towards the promotion and protection of consumers' interest," Gatchalian said.



CALAMBA CITY, Laguna -- Cavite Gov. Jesus Crispin Remulla is seeking exemption from the Commission on Elections (Comelec) restrictions during the election period so that local government units (LGUs) could source out additional funds to address the measles outbreak in the province.

Remulla, chair of the Calabarzon Regional Peace and Order Council (RPOC), presided over the first RPOC Peace and Development Summit on Tuesday, which tackled various peace and security concerns of the region at the NEDA-4A RDC Conference Hall in Barangay Milagrosa here.

Calabarzon is composed of the provinces of Cavite, Laguna, Batangas, Rizal and Quezon.

Remulla said the provincial government has brought up the matter to the Department of Health (DOH) in view of its declaration of state of calamity due to the increasing measles cases in the province.

"Para yung state of emergency (in the province) ma-exempt naman kami sa kinikilos na kailangan naming gawin dahil may mga pinagbabawal dahil sa election ban (Just like the state of emergency, we want to be exempted to let us act on what to be done because there are things that are prohibited by the election ban), Remulla said.

He disclosed that they have already released some PHP3 million under the calamity fund, which is earmarked to entice parents to bring along their children to be vaccinated.

"Ang problema ko yung pagtitipon namin ng Barangay Health Workers (BHW), mga 6,000 na iipunin mo. Maraming gastos ang gobyerno, eh wala kaming budget para doon (The problem is the meeting with Barangay Health Workers, we need to gather around 6,000. The government has many expenses, we don't have a budget for that)," he said, stressing the need for exemption to disburse funds.

Remulla said they have already requested the DOH for the inter-agency intervention measures and support activities as the measles outbreak is an emergency situation.

He said Cavite is a densely populated province and failure to contain around 85 percent of the population may spread the disease further.

He also expressed optimism that the Comelec is reasonable enough to grant the DOH request for exemption from the ban.

Cavite has declared a state of calamity by virtue of Sangguniang Panlalawigan (Provincial Legislative Council) Resolution No. 1165, which was passed last February 18.

Upon his approval of the provincial resolution, Remulla has convened an emergency meeting to discuss the plan of action following the DOH declaration of a measles outbreak in the Calabarzon, which tops the highest number of measles cases so far.

The Provincial Health Office in Cavite has already formed a Measles Outbreak Team to ensure that all emergency protocols and necessary interventions and response are implemented.

The Cavite legislative body has authorized the governor to release PHP5.904 million from the 5 percent Local Disaster Risk Reduction and Management fund for the provision of drugs and medicines, medical supplies and rice to address the cases.

Meanwhile, Dr. Paula Paz Sychiongco, DOH-Calabarzon assistant regional director, said the number of measles cases in the region continues to rise at 3,425, with 83 reported deaths as of February 26. (PNA)

MANILA -- President Rodrigo R. Duterte has included former Interior Secretary Rafael "Raffy" Alunan III in his senatorial lineup for the upcoming May 2019 mid-term elections

Alunan himself confirmed this during the campaign rally of the Partido Demokratiko Pilipino-Lakas ng Bayan (PDP-Laban) at the Alonte Sports Arena in Biñan City, Laguna

"Malaking karangalan (It is a huge honor) to be part of the President's team for May 2019," Alunan, one of PDP-Laban's guest candidates said during the event.

Duterte, in his speech, said Alunan is "the brightest" Cabinet member under President Fidel Ramos.

"Wala ka nang makita pinaka-bright sa panahon ni Ramos (You can't see someone brighter during the time of Ramos). He was the brightest Cabinet member," Duterte said.

"And he knows best what he's doing because he was once upon a time the DILG Secretary. Secretary Alunan," he added.

Alunan also served as Tourism Secretary under President Corazon Aquino.

Duterte further described as Alunan "a thinking guy."

This is Alunan's second attempt to run as Senator after losing

in the 2016 Senate race.

He is now running under the Bagumbayan Party of Senator Richard Gordon.

Aside from Alunan, other guest candidates being endorsed by Duterte are folk singer Freddie Aguilar, Taguig Rep. Pia Cayetano, Ilocos Norte Gov. Imee Marcos and reelectionist senators Juan Edgardo "Sonny" Angara, Joseph Victor "JV" Ejercito and Cynthia Villar.

Duterte is endorsing five senate bets from PDP-Laban namely former Special Assistant to the President Christopher "Bong" Go, former Presidential Political Adviser Francis Tolentino, PDP-Laban President and reelectionist senator Aquilino "Koko" Plmentel III, Maguindanao Rep. Zajid Mangudadatu, and former Philippine National Police and Bureau of Corrections chief Roland "Bato" Dela Rosa.

Earlier, Presidential Spokesperson Salvador Panelo said the President does not think that he possesses any "magical" power to make candidates of his choice win the elections after analysts said the May elections would test the President's power to endorse his candidates.

Panelo disagreed with remarks that the failure of administration allies to win seats would mean voter rejection of the Duterte administration. (PNA)

PRRD vetoes bill banning corporal punishment for children

MANILA - President Rodrigo R. Duterte has vetoed a bill banning corporate punishment for children stressing that he does not share "overly sweeping condemnation" of this practice.

Duterte vetoed consolidated bills Senate Bill 1477 and House Bill No. 8238 on Feb. 23 but a copy of the veto message was released on Thursday (Feb. 28).

The consolidated bills prohibit subjecting the child to any form of punishment or discipline using physical force and intended to cause pain or discomfort or any nonphysical act that causes a child to feel belittled, denigrated, threatened, or ridiculed.

In his veto message, Duterte said although he believed children should be protected from humiliating forms of punishment, he believed that disciplining children can also be done respon-

"I am gravely concerned that the bill goes much further than this as it would proscribe all forms of corporate punishment, humiliating or not, including those done within the confines of the family home. I do

not share such an overly sweeping condemnation of the practice." Duterte said

Duterte pointed out the legislation seemed to have condemned all forms of disciplining chil-

"Regrettably, this bill places such responsible disciplining of children in the same category as humiliating and degrading forms of punishment, and condemns them all in one broad stroke," Duterte

The Chief Executive also said that the measure violates the Constitution because it intervenes in the life of the family.

"Making no distinctions, the bill would allow government to extend its reach into the privacy of the family, authorizing measures aimed at suppressing corporal punishment regardless of how carefully it is practiced," Duterte said.

"In so doing, the bill transgresses the proper boundaries of State intervention in the life of the family, the sanctity and autonomy of which is recognized by the Constitution," he added.

Loving act of dis-

Duterte emphasized that corporal punishment may sometimes be done as "a loving act of discipline that desires only to uphold their welfare" and even raise children to become law-abiding citizens.

"I am of the firm conviction that responsible parents can and have administered corporal punishment in a self-restrained manner, such that the children remember it not as an act of hate or abuse, but a loving act of discipline that desires only to uphold their welfare," Duterte said.

"Such manner of undertaking corporal punishment has given rose to beneficial results for society with countless children having been raised up to become law-abiding citizens with a healthy respect for authority structures in the wider community," he added.

Meanwhile,

Duterte also stressed that despite the view of Western nations that all forms of corporal punishment are "outdated", these do not necessarily apply to the Philippines.

"The cultural trends of other countries are not necessarily healthy for our own nation. Indeed, in many instances such trends are of doubtful benefit even for the very countries which originated and popularized the," Duterte said.

"То uncritically follow the lead of these countries, especially in matters as significant as the family, would be a great disservice to the succeeding generations," he added.

Duterte said that instead of copying the style of the Westerners, the Philippines should create a "nuanced" approach to disciplining children responsibly.

"I strongly believe that we should resist this trend in favor of a more balanced and nuanced approach, one that is both protective of the child as well as cognizant of the prerogatives of devoted parents who believe in the merits of corporal punishment, rightly administered," Duterte said.

Executive Secretary Salvador Medialdea told reporters that Duterte vetoed the measure because he still wanted to give parents some "degree of control."

Former Special Assistant to the President (SAP) Christopher "Bong" Go, for his part, cited that the Constitution recognizes parents' role to determine how they would raise their children to be morally upright and responsible citizens.

Section 12 of the 1987 Constitution provides in part that "the natural and primary right and duty of parents in the rearing of the youth for civic efficiency and the development of moral character shall receive the support of the government."

however, Go, said there are several laws that provide ample protection to children from physical and emotional abuse.





The peak of success

To start a small source of living was Leah Ebrado's plan for her husband's first salary. She knew construction work is heavy work for him that's why she planned to venture into making folding bed out of rattan plastic. Leah learned from her neighbors that the raw materials needed to create such craft are not expensive.

Leah recalled that in 2004, the plastic rattan used for weaving costs P38 per yard while a recycled folding bed frame is only P30 per piece. "We just need to buy a paint to enhance the color of the folding beds," said Leah adding that the paint before is just around P50 per 250 milliliter can.

Leah grew up in Batangas City. When she married Edwin, a native of Talisay City, they decided to settle down and stay for good in Cebu. Her husband's hometown is known for rattan plastic folding bed as its primary source of livelihood, which also encouraged Leah to venture into it.

"At present, we are producing 20 pieces of rattan plastic folding bed per week and sell them at a wholesale price of 400 to 450 pesos per piece to our regular buyers. During peak seasons like December, we receive more orders. That is why we need to look for more junk shops in different barangays or municipalities that could supply us with frames," said Leah.

In preparation for peak seasons, according to Leah, they usually purchase frames in advance. Hence, the need for additional capital is needed. Then she met CARD SME Bank, a thrift bank that provides comprehensive microfinance and business loans to microentrepreneurs.
