# **DOH Caraga Inutile vs Dengue, One Died caused**



BUTUAN CITY, Aug. 4 - Dengue cases in Caraga region increases said the Department of Health – Caraga, it intensified the 4S campaign in the different provinces of the region. Data released by DOH-Caraga as of July 22, 2019 shows more than 6,000 dengue cases recorded in the region, higher compared to last year's figure of only 2,300 which very alarming already.

This is very high compared to last year's cases of 2,300, but questionably, with the new graph, DOH still considered it below the alert level," said Regional Director Dr. Jose Llacuna Jr. Computation shows a 260.86% increase of Dengue cases in Caraga, yet, DOH Caraga was not yet alarmed.

The health department also reminded the different barangays to continuously perform the 4S campaign to prevent the spread of dengue disease. These are: search and destroy; self-protection measures; seek early consultation; and say no to indiscriminate fogging.

The DOH Caraga also recognized the effort of the local government units in the region for their constant implementation of the health programs to the public.

The public asked why fogging is not the first line of defense of killing mosquitoes and ultimately stopped Dengue when it should be the best. Fogging should be an act of war against mosquitoes or the best prevention rather than cure to totally eliminate mosqui-

# **EDITORYAL:**

# **Weak economic growth**

The Philippine economy as expected grew more slowly in the second quarter of the year, weighed down by the delay in the approval of the 2019 budget, an anemic agricultural sector due mainly to El Niño, and the ban on construction activities during the midterm elections,

The economy just expanded by 5.5 percent in the April-to-June period from 5.6 percent in the previous quarter. The weak expansion puts tremendous pressure on the government to stimulate the economy in order to achieve the 6-percent to 7-percent growth target this year.

The government faces a tall order in getting the economy back on track. Economic Planning Secretary Ernesto Pernia has conceded that the Philippine economy must expand by an average of at least 6.4 percent in the second half to reach the low-end of the full-year growth target. The country's economic managers and the governor of the Bangko Sentral ng Pilipinas know the drill. They will have to stimulate or pump-prime the economy to achieve the growth objective.

The Monetary Board of the Bangko Sentral just reduced the borrowing rate by 25 basis points to 4.25 percent amid low inflation and the sluggish economic growth. The move aims to spur borrowing by companies through lower interest rates to fund their expansion. The rate cut, along with an expected infusion of liquidity into the financial system within the year, will lower the cost of funds and serves as an incentive to hire more workers through expansion.

The government will also have to step up spending, especially on infrastructure projects, in order to catch up on the backlog during the first five months of the year. Public construction, according to government data, dropped 27 percent in the second quarter and offset the growth of private construction. President Rodrigo Duterte was able to sign the P3.7-trillion national budget for 2019 only in April after a couple of months of impasse between the two houses of Congress.

The outlook on the global economy, meanwhile, is not upbeat amid the trade tension between the US and China. But the local economy is holding on. Household spending remains strong and it's just a matter of pushing the right buttons to spur the economy.

# Bill transferring seat of gov't to Clark Eco Zone filed

In a bid to decongest Metro Manila, Senator Win Gatchalian filed a bill seeking to transfer the seat of the national government to New Clark City in Tarlac by 2030.

"With our economy growing at 6% on the average and the rise of middle-income families who have the capacity to buy new vehicles, we need to move the seat of government to a new place to relieve Metro Manila of its traffic and population congestion problems," Gatchalian said in filing Senate Bill No. 876.

Gatchalian pointed out that moving the permanent seat of government is not something new, and has been done in several countries including the United States, South Korea, Brazil, Kazakhstan, and Malaysia, which moved its administrative capital from Kuala Lumpur to the city of Putrajaya in 1999.

"In the case of the Philippines, the solution lies outside Metro Manila: at the New Clark City located at the Clark Special Economic Zone in Capas, Tarlac," he said.

The lawmaker underscored the worsening congestion in Metro Manila, noting that the National Capital Region (NCR) has a population density of 20,785 persons per square kilome-

ter, which is much higher than that of Mumbai, Paris and Tokyo.

"Official figures from the Philippine Statistics Authority (PSA) show that the metropolis had 12.88 million residents in 2015, a figure that has been growing 1.59% annually," he said. "This means that Metro Manila's population is projected to reach 13.93 million in 2020 and 14.94 million in 2025."

The lawmaker also noted that according to a study conducted by the Japan International Cooperation Agency (JICA) in 2014, traffic volume in Metro Manila has already exceeded road capacities.

"The same study also stated that the traffic congestion in the National Capital Region resulted in losses of at least ₱2.4 billion a day and could reach ₱6 billion a day if not solved," he said.

"In its follow-up survey in 2017, JICA estimated that the Philippines loses ₱3.5 billion daily due to traffic congestion, and it is projected to lose ₱5.4 billion daily to traffic by 2035 if no interventions are made in Metro Manila," Gatchalian added.

Gatchalian said that for several years, the government has been trying to ease traffic congestion in Metro Manila by building more roads and bridges and implementing various traffic policies such as the number coding scheme, the restriction against provincial buses and the "driver-only" vehicles along EDSA.

However, these efforts are not enough to manage the daily traffic of around 15 million people within Metro Manila, he said.

The lawmaker added that beyond easing the congestion problems in Metro Manila, the transfer of the seat of government to New Clark City is also expected to spread development to other parts of the country, generate jobs for Filipinos, and help the economy achieve sustainable growth.

"The development of New Clark City is already part of President Duterte's Build-Build-Build program, and is projected to contribute ₱1.57 trillion per year to the country's gross domestic product upon its completion," he said

This 9.450-hectare development has already set aside 1,514 hectares for a National Govern-Administrative Center that will house government offices and its attached agencies. It will be the country's first smart, disaster-resilient and sustainable city that will have a mixed use of residential, commercial, agro-industrial, educational institutions, and information technology developments," he added.

Also present at the meeting were Undersecretary for legal affairs Bayani Agabin, Assistant Secretary Ma. Teresa Habitan, and representatives from COA and the Asian Development Bank (ADB).

Dominguez said the ADB can be tapped to provide the technical assistance and capacity building support necessary to help the DOF and BTA in this effort.

He said the DOF can meet once every quarter with Bangsamoro officials, with the meeting held alternately in Manila and in BARMM.

During the meeting, Galvez mentioned

the need to hire lawyers, accountants and technical personnel to assist BARMM government officials in transitioning to an autonomous setup.

Dominguez said the BARMM needs experienced people, such as retired government officials who are familiar with budget, revenue and customs processes.

Under the Bangsamoro Organic Law (BOL), the BARMM will receive an annual block grant that will be automatically appropriated under the General Appropriations Act (GAA).

The allocation of this yearly grant will

be based on the annual appropriations law to be passed by the BARMM Parliament. Any unspent amount in the current year's annual block grant shall revert to the Bangsamoro Treasury under a Special Fund for re-appropriation.

The BARMM can also tap a Special Development Fund to help rebuild, rehabilitate and develop its conflict-affected communities.

This Fund will be allotted P5 billion a year for a period of 10 years from the ratification of the BOL, or a total of P5o billion starting next year. (dof.gov.ph)

# **Cavite Mayor...**

IMUS CITY, Cavite — Mayor Emmanuel Leonardo Maliksi has given barangay chairmen at least one week to remove the obstructions on roads and sidewalks in their areas of jurisdiction.

The one-week ultimatum was made by Maliksi in a recent meeting with concerned department heads, lead barangay officials, and special teams to deliberate on the actions pertaining to the clearing of illegal structures, vendors, and illegally parked vehicles, among others, in the road vicinity.

The mayor also created a task force that will oversee the anti-road obstruction implementation in the city's 97 barangays (villages), particularly in markets and "talipapa" (flea markets)

and other crowded areas. The task force will be headed by the mayor himself, with the police, the City Disaster and Risk Reduction Management, Engineering, Planning and General Services and other concerned offices.

City Engineer Christian Mervin S. Sarno said that letters/notices will be issued this week by the Office of the Mayor to barangay captains for them to comply with the directives.

"We will be seeing actions in one or two weeks. The assigned team will demolish the illegal structures or any obstructions (on sidewalks or roads) if the barangay officers will defy the order," Sarno said.

amor Toledo de Pano said that her office will monitor and report regularly to her superiors the actions and progress of the clearing operation.

# Dominguez taps DOF, Tax Academy to guide BARMM execs on fiscal matters

Secretary Carlos Dominguez III has directed key officials of the Department of Finance (DOF) led by Undersecretary Gil Beltran to guide executives of the new Bangsamoro government in running their finance and budget departments as well as in crafting sound policies and implementing effective revenue-generating measures to ensure the long-term fiscal stability of this new autonomous region in Mindanao.

In a meeting to-day (Friday), Dominguez also directed Beltran to tap the Philippine Tax Academy (PTA) to help educate the new set of government officials of the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) on fiscal management, financial planning and budget-related matters.

Dominguez told Beltran to form a technical working group (TWG) together with the Department of Budget and Management (DBM); Bureaus of Customs (BOC). of Internal Revenue (BIR) and of Local Government Finance (BLGF); and the Commission on Audit (COA) in assisting the Bangsamoro government, through the Bangsamoro Transition Authority (BTA), initially

run its finance and budget departments.

The DOF co-chairs with the BARMM minister of budget, finance and management the Intergovernmental Fiscal Policy Board (IGBF), which is designed to address revenue imbalances and fluctuations in the regional financial needs and revenue-raising capacity of the BARMM government.

The other IGBF members are the DBM, Department of Trade and Industry (DTI), National Economic and Development Authority (NEDA) and other BARMM appropriate ministries.

Presidential Peace Adviser Carlito Galvez Jr. said in the meeting at the DOF central office in Manila that among the challenges faced by the BARMM are the ineffective budget planning and programming system that it inherited, as well as its weak accounting and reportorial capabilities and lack of oversight and internal auditing safeguards.

"I would like you to meet with them (Bangsamoro Transition Authority officials) within the month. Present them the plan," Dominguez told Beltran and the other DOF officials at the meeting.

- 1. Petition, **RICKY L. MEDENILLA**, is a Filipino citizen, of legal age, married and a resident of Blk 6 Lot 25 Geranium St., Capitol Hills, Trece Martirez City, Cavite. He is an OFW and most of the time at Saudi Arabia.
- 2. Respondent, Belinda A, Medenilla, is also of legal age Filipino Citizen, married, and currently residing at 279 Alegre Road, City, where she may be served with summon, notices and other court processes.
- 3. Local Civil Registra of Manila is hereby impleaded as a party defendant with their capacity as such with Office address at City Hall of Manila, where it, may be served with summons, notices and other court processes.
- 4. Petition was a grantee of the Philippine Coconut Federation scholarship wherein he was able to graduate at University of the East and after graduation was immediately hired by Banco de Oro.
- 5. Petitioner met respondent on 1984 while they were both working at Banco de Oro. Petitioner immediately noticed respondent and started counting her. Unfortunately, she already liked somebody else. She likes somebody else with more stature and money than him.
- 6. That's in 1988, Petitioner was able to work abroad at Saudi Refrigerator Manufacturing Company. While working abroad communications with the respondent started and before petitioner's first vacation, or December, 1990, respondent answered petitioner's plea for a relationship. Thus they became girlfriend and boyfriend, a long distance relationship.
- 7. As a girlfriend, became it is a long distance relationship, petitioner only noticed her domineering attitude, her social climbing behavior and clamour for more money. She always wanted to be at her best looks and even told herein petitioner that she does not want any children. Petitioner dismissed this as he thought that respondent was only kidding.
- 8. That petitioner went back to the Philippines for a vacation late in 1991, when the parties entered into a Marriage on December 11, 1991 at Manila solemnized by the Honorable Judge Benjamin Toingson. Herein attached as Annex "A" is the marriage contract of the parties.
- 9. Immediately the respondent became pregnant, while petitioner returned abroad and was transferred to Saudi Airconditioning Manufacturing Company, Ltd., where he works up to present.
- 10. Unknow to herein petitioner that respondent while pregnant was able to take several medications for purposes known only to the respondent. And even when pregnant had her goiter removed.
- 11. On September 11, 1992, their only child, Justine, was born. She suffers from mental retardation. Herein attached is the birth certificate of their daughter as Annex "B"
- 12. Two (2) years after, still unknow to herein petitioner, respondent had a tumor in one of her ovary. She had this removed and even when unnecessary had the other ovary also removed. She now can not conceive a child. It was just after the whole operations and when petitioner asks for another child that petitioner found out of this incident.
- 13. Petitioner still loves his wife that he purchased a house at Biñan, Laguna, He had this fully furnished but respondent refuse to leave her parents. That is why respondent resided either at her parents or siblings at Pasay City or Paranaque City.

- 14. Respondent nags herein petitioner for money. She also sold their house in Biñan, Laguna. Petitioner had no idea where the money from the sale went. But still respondent continuously and without rest nags for money. She is always jealous and would be loud about this with foul words directed against petitioner. She was jealous yet she refused to have sex with petitioner. He has to literally begged and even that does not guaranty that he would be able to have sex with respondent.
- 15. Every time petitioner went home for vacation with respondent, he always suffered from illness. Food poisoning, lead poisoning and other illnesses. One time, petitioner become so sick but respondent does not want to bring petitioner to the hospital. She would say, sayang ang pera, hindi ka naman nagpapadala ng Malaki. Mas Malaki pa makukuha namin pag hindi ka na gumaling. Lucky for petitioner, his brothers and sisters got worried and went to him and took him to the hospital where he was confined for 15 days.
- 16. One time, it was in 2006, when herein petitioner went home for vacation, one day, he went to his siblings. Respondent who was still working for BDO, looked for him when she got home. she called petitioner and warned him that if he did not go home to her immediately, he could not live with her anymore. When he got home, he found all of his clothes inside a luggage. Although, he was not kicked out that day, the tear in their relationship grew.
- 17. He went to his brother in Trece Martirez City, Cavite at that time and where he resides every time he is home in the Philippines ever since then.
- 18. Respondent kept on her nagging ways about money and her jealousy. She kicked him out of the house. His pleas landed in deaf ears, Yet she always calls for money and support. And he found out that respondent moved to another residence without giving her address.
- 19. Respondent on the same day, could no longer be found. Petitioner tried to find and talk to the respondent but her family would not tell her whereabouts. Petitioner has not seen respondent and their daughter ever since
- 20. That if the respondent be examined be a psychologist, she would find that the respondent is psychologically incapacitated to comply with the martial obligation from the very inception of their marriage.
