# **EDITORYAL: Divorced from reality**

At the Senate hearing this week on three divorce bills, many of the old arguments for and against divorce surfaced.

Those against the law say divorce is evil because it destroys the sanctity of marriage and jeopardizes the psychological well-being of the children.

In this day and age, there remains a certain stigma on so-called broken families, thus the pressure on families to remain intacteven only to keep appearances.

The premium on appearances has caused many couples to stay together for optics' sake, despite the unhappiness, dissatisfaction and the existence of other partners or families. The hypocritical situation then trumps the so-called evil that staying together supposedly avoids, and is equally if not more damaging to children who must live in these conditions.

While there is an option for legal separation and declaration of nullity, these require a psychological basis for the marital breakdown, some of which are trumped up or exaggerated just to build a strong case. With the prohibitive cost. these legal options are also anti-poor. That marriage is

a sacred unit of society is not disputed. It is indeed heartbreaking to see that such sanctity is violated, not by the availability of divorce as an option, but by dishonesty, lack of respect, apathy, abuse.

In the case of abusive marriages, those who want out of the relationship are deemed selfish for refusing to make sacrifices to keep their family whole. They are blamed for "destroying" the family when it is the abusive partner's behavior that made a sham of the union in the first plac

Sometimes, too. relationships that begin idyllically simply run their course because the parties have simply grown apart. Must they stay for the sake of staying even when the union has become joyless and uninspiring, and when they each find happiness with someone else?

Opposition to the law is premised on at least two erroneous notions: That people actually like terminating relationships,

and that they will rush to avail themselves of this option once it becomes available. Foremost, divorce is and should always be a last resort. It is difficult to imagine brides and grooms contemplating their estrangement at the outset.

Finally, a divorce law will not force anybody to actually get divorced. If some people are genuinely happily married, good for them. May their happiness know no bounds. If some are content with maintaining double lives, appearing whole, and if they feel the inconveniences of the separation would far outweigh the relief and happiness that freedom would bring, nobody forces them to use it.

They should not, however, deny those who want to be true to themselves the opportunity to be free from an oppressive arrangement, and to open themselves to the possibility of discovering that marriage could be actually blissful.

There is a reason that all other countries except the Vatican already provide this option to their citizens. It is not difficult to see why—if we just keep an open mind.

# Infra modernization to shield PHL from global growth slowdown, make it more attractive investment destination—Dominguez

President Duterte's centerpiece program "Build, Build, Build" will provide the Philippines the stimulus it needs to keep creating jobs and opening new investment opportunities despite the global economic slowdown, Finance Secretary Carlos Dominguez III has assured foreign investors.

Dominguez painted a picture of this positive economic outlook for the country as he invited Singaporean investors to consider investing in "Build, Build, Build" and other related businesses that would open up as a result of this ambitious infrastructure modernization program.

He also informed a visiting delegation from the Singapore Business Federation (SBF) that the Philippines expects to hit upper middle-incountry come status next year on the strength of its stable macroeconomic fundamentals and game-changing reforms enacted over the first three years of the Duterte administration, such as the Tax Reform for Acceleration and Inclusion (TRAIN) Law.

"I think we have proven that we can chew gum and walk across the

room at the same time. We can do reform and we can deliver in the field. We have done significant reforms in taxation, and we are moving forward with that," Dominguez said in his meeting with SBF members at the Department of Finance (DOF) office in Manila on Monday morning, Sept. 9.

Duterte The administration, he said "delivered in the field" as it was able to increase spending on infrastructure from a mere 2.5 percent of the country's GDP in the last 50 years, to 5 percent of GDP in 2018.

Dominguez said "Build, Build, Build" will create jobs and boost domestic consumption. thereby shielding the domestic economy from the global growth slowdown. the adverse effects of the ongoing US-China trade war and other risks to the government's efforts to sustain the Philippines' high growth rate.

"The Philippine economy continues to demonstrate strength, stability and resilience in adverse conditions. We hope to sustain our growth, relying on strong domestic demand to offset the general slowdown," Dominguez said.

"Private sector participation is not only in our country's 'Build, Build, Build' program, but also in investments that would open up as a result of our infrastructure modernization, and we think that the Singaporean investors should take a close look at that," he added.

Led by its chairman, Teo Siong Seng, the SBF met with Dominguez and other DOF officials to know more about the business climate in the country and explore investment opportunities here. The SBF represents 25,800 companies based in Singapore.

"Even as the global economic outlook deteriorates further, we are confident that the economic stimulus provided by our infrastructure program will continue to create new jobs and be verv beneficial for businesses in the sense that it will lower your logistics costs in the Philippines," Dominguez said.

Another key advantage that the Philippines has which Dominguez said makes him "even more confident" of the economy's stable outlook is its young and well-educated workforce with a median age of 24 vears old. This is in sharp

contrast to the aging populations of the region's more mature industrialized countries and some ASEAN economies, such as Singapore, which can team up with the Philippines as "demographic partners" so that they can complement each other economic strengths, Dominguez said.

He said the robust revenue flows from the TRAIN Law has enabled the Philippines not only to support its "Build, Build, Build" program but to dramatically increase spending as well on programs to develop the country's human capital.

These programs on human capital development include free tuition in tertiary public education and cash transfers for the country's most disadvantaged families, Dominguez said.

Another CTRP package, which aims to increase excise taxes on "sin" products such as cigarettes and alcoholic beverages, will help fund the universal health care (UHC) program, he added.

Dominguez cited some of the factors that make the Philippines a prime investment destination:

A strong fiscal position as proven by the recent upgrade by Standard & Poor (S&P)'s of the Philippine's credit rating from "BBB" to "BBB Plus," the highest ever achieved by the country and which is only a notch away from the single "A' arade:

Sufficient gross international reserves (GIR) at over \$US86 billion;

Enactment of the Rice Tariffication Law (RTL), which will keep rice prices down while transforming agriculture into a main driver of economic growth;

of the Ease of Doing Business (EODB) law and a national ID system to address investors concerns on red tape; and

Digitalization of the government's frontline services, including tax collection and payment systems.



Senator Win Gatchalian wants to champion greater competition on locally-funded government public works projects by amending restriction's in the country's 78-year-old law.

Gatchalian, vice chairman of the Senate Committee on Economic Affairs, recently filed Senate Bill No. 1009 (SBN 1009) to amend the already antiquated Commonwealth Act No. 541 (CA 541) or "An Act to Regulate the Awarding of Contracts for Construction or Repair of Public Works."

The senator said amending CA 541 has long been overdue and very much needed at this time given the government's current thrust on infrastructure development via the Build, Build, Build Program. "For seventy-eight

years, such domestic preference policy has confined competition in the construction industry within our territorial boundaries and has discriminated in favor of domestic businesses with substantial market power and political influence," Gatchalian said.

"In this light, this bill seeks to provide a more level playing field and extend equal opportunities to eligible and qualified domestic and foreign bidders to participate in the bidding by the Government for public works projects," he said.

SBN 1009, in a nut shell, fine-tunes the decades old law to ease restrictions that prohibits foreign contractors from bidding on locally funded public works projects.

The bill amends Section 1 of CA 541 to state that it is now the policy of the state "to extend equal opportunities to eligible and qualified bidders to public works projects of the government and to attract domestic and foreign investments in the construction industry to

improve market dynamism, encourage innovation, and reward good performance.

In pushing for the amendment of CA 541, Gatchalian contends that domestic businesses with substantial market power and political influence have been benefiting from a restrictive policy that confines competition in the Philippine construction industry.

The senator noted that public construction public construction grew by only 8%, while private construction grew by 58% between 2010 and 2015 due to the lack of genuine competition in the public construction industry.

"The lack of genuine competition in the public construction industry impairs public welfare as there are fewer incentives for existing domestic firms to innovate and puts at risk the delivery of reliable, safety-compliant and quality public works," Gatchalian lamented.

In pushing for the passage of the bill, the lawmaker said the measure should be considered "in the context of positioning the Philippines more competitively and attracting new investments in the construction industry to enable the Government to deliver the much-needed infrastructure that would support the country's initiatives in providing a business climate conducive to investments in the country."

"The enactment of this measure will encourage and attract foreign firms that possess the capacity to construct vital projects and are capable of sharing technical expertise with local firms to enter the Philippine construction market," Gatchalian said.

### CAVITE LGU'S ...

The Department of the Interior and Local Government Memorandum Circular 2019-121 has imposed the deadline on Sept. 29 for local government units (LGUs) throughout the country.

"I think we will get it before the Sept. 29 deadline by DILG. Most of the residents and business owners already comply with the clearing operations order," General Trias City Mayor Antonio Ferrer said in an interview.

Ferrer has led the clearing operations since Day One of the DILG's enforcement order, in Barangay Tejero, by directing the Public Order and Safety Task Force to check compliance by the city's 33 villages ahead of the deadline.

This city's clearing operations also received the support from 33 village chiefs through the Liga ng Barangay (LnB) Federation president Alfred Ching for the city-wide information dissemination campaign and actual cleanups.

"I am grateful to those who have already followed the DILG order," Ferrer said.

The city's clearing operations covered busy stretch of the Antero Soriano Highway from Bacao to Tejero; Tejero Crossing, Tejero-San Juan Road, Malabon Trias proper; Gen. Antonio Road from Bacao to Dulong Bayan to Brgy. 96th, **Governor Ferrer Drive** from Barangay Prinza to Manggahan, Crisanto delos Reyes Avenue from Manggahan to Alingaro, Governor's Drive from San Francisco to Manggahan, up to the boundary at Trece Martires Citv.

In Carmona town, Mayor Roy Loyola and his team are clearing the stretch of Governor's Drive and the town

proper's main road, assisted by the local police and the clearing task force.

Tagaytay City Mayor Agnes Tolentino also ordered the 34 village chiefs to place "No Parking" signs on the city's major thoroughfares, including the removal of illegal structures on sidewalks.

In Amadeo town, some 26 village chiefs and their clearing operations team also removed electric posts and tree obstructions upon instructions from Mayor Redel Dionisio who also ordered the upkeep of the town's main Crisanto delos Reyes Avenue.

M e a n w h i l e, Cavite's western coastal town of Noveleta Mayor Dino Reyes Chua admitted he has to work until midnight to monitor the clearing operations along the Antero Soriano Highway going to Cavite City.

He has been supervising the removal of electric posts obstructing the main highway because these posts that pose risks and hazards to motorists and vehicles, have to be removed after the road-widening projects.

He thanked the town's 16 village leaders for taking the lead to clean their respective areas and responding to constituents' reports on illegal obstructions that need to be removed.

Officials of the cities of Imus, Bacoor, Dasmariñas, Cavite, Trece Martires and the towns of Kawit. Rosario, Naic. Maragondon, Ternate, Magallanes, Bailen, Alfonso, Indang, Mendez, Gen. Mariano Alvarez and Silang confirmed that they are now in the final stages of clearing operations in their respective areas. (PNA)

13, 2019. Centenarians also received some vitamins and prescribed medicines.



# **DOH-Calabarzon pushes** proved rural health services

IMUS CITY, Cavite - The Department of Health (DOH) in Calabarzon (Region 4A) has embarked on a series of training of its health workers particularly on family planning to improve rural health services in the region.

nating "Kailangan ayusin lahat ng mga Rural Health Units (RHUs) at mabigyan sila ng sapat na pangangailangan upang makapagbigay ng wastong serbisyong pangkalusugan.(We have to improve all the RHUs and gave them enough support for them to give the appropriate health services)," DOH-Calabarzon Director Eduardo C. Janairo said on Tuesday.

Janairo said the first batch of the Revised Family Planning Competency-Based Training (FPCBT) held in Quezon City from Sept. 9 to 13, is pre-requisite to improve the skills of all health care providers particularly the newly-hired nurses and midwives assigned in remote barangays.

"They serve as the first point of contact for patients and families when scheduling appointments, coordinating patient follow up, and arranging transportation for patients to and from the nearest health facilities." he said.

Prioritizing health workers of RHUs from island communities will also help attain and sustain "Zero Unmet Need for Modern Family Planning" as mandated by Executive Order No. 12 signed by President Rodrigo Duterte in 2017.

A total of 42 rural nurses and midwives from Quezon province, including Polillo Island, comprised the first batch of trainees.

Maria Luisa M. Malana, outcome manager for family planning and gender and development, emphasized that child spacing and the choice of contraceptive method is the decision of the couple. "Our role is to educate them and pro-

vide them the proper information regarding their choice of family planning method. And it is the duty of frontline health workers to give them the essential knowledge and ensure that these are fully understood," Malana told the health workers.

Calabarzon ranked No. 16 among the regions with contraceptive prevalence rate (CPR) with Cavite having the highest CPR at 81.53%, followed by Quezon (77.90%), Laguna (53.27%), Batangas (40.08%), and Rizal (33.77%).

Among the top three family planning methods commonly used are pills, injectables and bilateral tubal ligation. (PNA)
