Learning our lesson

The inauspicious start of this year's Southeast Asian (SEA) Games is quickly becoming a lesson for Filipino officials.

Two things need to be done. First, competent and efficient leadership must be quickly asserted to ensure that our visitors—athletes and officials from our Southeast Asian neighbors—are accorded the treatment they deserve. Second, all parties concerned must stop finger pointing and work together to avert further international embarrassment. There will be time enough to ascribe blame—after the Games are

By now, we are all familiar with the stories that marred the run-up to the Games' opening on Nov. 30. One visiting football team waited for hours at the airport before their transportation took them to their hotel, which had no provisions for their early check-in. At least one team was taken to the wrong hotel, and athletes from Muslim countries were offered no halal food and given Chinese sausages made of minced pork. Foreign and local press alike struggled with an accreditation process that kept some of them waiting days for their IDs-some of which went out with the wrong photos. A "media center" turned out to be a room with unfinished hollow-block walls, a whiteboard of some description and plastic chairsworth perhaps of some backwater sporting event, but hardly acceptable for an international tournament of this scale. Clearly, all this suggests a failure of leadership and planning.

With enough foresight, these problems could have easily been averted-had the organizers been doing their jobs. We learn, for instance, that the National Commission on Muslim Filipinos (NCMF) had reached out to the organizers about providing halal food to athletes from Muslim countries. Inexplicably, these offers were

As one problem piled on top of another, the finger pointing began. Speaker Alan Peter Cayetano, who heads the Philippine Southeast Asian Games Organizing Committee, blamed opposition Senator Franklin Drilon for cutting and delaying the budget for the Games.

But as Senate President Vicente Sotto III points out, the House could have objected to the budget cuts in the bicameral conference committee. They did not do so.

Logic also suggests that the problems that have surfaced so far have less to do with the lack of funding and more to do with the failure to plan and execute the necessary tasks. Keeping track of arriving teams and ensuring they have timely transportation—that doesn't take a lot of money. Nor does making sure that all athletes are adequately fed.

President Rodrigo Duterte is said to be displeased with the inconveniences suffered by the country's guests and wants an investigation of the problems hounding the Philippines' hosting of the Games.

His spokesman, who had initially sought to play down the complaints as "not that serious." now says those responsible would be held accountable, and that the organizers should learn from mistakes.

He also now admits that what the organizers have done "is not a good example of how a country should host" an international event.

This is all well and good, but clearly somebody must now take charge to ensure that these mistakes are not committed again to the embarrassment of the entire nation.

Last week, the U.S. Centers for Disease

Gatchalian lamented that the lack of stricter Control and Prevention has confirmed at least 42 deaths in 24 states due to EVALI.

In the Philippines, the Department of Health (DOH) reported that a 16-year-old girl from the Central Visavas was the first patient in the country who met the criteria for EVALI. The criteria used by the DOH was based on the guidelines set by the US Centers for

"Also, the manufacturers, distributors and sellers of these products are claiming that e-cigarettes are safer or healthier alternatives to traditional cigarettes so we need a regulatory framework to check the safety claims of the e-cigarettes that are being sold in the market. This is necessary to assure the public of the effects to their health of the chemicals or substances they ingest in their bodies," Gatchalian said.

"Let's not wait for another patient to be confined, or even worse die, as a result of EVALI. It's time to regulate these smoking devices and save the lives of many Filipinos, particularly the youth," he said.

family, Pascual decided to turn down the new assignment and pursued other opportunities in Bohol. In April 2012, he joined the Bohol Island Operators and Drivers Multi-Purpose Cooperative (BIODMPC), a company that offers tourist packages in the island. In just a month. Pascual was voted by the board as BIODMPC's chairman. The cooperative experienced a lot of breakthroughs, such as acquiring Php 3.7 million in assets by December 2018. under his leadership.

Pascual ceived an accumulated Php 145 000 cash prize a brand new vehicle. Php 50,000 worth of Phoenix Petroleum fuel and lubes products, and a livelihood package sponsored by Super Phoenix LPG and Posible as the PTH grand champion. He is also the official Phoenix Petroleum Ambassador for one year. This ´year's received

competition more than 12,000 nominations nationwide. After deliberation, only the top 30 drivers were sent to Metro Manila for a 5-day training that included lessons on defensive driving, road safety, environmental protection, and entrepreneurship. year's training included financial literacy lessons to further empower finalists who were given cash prizes to implement their pitched community projects.



20,000 Mindanao quake victims seek relief from Microfinance NGO

More than 20,000 victims of the spate of earthquakes that rocked parts of Mindanao recently have found solace from the quick response for relief provided by a grassroots-based non-government organization that specializes in microfinance.

Jocelyn Dequito, executive director of the Center for Agriculture and Rural Development, Inc., reported that their NGO managed to provide immediate relief assistance such as food, water, clothes, and medicines to quake victims from 4,878 affected families in Mindanao.

"The recent earthquakes in the different parts of Mindanao is a reminder that Filipino families continue to be vulnerable to natural disasters. Not only were houses and establishments destroyed, but lives were also taken away because of the recent disaster," Dequito said.

"While these calamities

cannot be prevented or avoided, there is always hope for vulnerable. Organizations like the Center for Agriculture and Rural Development, Inc., a Microfinance NGO, are always ready to extend their helping hands whenever the socio-economically challenged faces adversities," Dequito added.

Since the establishment of the microfinance NGO in 1986, it has vowed to empower communities by providing access to social and economic development services including disaster management.

From 2016 to 2018, more than 320,000 affected individuals of calamities were given relief assistance amounting to PHP64 million. As of November 2019, the institution spent more than PHP580,000.00 for the relief assistance to afflicted communities.

"CARD, Inc. also allows its clients to become resilient when calamities strike. More than 64,000 of its clients received claims payment having access to microinsurance services. This served as their safety nets in times of uncertainties," Dequito explained.

"However, it is not only during calamities when the poor faces uncertainties. It is when there is lack of access to education, healthcare, and other development programs that they remain trapped in the cycle of poverty," she added.

As such, Dequito noted that CARD, Inc. implements relevant community development programs and services for the com-Continuous munities. and better healthcare programs and services, through its microfinance and health protection program, are brought closer to the communities especially to those impoverished and disaster-stricken areas.

In the last three years, more than 20,000 of its clients received hospitalization benefits and 337 thousand individuals have

access to affordable and quality medicines, and to other healthcare-related services. For these, the institution allocated an average of PhP 45M per year.

The Microfinance NGO envisions a future when every household will have at least one college graduate, hence the One Family One Graduate Program.

"When people are educated, their chances of creating a better future for themselves and their families become higher," Dequito said.

CARD, Inc. also offers scholarship programs that enables deserving individuals to complete their education. Currently, a total of 11,777 beneficiaries has already received scholarship/educational assistance program and in the last three years, CARD, Inc. allocated an average of PhP 23 M per year for this.

Apart from formal education, CARD, Inc. also provides other platforms for communities to become informed and educated. More than 2.2 million CARD clients received Credit with Education, 1,338 had the opportunity to attend educational tours, 16,587 received marketing assistance, enterprise development, and livelihood trainings. CARD Inc allocated an average of PhP 24M per year since 2016 for these services.

Being an institution that has lasted for more than 30 years, Dequito said CARD, Inc. hopes to create more impact to the communities it serves. With partnerships created with appropriate agencies, private institutions and other organizations and individuals, CARD, Inc. is able to facilitate change in the lives of more than 2.1 million families.

One concrete example is the support given by the government when it passed the RA 10693 or the Microfinance NGO Act, signed on November 2015. This Act supports the low-income sector by giving tax incentives to Mi-

crofinance NGOs that the latter use as fund to implement community development programs.

"Microfinance NGOs can continue creating sustainable programs for underserved families and encourage them to start entrepreneurial activities because of the two percent preferential tax contribution based on gross receipts from microfinance operations," Dequito explained.

"The advocacy of microfinance NGOs to touch more lives through extending their social causes to create meaningful impact will endure. No earthquake, typhoon or any other calamity will be strong enough to shake its mission of ending poverty in the country. With continuous support, CARD and other microfinance NGOs will continue the work it has started in nation building and development until all Filipinos are free from extreme poverty," she added.


