# **CONCEPCION: CAVITE MAYORS BACK LOCALIZED GRANULAR LOCKDOWNS**

PA Joey Concepcion was joined by City Mayors Lani Mercado-Revilla (Bacoor), Emmanuel Maliksi (Imus), Antonio Ferrer (General Trias), Dasmariñas Head of Tourism Office Red Alano, Trece Martires Lead MD Dra. Lorelie Escario, and ARK LGU Lead Ginggay Hontiveros-Malvar, on a virtual presser last August 13.

A number of Cavite mayors are increasingly using a localized and granular approach to lockdowns in their respective cities in tandem with targeted testing as a way to contain COVID-19 infection rates in local clusters. This was shared during a virtual presser with City Mayors Lani Mercado-Revilla, Antonio Ferrer, Emmanuel Maliksi, and representatives from other partner cities.

"Bringing innovation into testing is very important for us because this is the only weapon we have to create visibility. By creating visibility, then we know what areas or barangays to lockdown and that's very important. I believe our mayors are the most capable people in determining where to lockdown," said Presidential Adviser for Entrepreneurship and Go Negosyo founder Joey Concepcion.

In the partial results of the City of Bacoor, a total of 2,133 individuals were tested. Of this number. 17 tested asymptomatic IgM positive, 20 were asymptomatic igG positive which means they had the virus but were able to recover and build antibodies. three were asymptomatic IaG/IaM while 2,087 were asymptomatic negative One tested symptomatic IgM positive, four tested symptomatic IgG/IgM and one symptomatic negative

ARK Medical Team Lead Dra. Minguita Padilla emphasized the importance of quality high-specificity rapid test kits (RTKs) in creating a level of visibility against the virus. She cautions that RTKs should be used in compliance with strict medical protocols along with knowledge of its limitations.

"As medical head, I have access to a lot of data from companies. As long as the company structured the medical protocols. RTKs have helped them open and stay open. Like any weapon, the key is to use it properly," she said. "At the beginning, there was nothing so we used RTKs but [they should be used] always in strategic combination

with RT-PCR when nec- viduals that work in] Metro lowing DOH guidelines. [Our] knowledge about the virus has evolved evolve. What we know todav is different from what we know tomorrow. That's the nature absolutes. We started with RTKs, we have RT-PCR, now we're going to pooled PCR then perhaps there's also rapid antigen testing. We have to keep our minds open and make the most of what we have - technology-wise."

The local chief executives echoed the statement, affirming the validity of RTKs in supporting their surveillance efforts, augmenting limited testing capacity, and guiding the implementation of localized lockdown, when necessary.

In General Trias, a total of 856 individuals were tested. Of this partial number, seven tested asymptomatic IaM positive. 2 were asymptomatic IgG positive, 840 asymptomatic negative, and two symptomatic negatives. Mayor Ferrer expressed gratitude for the RTKs donated by Project ARK which they used to promptly test their medical frontliners and barangay personnel.

"By making these [rapid] test kits available, we were able to address the need and obtain information that can guide us to our way forward. Testing helps us to identify probable areas that we need to strengthen protection. especially for our people and where and how to rally our resources to respond appropriately. Rapid testing keeps the morale of your workers up," he said. "We welcome pooled testing whenever it becomes available. For pooled testing, mas mapapabilis at any given time kasi mas madami yung ma-test. Kung ma-detect man sa isang pool, okay lang i-test lahat individ ually. Kung walang positive, it saves time and mas economical."

For Imus, a total of 1.315 individuals were tested. Of this number. only two tested asymptomatic IgM positive while 1,313 asymptomatic individuals tested negative. Mayor Maliksi said that they used nearly all of the 3.500 RTKs turned over by Project ARK to screen workers at two public health markets. Like his fellow mayors, Maliksi highlighted the importance of RTKs due to its affordability and ability to offer a good insight into infection levels as long as confirmatory tests were done through swab tests.

"Kahit kami na may sariling molecular lab, we push na damitin pa rin and rapid test kasi mas affordable vun sa tao. Pag naibababa vung cost ng tests, mas magiging madanda vund surveillance natin. Kava maganda yung pag-aaral on pooled testing na malaking tulong sa mga LGUs tulad namin," he said.

Concepcion also shared that Go Negosyo,

togetherwith the Philip pine Society of Pathologists Inc., Philippine Children's Medical Center, and partner laboratories, will formally announce the results of the Pooled Testing Research on August 17. The study results will be applied in the implementation of Pooled Testing in NCR, particularly the size of the pool per location and/or area. Once approved, this strategy can be immediately implemented throughout NCR and progressively rolled out to all participating companies across the country.

# **Coping with COVID Through Microinsurance**

#### By the Microinsurance MBA Association of the Philippines, Inc. (MiMAP)

Since March 2020 when the Philippines was placed on lockdown associated with the COVID-19 pandemic, foodbased microentrepreneurs have been hard at work as frontliners, without much fanfare or support, to provide Filipino communities with access to food and other essential household supplies. Celia was one of these microentrepreneurs who woke up at dawn, opened her store daily to be of service to her community in Caloocan. But while the sales for her business increased, she was also weakened by the long hours of work and constant interaction with buyers. She got sick back in May from COVID-like symptoms and died at 55 years of age. Celia, a member of a Microinsurance Mutual Benefit Association (Mi-MBA), had microinsurance. When informed of her passing, the Mi-MBA staff promptly processed her insurance claim. Despite operational challenges during the lockdown, the Mi-MBA was able to settle Celia's family's claim within a week.

Celia's case is one of 428 other COVID-related deaths among members and beneficiaries that was promptly settled from 16 March- 15 July 2020 by Mi-MBAs connected with the Microinsurance MBA Association of the Philippines Inc. (MiMAP). These claims under MiMAP account for 2% of the total 20,540 microinsurance claims involving PhP 462.81 million that Mi-MBAs settled and paid for within the 4-month lockdown period.



#### **Microinsurance Just Around the Corner**

MiMAP, also known as RIMANSI, is composed of 18 Mi-MBAs and institutional partners spread all over the country. This network is united by a shared vision to bring microinsurance access and benefits to 48 million poor and low-income Filipinos by 2024. MiMAP has a collective outreach of 7 million individual members majority of whom are microentrepreneurs, small farmers and fishermen. As microinsurance coverage is likewise extended to members' families, insurance coverage is given to nearly 25 million Filipinos. MiMAP Mi-MBA members account for a substantial 62% share in the country's total microinsurance coverage of 40 million individuals in 2019.

Mi-MBAs The provide basic life microinsurance plans and a range of optional life plans that include coverage for health and retirement. For example, one Mi-MBA extends a microinsurance coverage of Fifty Thousand Pesos (PhP 50,000) for basic life insurance for only Sixty Pesos (PhP60) a month. More than having access to an affordable and good set of risk-protection products, the MBA is structured to be owned and governed by its members drawing on the power of mutual care and support.

During the first month of the lockdown, Mi-MBAs extended the grace period of 45 days to add 30 more days on premium collections while managing to sustain the processing and settlement of microinsurance claims. This move has helped ease the financial burden of members and their families

MiMAP has successfully lobbied with the Insurance Commission (IC) for MBA operations to be categorized as a frontline essential health service. This has paved the way for mobilization of staff to validate claims and to arrange for money transfer of approved claims. To further support members, MiMAP has also filed a proposal to allow Mi-MBAs to draw on the accumulated refundable equity value of members for premium payment when the prescribed grace period expires. If this proposal gets the nod of IC. members will be given more time to generate income and save up for the next premium payment.

### Microinsurance At Your Fingertips

With а growmembership base, ing Mi-MBAs have turned to technology to increase efficiency. This enabled Mi-MBAs to settle claims and release the insurance benefits within a day. The submission of claim documents has been made easy through electronic copies shared via email or other mobile phone applications such as FB messenger. MBA staff resorted to teaching members or their beneficiaries on use of phone camera or relevant software applications to ensure the timely submission of documents. A strong culture of mutual support keeps Mi-MBA staff flexible and committed to deliver responsible and efficient services.

Amidst the challenges brought about by the Covid-19 pandemic to the operations of the Mi-MBAs. Citi Foundation continues to support the growth of the microinsurance industry through a grant partnership with MiMAP (RIMANSI). The program aims to build capacities of Mi-MBAs by developing innovative mobile technology solutions and a member-education strategy that will help them adapt with the new normal conditions. Citi Foundation works to promote economic progress and improve the lives of people in low-income communities around the world.

In 2019, MiMAP Mi-MBAs mobilized a total of PhP 4.81 billion in contributions and premiums, paid PhP 1.43 billion in claims benefits, and reserved Php 956.10 million in refundable equity value to members. Also positioned as a regional microinsurance resource center through RIMANSI, MiMAP has provided technical support to promote, build and strengthen microinsurance in Cambodia, Fiji, Indonesia and Vietnam involving eight (8) microfinance institution partners.
