



Jobs at stake in EU row

The Philippines must play its cards right in renegotiating a trade deal with the European Union. Hundreds of thousands of Filipino jobs and 2 billion euros worth of Philippine commodity exports are at stake if Manila fails to work out an extension of the preferential tariff treatment granted by the EU.

The Philippines must play its cards right in renegotiating a trade deal with the European Union. Hundreds of thousands of Filipino jobs and 2 billion euros worth of Philippine commodity exports are at stake if Manila fails to work out an extension of the preferential tariff treatment granted by the EU.

The Philippines is a beneficiary of the EU Generalized System of Preferences Plus that offers tariff-free entry to some 6,724 Philippine products to the EU in exchange for compliance with 27 international conventions. The zero tariff makes Philippine products competitive in Europe and provides job opportunities in several local industries that are drawn to the European market. These products include dried and frozen mangoes, dried and frozen pineapples and banana chips.

The Federation of Free Workers has already warned that some 600,000 workers in the tuna industry could lose their livelihood if the Philippine government failed to renegotiate the trade incentives

Easier access to the European market by way of zero tariffs, however, is tied to the progress the Philippines is making on several issues, such as labor rights, environmental protection, gender equality, health, education, social-economic rights, people trafficking and the fight against corruption.

The Philippines has generally done well in meeting the requirements of the 27 conventions. But the EU lately expressed its misgivings on the administration's handling of the war on drugs and attempts to legalize the death penalty and reduce the criminal age of responsibility.

The criticism did not sit well with President Rodrigo Duterte, who eventually rejected European aid and claimed the EU was interfering on the country's internal affairs. The EU, meanwhile, has threatened to impose economic sanctions on the Philip-

Members of the Management Association of the Philippines are naturally alarmed with these developments. The removal of the GSP preferences, it says, will make Philippine products less competitive and seriously affect several industries. The association raised the specter of increasing unemployment during the time of pandemic.

The Philippines, according to Trade Secretary Ramon Lopez, is addressing the concerns of the EU with right information and facts. Manila must allay the fears of the European Union in the negotiating table where it matters. As in other trade negotiations, it must be forthright about the real conditions in the Philippines and stress its independence at the same

Cavite police were ordered to beef up its visibility in provincial borders and popular destinations in Tagaytay City to manage and control the arrival of tourists.

"We support the coordination and collaboration of the local government units and law enforcement agencies. This is a work in progress. a scenario of an increase in Covid cases to happen. That is why necessary health protocols must be properly and strictly implemented," Eleazar added.

He reminded the police force in Tagaytay City to regularly coordinate with its LGU in the crafting and implementation of more security and health safety protocols, as well as security adjustments, especially during weekends when the area receives more tourists.

He said police should focus on the entry of unauthorized tourists, or those coming from GCQ and higher quarantine status areas with no travel authority, and set up quarantine control points in the boundary of Laguna and Cavite.

Although both Laguna and Cavite are under the less strict modified GCQ, the setting up of a checkpoint would ensure that those coming from GCQ areas, particularly from Metro Manila, would not enter Cavite without a travel authority, Eleazar said. (with Priam F. Nepomuceno/PNA

President Duterte has approved the appointment of Finance Secretary Carlos Dominguez III as ex-officio chairperson of the Governing Board of the Philippine Tax Ácademy (PTA).

The appointments of Commissioner Caesar Dulay of the Bureau of Internal Revenue (BIR) and Commissioner Rey Leonardo Guerrero of the Bureau of Customs (BOC) as ex-officio vice-chairpersons of the PTA Governing Board were likewise approved by the President, the Department of Finance (DOF) said.

In his report during a recent DOF Executive Committee (Execom) meeting, Finance Undersecretary Gil Beltran said that despite the COVID-9 pandemic, the PTA has continued to provide training to 258 government employees by migrating the courses offered by the Academy online.

The employees trained from April to June through the PTA's e-learning system. They include 28 from the BIR, 152 from the BOC and 47 from the DOF, Beltran said in his report to Dominguez during the meet-

Another batch of 31 employees from the BOC was undergoing online PTA training as of the first week of September, he added.

Beltran, who is the DOF's chief economist and anti-red tape czar, said the PTA is also conducting its basic Integrity Education Program covering 79 BIR employees and a separate refresher and integrity education course for 2,000 BOC workers assigned to the Customs main office and the bureau's various ports.

By the end of their PTA training, around 600 new BIR employees will be inducted into the service before the end of 2020, Beltran said.

Beltran said local government treasurers also continue to receive training online through the PTA's e-learning system.

Under Republic Act (RA) 10143, the PTA "shall serve as a learning institution for tax collectors and administrators of the government and selected applicants from the private sector.'

This law provides that, "All existing officials and personnel of the BIR, the BOC and the BLGF (Bureau of Local Government Finance) shall be required to undergo the re-tooling and enhancement seminars and training programs to be conducted by the Philippine Tax Academy.

It also requires "all applicants to the said bu-"to pass the basic courses before they can be hired whether on contractual or permanent status." (PR)

Addressing the concerns of teachers amid uncertainties in this time of the COVID-19 pandemic is the best way to celebrate National Teachers' Month. For Senator Win Gatchalian, this is the most meaningful way to observe the month-long celebration which culminates on October 5, coinciding with the official school opening.

Gatchalian reiterated that addressing the health care needs of teachers should be a top priority to ensure the successful implementation of the Basic Education Learning Continuity Plan (BE-LCP) under the dire consequences of the coronavirus. According to Gatchalian, teachers should be assured of healthcare support, including coverage for hospitalization, medication, and treatment, should they test positive for COVID-19. Without this assurance, they will lack confidence to perform their duties and the Learning Continuity Plan will fail, the senator warned

On celebrating National Teachers' Month: Address teachers' concerns, fears on class reopening

The Department of Education (DepEd) earlier assured that while its 2020 budget does not have allocations for COVID-19 treatment, teachers and non-teaching staff are covered by the Philippine Health Insurance Corporation (PhilHealth) like all government employees. To ensure that their needs are immediately addressed, however, Gatchalian urged DepEd to formalize a partnership with the state insurer in putting up a "special lane."

Though DepEd is already in talks with Phil-Health, the Employees' Compensation Commission (ECC) and the Government Service Insurance System (GSIS), the senator said it is crucial to finalize and roll out these partnerships before the opening of classes. He pointed out that since teachers will be distributing self-learning modules and risking their safety when face-to-face classes resume, they are vulnerable to getting infected with COVID-19.

Latest DepEd figures show (August 23) that 823 DepEd personnel and learners contracted COVID-19, 310 of which are active cases, 23 have died, and 490 have recovered. Out of these cases, 297 are learners, 340 are teachers, and 186 are non-teaching personnel.

Gatchalian also sought the smooth distribution of cash-assistance to displaced teaching and non-teaching personnel from public and private schools, which is mandated under Bayanihan to Recover As One Act or Bayanihan 2.

Botika-on-Wheels (BoW), the Provincial Government's initiative rolled out in the municipality of Noveleta on September 7 - 10, 2020 giving out maintenance medicines to senior citizens and vitamins to children.

About 1,563 Senior Citizens benefited from the activity while 1,817 children in the municipality received vitamins to help boost their immune system.

BoW is the brain project of the Office of the Governor that aimed primarily to help the vulnerable group of Senior Citizens who are not allowed to leave their houses as well as caring for the children's health during the pandemic, as it brings the health services closer to the people in the barangays.

rent them from shops for the day if they need to do an assignment. We hope to fix this problem by giving students access to finance to buy a laptop.

Covid-19 has forced students into online learning. This is challenging if students don't have their own laptops and shops aren't open to rent from. Because of Covid-19, we think this is the right time to launch this product.

As well as impacting your decision to launch, has Covid-19 been a challenge for your operations?

The most challenging thing in this pandemic is the promotion process. We would usually promote face to face, but we have switched to digital marketing and online promotion. We used to be flexible and could promote directly to people but now we have to work with the universities and get permission to promote online before the classes start. We also have an e-brochure and video promotion which we're promoting through social media.

We were not able to do a product development workshop or staff training in person before the launch because of Covid-19 restrictions so we did a lot of it virtually through Zoom calls and small groups of face to face meetings. We had not done workshops like this before and we had to be flexible and adapt so that we could still pilot the product in the current circumstance.

What are you hoping that you will achieve with the new product?

We hope the product will increase the number of students that own laptops so that they can study better and improve their grades. We are optimistic that the product will meet the demand and that is designed to its target audiences. We plan to cross-sell with savings for semester fees and hope to expand the product beyond Singaparna if it is successful. BPR Nusumma Singaparna already lends to teachers and we are hoping this new product will increase Nusumma Singaparna's branding as the Educational Bank in Tasikmalaya.

FINANCING EDUCATION TECHNOLOGY IN ASIA PACIFIC



At the peak of Covid-19 forced school closures, it was estimated that 1.5 billion children were out of school in 165 countries, equating to 87% of the global school-aged population. Governments and education companies reacted rapidly with more than 90% of ministries of education enacting policies to provide digital and broadcast remote learning. However, according to a recent UNICEF study, at least 463 million students (31% of students worldwide) have been cut off from education and cannot be reached by remote learning programs due to a lack of necessary household assets or policies geared towards their needs.

DISPARITIES IN DEVICE ACCESS FOR LEARNING

For students to engage in remote learning, they require access to devices such as mobile phones, tablets or televisions. Low-income families may not always have access to these devices or, in families where there is a device in the home, the device is often utilised by the parent which limits the time a child can use the device for learning. Sharing one device can be even more difficult for families with more than one school-aged child. In South Asia, East Asia, and the Pacific, UNICEF estimated that 227 million children cannot be reached by either digital or broadcast learning, which is more than 28% of school-aged children in the region.

It is not only families that face difficulties accessing devices for remote learning. Non-state affordable schools face similar challenges. EduFinance market research conducted in West Bengal, India in late 2019 found that while most school leaders interviewed owned a mobile phone, only 18% of school leaders owned a computer.

Similarly, after interviewing K12 non-state affordable schools in Indonesia, EduFinance found the majority of low-cost schools do not own computers despite students being expected to take exams on computers. Many of these schools rent or borrow equipment from other schools on a short-term basis. During these same interviews in August 2019, 36% of school leaders saw a need to invest in ICT equipment for staff or students. We expect this need to have risen over the past 12 months. However, device purchases and data can be costly and require upfront cash, which many families and schools are unlikely to have due to the impact of Covid-19 on household income and temporary school closures.

MEETING THE GROWING DEMAND FOR DEVICES

The growing demand for technology is not a new trend. In EduFinance market research, parents often cite investment into computers as the number one item they want their school to invest in. The demand existed in low-resource communities before the pandemic. However, Covid-19 has in-

creased the urgency of the need to access technology for learning while also highlighting the disparity in access.

As we enter September and see school restrictions begin to lift in many countries, the need for technology remains. Covid-19 has fundamentally changed the landscape of education and demands new innovations to make online learning more accessible to a wider range of children, mitigating future learning loss implications if the need to close schools occurs again, whether on a global or local level.

Financial institutions that serve low-income communities are in a unique position to offer tailored loan products that can help families and schools access and purchase devices. We spoke with two of our financial institution partners in Indonesia and the Philippines to discuss their approaches and how they are adapting their loan products during Covid-19 as a way to address this increased need.



SPOTLIGHT: CARD LFC, PHILIPPINES JULIUS ALIP, PRESIDENT AND CEO

Thank you, Julius, for speaking with EduFinance about how CARD LFC is financing technology for education in the Philippines. Before we talk about how Covid-19 has affected your model, it would be great to first get an overview of the current product that CARD LFC offers schools.

CARD LFC is a leasing and finance company under the CARD MRI umbrella, a group of mutually reinforcing institutions with a common goal of eradicating poverty in the Philippines. We offer finance lease and working capital loans for schools and are also experimenting with direct loans to teachers for technology during Covid-19.

Our current financing model for schools lends directly to the schools for financing tablets and computers that can be used by teachers and students. We absorbed the portfolio of a finance company offering this product to schools several years ago. We kept the product because CARD believes in the lasting impact that education has on poverty eradication and we want to level the playing field for children and schools that are not well funded. We do not compete with large banks for premier schools. We are needed by the schools that have just enough capital.

What do you think works well about the model and are there any lessons you have learnt along the way?

Identifying our target market and what sets us apart was key to our business strategy. Big commercial banks will offer better interest rates to larger and higher-income schools, but small and medium affordable schools will choose CARD LFC because we are able to say what makes us different. We don't ask huge

documentary requirements; we give speedy credit decision and offer good customer service. We invest in relationship building and business development to get new clients and focus on keeping our existing customers happy and satisfied. It is also important to make alliances with like-minded companies, like our partnership with Opportunity EduFinance to develop a credit-scoring model that enables process efficiency.

What was the feedback you received from your clients during Covid-19 and how did you respond?

We heard from the schools that we serve that they had issues transferring to remote learning and needed help with capacity building of teachers. The delivery of courses and course material are now all delivered using technology through tablets and computers. CARD LFC's leasing and financing products help schools, students, and teachers to access it.

Our exploration with financing teachers is also a response to Covid-19. We introduced it as we kept receiving queries from government schoolteachers who were not able to access laptops but needed them to continue remote teaching.

What are your goals for your education portfolio during the pandemic and beyond?

Covid-19 has increased the demand for access to technology for education. The portfolio is only small at the moment, but we want to expand and lend to more schools to fulfil our mission of fighting poverty by enabling affordable access to technology. We are always on the lookout for schools that need our services.



SPOTLIGHT: BANK NUSUMMA, INDONESIA DESINAYA AGDI, BUSINESS DEVELOPMENT MANAGER, ELSARANTI BPM ANALYST, AND MARISKYA AYU AIDIA, RISK MANAGEMENT SPECIALIST

Thank you Naya, Mariska and Elsa for speaking to us about the new loan product that BPR Nusumma Singaparna will pilot this month. Could you give us an overview of the laptop ABDI loan product?

The Laptop ABDI loan is targeted to university students in Singaparna, Indonesia. We have two aims through the Laptop ABDI loan. They are 1) to provide easier access to laptop ownership to enhance the learning process for university students, and 2) to support the digital learning transformation among university students.

What made you decide on launching the Laptop ABDI loan product?

Based on key findings from an Opportunity EduFinance research report, we found that most students at university face challenges to purchase laptops. We also interviewed some of our employees who are also students and found that there is a really small amount of students that own their own laptops at university. Most students borrow laptops from other people or
