EDITORYAL:

Longer economic recession

"Authorities should aggressively reopen the economy now before it is too late."

The economic recession in the Philippines will persist for a longer period of time. With limited public transportation and many areas protecting their borders from each other, it is inconceivable to expect economic activities to go back to their pre-COVID-19 levels soon.

The World Bank now sees the economy contracting 6.9 percent this year after averaging a 6.6-percent growth from 2015 to 2019. The latest projection from the bank is worse than its estimate of -1.9 percent in June.

Our economic managers will not likely contest the dire forecast of the World Bank. A visit to a typical shopping mall will show plenty of empty stalls and much fewer people visiting their favorite hangouts. Many department stores are still closed while fast-food restaurants operate on a skeleton staff.

Ndiamé Diop, World Bank country director for Brunei, Malaysia, the Philippines and Thailand, has suggested assistance to the poor and vulnerable families and micro and small enterprises will help cushion the impact of the pandemic and hasten economic recovery in the Philippines. The Philippines, he says, must act now to reduce the impact and strengthen the recovery.

The government's several aid programs have somehow helped the poor cope up with the pandemic in the face of reduced economic opportunities. Every peso given to the poor and vulnerable families through social assistance theoretically translates into demand

for basic goods and services in local communities. The World Bank says this, in turn, supports micro and small enterprises and the government's recovery efforts.

The state assistance, however, may not be sustainable. It may impair the government's finances in the long haul. Economic recovery will hinge largely on a more aggressive reopening. Every single Filipino who is forced to stay home because of limited public transportation will not be able to contribute to consumer spending. Factories and manufacturing companies take their cue on the spending power of the consumers.

Strict quarantine measures that restricted mobility, work-from-home arrangements and closures of workplaces greatly curbed economic activities in the first and second quarters of the year. Authorities, thus, should aggressively reopen the economy now before it is too late.



With barely a few days to go before classes in public schools open, Senator Win Gatchalian pointed out the need to spare teachers from a congested workload to prevent burnout amid the country's shift to distance

The Chairman of the Senate Committee on Basic Education, Arts and Culture warned that bombarding public school teachers with loads of tasks would increase teachers' stress and anxiety levels, which would hamper the effectiveness and quality of instruction for more than 22 million learners enrolled in public schools.

The workload assigned to teachers and principals is one of the issues raised in a Senate panel hearing on the opening of classes. During the said hearing, Philippine Elementary School Principals Association (PESPA) president Dr. Ferdinand Millan asked the Department of Education (DepEd) to stagger the different activities in preparation for class openings.

There are lots of programs and projects in the central, regional, and division offices on the part of teachers and principals that cause cognitive overload," the

Teachers' workload should be decongested to prevent burnout

PESPA president said.

Gatchalian learned that teachers and principals are "multi-tasking" ahead of the October 5 class opening. On top of preparing for the learning materials, including the printed self-learning modules that will be distributed to learners, teachers and principals are also attending webinars and completing courses on different learning modalities.

To address the issue of congested teacher workload, Gatchalian is seeking a Senate inquiry on the implementation of the Magna Carta for Public School Teachers (Republic Act No. 4670), which seeks to improve the living and working conditions of public school teachers. The Magna Carta mandates that public school teachers shall not render more than six hours of teaching in a day. Public school teachers are entitled to additional compensation if their teaching load exceeds six hours or if they perform activities outside their normal duties.

Even with these provisions in the Magna Carta, teachers are burdened with non-teaching tasks, even before the COVID-19 pandemic hit the country, Gatchalian noted.

According to a February 2019 policy paper from the Philippine Institute for Development Studies (PIDS), teachers receive additional designations on student guidance, budget, disaster response, and health. Teachers' participation is also expected in government programs such as mass immunization, deworming, feeding, and election, among others.

They never stop in their efforts to reach out to all students to make sure that they will be onboard when classes open on October 5. We are proud of them!" ended Gatchalian.



The live exchanges of the electronic certificates of origin (e-COs) among the Philippines and the nine other members of the Association of Southeast Asian Nations (ASEAN) via a regional initiative designed to facilitate trade through the online exchange of customs and other border documents has averaged around 8,712 transactions per month since January this year, the Department of Finance (DOF) said.

A report by Finance Undersecretary Gil Beltran show that from January to August this year, about 78,000 transactions were processed through the Philippines' National Single Window (NSW) or TradeNet, which aims to simplify applications for import and export documents by allowing their processing online.

Beltran informed Finance Secretary Carlos Dominguez III during a recent DOF Executive Committee meeting that the Anti-Red Tape Authority (ARTA) will be included in the NSW Steering Committee to fast-track the streamlining of the various regulatory agencies involved in TradeNet.

"Year-to-date, there are about 78,000 transactions that we have through the National Single Window," said Beltran, the DOF's anti-red tape czar.

Aside from the Philippines, the rest of the ASEAN member-states have also gone live and started exchanging e-COs on the ASW. These are Indonesia, Malaysia, Thailand, Singapore, Brunei, Cambodia, Myanmar, Laos and Vietnam, Beltran said.

Customs Memorandum Order (CMO) 15-2019 on the Operationalization of the Issuance of e-COs was signed and issued by Customs Commissioner Rey Leonardo Guerrero on March 18 last year.

TradeNet.gov.ph, which will perform the functions of the government's National Single Window (NSW), has been interconnected to the ASW, which is a regional initiative that aims to speed up cargo clearances and promote economic integration by enabling the electronic exchange of border documents among the 10 ASEAN member-states.

Once TradeNet is fully operational, Beltran said that traders may apply online for import and export permits for commodities such as rice, sugar, used motor vehicles, chemicals (toluene), frozen meat, medicines (for humans, animals, or fish) and cured tobacco.

The Duterte administration's goal is to have all 75 trade regulatory government agencies across 18 government departments fully interconnected via TradeNet.

TradeNet will simplify import and export documentary processes covering an initial 7,400 regulated products. (PR) e-Certificates (PR)

Finance Secretary Carlos Dominguez III has called on local government units (LGUs) to embrace the switch to digital technologies to vastly improve their delivery of frontline services and generate more revenues under the New Economy in the post-pandemic era.

Dominguez said executives should also start working with the national government in preparing for the seamless transfer to their offices of the additional devolved functions, services and facilities that they would have to assume with the implementation beginning 2022 of the Supreme Court (SC) ruling on the far higher revenue allotment (IRA) share of LGUs.

Under the high court's Mandanas doctrine, the IRA share of LGUs should come from all national taxes, as mandated under the 1991 Local Government Code, and not from just the taxes collected by the Bureau of Internal Revenue (BIR) within the respective jurisdictions of LGUs.

This expanded revenue coverage means the IRA share of LGUs should also include other taxes such as those collected by the Bureau of Customs (BOC).

Dominguez said this sizable IRA increase for LGUs will let them pumpprime their respective local economies in the New

Economy.

"As we anticipate a new economy in the post-pandemic era, strongly encourage our LGUs to adopt digital technologies to efficiently deliver frontline services. said Dominguez in Monday's webinar hosted by the Union of Local Government Authorities of the Philippines (ULAP).

This should include the processing of business registration and the collection of local taxes. Investments in information technology will not only make for more responsive governance, it will improve revenue generation of our LGUs," he said.

Led by its president, Quirino Governor Dakila Carlo Cua, ULAP organized the online dialogue with the Departments of Finance (DOF) and of Interior and Local Government (DILG) to tackle the recovery of local economies from the devastation wrought by the COVID-19 pandemic.

During the we-

binar, Dominguez expressed confidence in the country's ability to regain its growth momentum by next year, powered by several fiscally responsible economic stimulus measures and supported by a strong financial position resulting from Pres-Duterte's prudent economic policies and the game-changing reforms both the introduced by executive and legislative departments.

"We remain confident that we will win back our growth momentum by next year. A lot will depend on whether we can revive consumer confidence and domestic demand." Dominguez said.

"Let us work hand in hand to beat this pandemic. We have a future to win," he told the local chief executives during the online event.

Dominguez said that with the end of the public health emergency triggered by the pandemic remaining uncertain, the government should continuously build up its fiscal resilience by optimizing the revenue generation capacity at both the local and national levels, and improving tax administra-

He thanked the local chief executives for the "invaluable work" they have been doing in fighting the pandemic and assured them of the national government's support in helping LGUs bounce back from this crisis.

"The national economy. after all, is the sum of all our local economies. LGUs are at the frontline of serving vulnerable communities. You are also catalysts for building a new economy while we do all we can to address this global health emergency,' Dominguez said.

He said the nagovernment will continue to rely on LGUs for continued monitoring and contact tracing of possible COVID-19 infections even with the early signs of improvement in the public health situation, as well as in reviving economic activities in the coming months.

Dominguez said the national government demonstrated its commitment to help LGUs deal with the pandemic by granting them a onetime financial grant of P37 billion under the Bayanihan To Heal As One Act (Bayanihan 1) to boost the capability of their health care systems and provide

relief assistance to affected households.

Under Bayanihan to Recover as One Act (Bayanihan 2), Dominguez said LGUs can continue to count on several streams of support to restart their respective local economies and rescue businesses through the following:

Extension of the carry-over period of net losses in 2020 and 2021 from three to five years for businesses.

Dominguez said this extension will allow micro. small and medium enterprises (MSMEs) to deduct incurred losses from tax payments for a longer period, thus giving them more time to set their finances in order and return

to profitability;
Infusion of more capital to government financial institutions (GFIs) to dramatically expand their lending to MSMEs.

This will have a large multiplier effect in economic activity, he said, given that every peso pumped into GFIs will generate around 10 times its value in credit.

The additional capital of P24.47 billion to the Land Bank of the Philippines (LandBank) and the Development Bank of the Philippines (DBP) and another P1 billion each to both of them for interest subsidies for new and existing loans secured by LGUs will be used to protect the productive parts of the economy and enable GFIs to provide wholesale financing to rural banks and microfinance institutions, he said;

Allocation of P5 billion to the Philippine Guarantee Corp. (PHilGuarantee) for its credit guarantee program; and

Making available P10 billion for the lending programs and interest rate subsidies of the Small Business Corp. (SBC).

Outside Bayanihan 2law, Dominguez said LGUs can access funds from the Municipal Development Fund Office (MDFO) under LandBank as the DOF-attached Bureau Local Government Finance (BLGF) has already streamlined its process in issuing certificates on net debt service ceiling and borrowing capacity to LGUs by allowing applications and other requirements to be done electronically.

(BSP), meanwhile, has agreed to count loans extended to MSMEs as part of the banks' compliance with reserve requirements to continue freeing up more funds to support the revival of our small businesses, Dominguez said. He said both the Land-Bank and DBP have designed several lending programs to promote the recovery of business enterprises and rebuild local economies, while the DOF has been investing in training programs that aim to raise the competencies of local government treasurers through the BLGF's Standardized Examination and Assessment for Local Treasury Service (SEAL).

Both the BLGF and the Philippine Tax Academy (PTA) are also preparing online learning modules for local government treasurers and assessors. he added.

Dominguez said the national government is working closely with the Congress to swiftly pass several legislative imperatives vital to the country's recovery from the pandemic.

These include measures:

allowing banks to dispose of non-performing loans and assets:

reducing the corporate income tax (CIT) rate from 30 to 25 percent and other investor-friendly reforms through the swift congressional approval of the recalibrated Corporate Recovery and Tax Incentives for Enterprises Act (CREATE)

providing support to strategically important companies facing solvency issues; and

amending the Agri-Agra Reform Credit Act to make it easier for banks to pump fresh capital into the farm sector.

Many of you expressed support for these reforms. There is still time for LGUs to manifest to the Congress the urgency of enacting these measures within this year," Dominguez said.

Dominguez further said the government's economic recovery strategy remains anchored on sustaining the 'Build, Build. Build' program. which covers infrastructure projects outside Metro Manila to immediately create jobs, encourage investments and increase economic activity outside the national capital region.

MOA signed

Finance Secretary Carlos Dominguez III has assured micro, small and medium enterprises (MS-MEs) that the Duterte administration's plan for the economy to recover from the coronavirus-induced global crisis covers an array of programs meant to help them get back on their feet.

Dominguez said two bills pending in the Congress—one on immediately slashing the corporate income tax (CIT) rate and another designed to free the banking system from bad loans and other non-performing assets (NPAs)—will benefit big firms as well as MSMEs hit by the pandemic.

The proposed Corporate Recovery and Tax Incentives for Enterprises Act (CREATE) will lower the CIT from the current 30 percent to 25 percent, which means tax breaks for 99 percent of business enterprises, which are the MSMEs, Dominguez said.

"The small and medium enterprises in this country have never had a tax break. It's the big ones that go and register with PEZA (Philippine Eco-

nomic Zone Authority (PEZA) (that are given tax) incentives," Dominguez said during a recent briefing by the Development Budget Coordination Committee (DBCC) before the House appropriations committee.

Dominguez said the passage of CREATE, which will align the corporate tax rate with the ASE-AN average, will make the Philippines the only government to provide tax breaks to MSMEs.

Under the current system, about 3,000 big companies enjoy incentives that let them pay discounted tax rates of between 6 and 13 percent of net income only, while small enterprises that make up 99 percent of local businesses and employ majority of Filipino workers pay the regular CIT of 30 percent, which is the highest in the region.

Another pending legislative measure—the Financial Institutions Strategic Transfer (FIST) bill will allow banks to dispose of their NPAs through newly-formed asset management companies similar to the special purpose vehicles (SPVs) created in

the 2000s in response to the 1997 Asian financial

Dominguez said that clearing the books of banks of roughly P1 trillion of bad loans and other NPAs will, in turn, enable them to lend another P3.5 trillion to private businesses, most of them MSMEs. "Without the FIST bill, the economy is going to be worse off and the worst hit is going to be the small and medium enterprises," Dominguez said. "Allowing banks to clear their books allows them, actually, to have more money for the small and medium enterprises.'

On top of these two pending bills, Dominguez said the Monetary Board (MB), for the first time ever, allowed loans to MSMEs to be used by banks as compliance with their reserve requirements

Preliminary data from the Bangko Sentral ng Pilipinas (BSP) show that as of July 23, around 97 banks have disbursed loans to MSMEs, which increased the reserve requirement balance from MSME loans to an average of P84.2 billion.

This was more than seven times the P9.9-billion average daily balance of MSME loans used by 55 banks as alternative compliance with the reserve requirement as of end-April, the BSP said.

In his 5th State-of-the-Nation Address (SONA), President Duterte called on the Congress to pass the CREATE and FIST bills as part of the government's comprehensive economic recovery plan for the Philippines to rise above the crisis triggered by the COVID-19 pandemic.

On top of immediately reducing the CIT to 25 percent, CREATE will also provide the government flexibility in the grant of fiscal and non-fiscal incentives to corporations and investors, which will be critical as the country competes internationally for high-value investments

The CIT cut

The CIT cut alone will free up around P42 billion in capital for businesses in the first year of CREATE's implementation, Dominguez said.

For the succeeding five years when the tax would be reduced by 1 percentage point every year until it goes down to 20 percent, the total estimate is around P625 billion in foregone revenues for the government but which will translate into additional capital for businesses, mostly MSMEs.

The FIST bill will allow the formation of Financial Institutions Strategic Transfer Corporations (FISTCs) that will absorb the financial risks of distressed banks.

Dominguez said enacting the FIST law will preserve the asset quality of banking institutions and ensure the continued strength of the financial sector, which, in turn, will help the economy recover faster from the COVID-19 pandemic.

The FIST Act is

an "improved version" of the old SPV law, and will help the financial system mobilize credit for the productive segments of the economy, Dominguez said.

FIST will also encourage the private sector, government financial institutions (GFIs) and government-owned or-controlled corporations (GOCCs) to help rehabilitate distressed businesses, he added

The measure provides tax incentives to defray the transaction and transfer costs of NPAs to the would-be asset management companies.

Dominguez said this would entail foregone revenues of between P3.3 billion and P13 billion every year for the next five years to clear the books of banks of bad loans, and to keep the economy going. "We believe that the economic benefits of strengthening the financial sector through this effort outweigh the fiscal costs of doing so," he said. (PR)
