PREVENTION AND CONTROL OF ANIMAL DISEASES IN THE PROVINCE: In response to the increasing cases of animal diseases in Cavite, the Provincial Veterinary Office (PVO) headed by Dr. May M. Magno, Provincial Veterinarian in coordination with the Agricultural Training Institute (ATI) conducted a Training on Sample Collection for Barangay Biosecurity Officers on June 1, 2021 at Imus City Slaughter House and on June 4, 2021 at Indang Municipal Slaughter House. The training was attended by agricultural extension workers of Municipal and City Agriculture and Veterinary Offices of Cavite LGUs.

Lecturers include Dr. Gloria S. Digma, Dr. Gerry Romen, Dr. Gladys Credo, Dr. Kristine Roraldo and Ms. Marjo Mojica of PVO. Topics discussed during the training were the revised guidelines on the local movement of swine, pork, pork products and pork by-products outside disease outbreak areas, guidelines on the implementation of the recovery, rehabilitation and repopulation assistance program for ASF-affected and non-ASF affected areas, guidelines on local transport shipment of animals, animal products and by-products, sample collection, handling, storage and transport, and ASF situation in Cavite. Participants were also trained to collect blood samples from the animals. This undertaking was the provincial government's response to prevent the further spread of diseases in animals. (Janice D. ## **Nobody deserving**

"Maybe the President is right."

We have not by any means cleared the COVID-19 hurdle yet and the economic devastation that it has wrought, but already, politicians are talking about running for president next year.

Out of the morass of pre-election claptrap that has filled the recent new cycles comes this gem from none other than President Duterte, who says he sees nobody "deserving" to be his successor. He also said he warned his daughter, Davao City Mayor Sara Duterte-Carpio, not to seek the country's highest office because it will be all about work, doing an "empty" job.

The advice, of course, runs counter to the whisperings of failed politicians who seek to ride on another Duterte's coattails. One is a failed presidential candidate who says he will be happy to run for vice president as the mayor's running mate. Another is a frustrated senatorial aspirant who was told by President Duterte that he had no chance of winning in 2019, and who now says he will run for senator only if the President's daughter runs for president—providing us with yet another reason Sara should not run.

Then there is the freshman senator who has made it his life's mission to be in the same room as the President and to photographically document their activities together. He has disavowed any interest in the presidency and says he will blindly follow another Duterte—but issues press statements like a presidential candidate.

"Maybe the President is right."

We have not by any means cleared the COVID-19 hurdle yet and the economic devastation that it has wrought, but already, politicians are talking about running for president next year.

life's mission to be in the same room as the President and to photographically document their activities together. He has disavowed any interest in the presidency and says he will blindly follow another Duterte—but issues press statements like a presidential candidate.

Still other politicians want the President to run for vice president and to nominate his presidential running mate in a move that clearly seeks to bypass the constitutional ban on a second presidential term. In their eyes, this is the best way of ensuring that the good times continue to roll after Duterte's six-year term ends next year.

There is, too, the former senator and pardoned coup plotter, who once thought he could change a government through the barrel of a gun. He is now offering his services as the standard bearer for opposition groups, should the current vice president, who is the leader of the opposition, decline to run for president next year.

Another senator declared he, too, would seek the presidency, only to backtrack after a few days to say the plan was still under study.

Still another senator—an ally of the President—says he will either retire from politics or seek the highest elected position in the country again, a contest he lost in 2004. The Senate President has said he will run for vice president, only if this failed candidate tries again next year.

Maybe the President was right after all.

## BIR filing . . .

The Bureau of Internal Revenue (BIR) is set to file criminal charges and assess deficiency taxes against the persons behind the manufacture of some P544 million-worth of counterfeit cigarette tax stamps seized recently in Bacolod City.

In its report to Finance Secretary Carlos Dominguez III, the BIR said the 15 million pieces of these fake internal revenue tax stamps were confiscated last May 4 at a warehouse and in three trucks parked outside the premises in Barangay Tangub in Bacolod City, along with various raw and packaging materials for

cigarette production.

"The BIR office in Region 12 will file--and we coordinated with them--the necessary criminal cases and the assessment of deficiency taxes on this," BIR Deputy Commissioner Arnel Guballa said in his report during a recent Department of Finance (DOF) Executive Committee (Execom) meeting.

Also during the meeting, Guballa reported that the BIR Strike Team, along with personnel from the Philippine Economic Zone Authority (PEZA), inspected the facility of GB Global Exprez Inc. at the Angeles Industrial Park in Pampanga and found a total of 3,068 cigarette mastercases of the A380 and Manchester brands inside the facility, which GB Global personnel at the site claimed that the cigarettes were manufactured as part of a "dry run" of its facilities.

The BIR made sure that the subject cigarettes would not be removed from the premises as the Bureau will undertake appropriate action against the company.

Guballa also reported during the Execom meeting that the BIR had padlocked 83 establishments and collected P737.28 million in April 2021 alone under its Oplan Kandado program. (PR)

Samples of activities under this Tier include vaccine development and production; manufacture of 3D printers, drones, robots, electrical vehicles, plug-in hybrid electrical vehicles, and optical image devices; establishment of smart factories and smart cities, and predictive agriculture, Aldaba said.

Also covered by Tier 3, she said, are the introduction of new products that embed new technologies; adoption of innovative processes using industry 4.0 technologies such as Artificial Intelligence, Machine Learning, and the Internet of Things.

During the meeting, the FIRB also approved

the key features of the online Fiscal Incentives Registration and Monitoring System (FIRMS) for investors applying for incentives, with some modifications to ensure that the process would be fully compliant with the provisions of the Ease of Doing Business (EODB) Law.

FIRMS would be set up to make it easy and convenient for potential investors to apply and track the progress of their applications.

The FIRB also approved the proposals presented by DOF Assistant Secretary and FIRB Secretariat Head Juvy Danofrata on allowing the Technical Committee to recommend to the Board: 1) policies for the development and expansion of the domestic supply chain in order to reduce dependence on imports, promote diversification, and raise the quality of locally consumed and exported products; and 2) place-specific SIPPs during periods of recovery from calamities and post-conflict situations.

Tionko, as head of the Technical Committee, was authorized by the FIRB to obtain information from other government agencies relevant to the grant of tax subsidies and incentives to businesses. (PR)

## To BIR: Suspend imposition of tax hike on private schools

Senator Win Gatchalian is urging the Bureau of Internal Revenue (BIR) to suspend the imposition of a 25 percent corporate income tax on private schools, warning that the added burden on struggling institutions amid the COVID-19 pandemic could lead to more school closures, job losses, and a more restricted access to education.

For the Chairman of the Senate Committee on Basic Education, Arts and Culture, BIR's Revenue Regulation (RR) 5-2021 runs counter to the intention of the Corporate Recovery and Tax Incentives for Enterprises Act or the CREATE Act (Republic Act No. 11534) which seeks to impose a one percent tax rate on proprietary educational institutions for a three-year period. The law also provides that these institutions have to pay ten percent tax on their taxable income.

Under the CREATE Law, 'proprietary' means a private hospital or private school maintained and administered by private individuals or groups. These institutions should have an issued permit to operate from the Department of Education (DepEd), the Commission on Higher Education (CHED), and the Technical Education and Skills Development Authority (TESDA).

Based on RR 5-2021, however, proprietary educational institutions have to be non-profit to avail of the reduced tax rate. If these rules are imposed, private schools' income tax rate would increase by 150 percent

In an earlier statement, Gatchalian called the tax rule ill-timed considering how private schools are trying to stay afloat. He cited the March 2021 Labor Force Survey, which showed that the education sub-industry had the largest decrease in the number of employed persons from February to March 2021 at 248,000.

Last February, DepEd reported that 929 private schools did not operate for the school year (SY) 2020-2021. Citing a report from DepEd, the Coordinating Council of Private Educational Associations (CO-COPEA) said in a statement that enrollment in private K-12 schools dropped by over 900,000 compared to the previous school year.

Gatchalian is also mulling to file a resolution that would urge the BIR to suspend the imposition of the tax hike on private schools.



The Philippines will receive the biggest single day delivery of vaccines by far today, June 10, with the arrival of one million doses of Sinovac vaccines earlier this morning and the expected arrival of more than 2.2 million doses of the Pfizer vaccines.

Presidential Spokesperson Harry Roque made this announcement in a press briefing today, where he mentioned that today's delivery is part of the 11 million vaccine doses that are expected to be delivered this month of June.

"Sisiguraduhin natin na ang ating mga lokal na pamahalaan ay magkakaroon ng mga bakuna," said Secretary Roque.

This is in response to reports that some local government units have run out of vaccines and that some vaccination centers have stopped operating.

operating.

The Palace official added, "Tiniyak ng ating Vaccine Czar Secretary Carlito Galvez na magkakaroon ng steady supply ng bakuna at bibigyang prayoridad ng ating vaccine deployment ang mga lugar na most vulnerable sa COVID-19 surges, alinsunod sa direktiba ng ating Presidente."

Secretary Roque also gave assurance that new vaccine deliveries are on its way to areas that have reported to have used up all their vaccine supplies already. "Huwag po kayong mag-alala, may paparating na pong mga bagong suplay," Sec. Roque said.

Roque who is also spokesperson of the Inter-Agency Task Force (IATF) reiterated that there is no inequality in the distribution of vaccines. "It is based on science na talaga pong kung saan yung pinaka-mataas ang mga kaso ng COVID-19 ay binibigyan po natin ng karagdagang supply, dahil ang pagbabakuna nga po ay isang depensa laban sa lalo pang pagkalat ng COVID19," explained Sec. Roque.


On another matter, the President's spokesman said that on the suggestion to amend the Philippine Baselines Law, President Duterte is open to the idea and has asked the Office of the Executive Secretary for a full staff work.

"Ang sagot ni Presidente, pakisabi kay Justice, pag merong suggestions sa akin ibibigay ko muna yan sa Office ng Legal ng Executive Secretary, then it will be forwarded to the Executive Secretary for a recommendation for my decision," commented Sec. Roque about the issue.

Former Associate Justice of the Supreme Court Francis Jardeleza earlier wrote a letter to the President, saying a new Baselines Law needs legislation, contrary to the suggestion of certain quarters that a Presidential Proclamation would suffice.

Prof. Rommel Bagares, executive director of the Center for International Law, agreed with the former SC Associate Justice saying that an Executive Act cannot amend a law passed by Congress. Prof Bagares said that according to International Law, sovereign acts are needed to show acts of effective occupation by a sovereign and legislation is one of them.

Meanwhile, Dr. Melissa Loja, International Law scholar, explained that the proposed bill will identify the features claimed or occupied by the Philippines in the West Philippine Sea, like coordinates and names. Dr. Loja added that it will also identify and demarcate the baseline, and will reiterate continuing claims to sovereignty of the Philippines. ### OPS-PCOO



## FIRB adopts framework for investment perks applications

The Fiscal Incentives Review Board (FIRB) has adopted the framework for the grant of incentives to qualified industries under the government's Strategic Investment Priorities Plan (SIPP) that aims to attract high-value, labor-intensive investments that will create more jobs and further sharpen the Philippines' competitiveness in the global market.

As provided in the newly signed Corporate Recovery and Tax Incentives for Enterprises (CREATE) Law that rationalized the country's corporate tax incentives for investors, this framework puts flesh into the SIPP.

The menu and length of incentives that would be offered to corporations or investors will depend on the tier classification of the enterprise applying for the investment perks.

For instance, Tier 3, which covers sectors considered "critical to the structural transformation and industrial revolution of the economy" will receive the longest period of incentives.

This SIPP framework was drafted by the Department of Trade and Industry (DTI)-Board of Investments (BOI).

The three-tier structure of the incentives offered to priority investors is already contained in the CREATE Law.

After the adoption of the framework, Finance Secretary and FIRB Chairman Carlos Dominguez III urged the DTI to identify at least two leading companies in each of the industry tier and determine what incentives should be offered to these potential investors to encourage them to set up shop in the Philippines.

"Let's already identify these firms. Let's take a couple in Tier One, a couple in Tier Two, and a couple

in Tier Three, and let's do the research on them. Then, offer them and ask them: 'what will it take for you to come here?" Dominguez said during the FIRB's second meeting last week.

Dominguez said the investment promotion agencies (IPAs) can undertake these tasks.

DTI Secretary Ramon Lopez agreed with the proposal, which will now transform our IPAs into "marketing arms" rather than for them to merely function as processing agencies for investment applications.

Also during its second meeting, the FIRB gave the go-signal to Dominguez's recommendation to let the Board approve tax incentives for all investments amounting to over P1 billion per venture until the end of

After this period, the approval of incentives for investments of more than P1 billion but not more than P3 billion per venture will be delegated to the FIRB Technical Committee, which is chaired by Department of Finance (DOF) Undersecretary Antonette Tionko of the Revenue Operations (ROG).

The FIRB also approved during the meeting a proposal by Department of Budget and Management (DBM) Secretary Wendel Avisado to put in place an appeals process for investment projects disapproved by the Technical Committee. Such actions may be appealed with the FIRB board proper.

A recommendation by Tionko to provide the Board with a list of approved and disapproved investment projects was also approved.

DTI Undersecretary Rafaelita Aldaba discussed during the meeting the SIPP's features under the CREATE Law.

Under the SIPP, Tier 1 covers investments with high potential for creating jobs, value creation, and providing essential support to sectors critical to industrial development, as well as emerging industries with potential comparative advantage, Aldaba said.

Falling under this category are, among others, modern agriculture and food processing; agricultural production using modern technologies; design-focused industries such as furniture, games and toys, jewelry and garments; energy efficiency and environment-friendly activities; health and medical products; industrial parks; and ports, airports and seaports.

Aldaba said Tier 2 includes the manufacture of supplies, parts, and components not produced in the country, to encourage import substitution and address gaps in the domestic supply/value chain.

These activities, among others, are the production of iron, steel and non-ferrous metals, copper rods, plastics and synthetics in primary form, basic chemicals, and pharmaceuticals.

The production of fiber optic cables, refined petroleum, semiconductor devices and other electrical components, and machinery and equipment are also classified under Tier 2.

Tier 3 involves research and development (R&D) activities that yield significant high-value added results and higher productivity; breakthroughs in health and science; generation of new knowledge; commercialization of patents, industrial designs, copyrights and utility models; and highly technical manufacturing.
