<u>EDITORYAL:</u> 'Tough'

"We've bought into the obvious ones, and look where we are now."

A senator who may or may not run for president next year said the current vice president would win the elections if the sole measure were goodness of heart.

Senator Panfilo Lacson, however, said one also needed toughness and other qualities to lead the country.

We agree completely with the senator. Anybody who aspires for the top post in government, with our numerous domestic and international problems, has to be the epitome of toughness.

But what does the word exactly mean, in this context?

We suspect many of us still subscribe to obvious notions of toughness. For example, somebody like Lacson who brings with him decades of police and intelligence work would definitely qualify as tough. Remember how he dealt with menaces in his line of work. He wants to go after terrorists. As a legislator, he is not affiliated with any political patron. In this country of fast-changing political color and malleable positions on the issues of the day, Lacson has

cultivated an independent image, unlike many of his colleagues. Certainly, someone who appears to be his own person is a tough person.

Perhaps a more obvious brand would be that variant from Davao. Remember how city mayor Sara Duterte slapped a sheriff at the height of a squatters' demolition many years ago?

The fruit doesn't fall far from the tree. Sara's father, the President, is famous—notorious, really—for his tough talk when he decides someone is his enemy. He has shown no reverence for his critics, journalists, an American president, the Pope—God, even. He has no qualms issuing threats to kill; his minions at the Palace are always quick to dismiss his words as figures of speech.

At other times, they say he is joking when he talks tough—like the time he said he would jet ski to the disputed Spratly Islands to plant the Philippine flag

And now this same President is hounded by the International Criminal Court. The ICC prosecutor has applied for authorization to open a probe into alleged crimes against humanity committed in the name of the war against illegal drugs, and into the killings in Davao City during his long reign as local chief executive there. Human rights groups estimate the number of drug-war deaths at 27,000 even as the police says the official count is 7.000.

The Justice Department has also sought to look into the records of these drug killings, but so far

the results are far from encouraging.

A move of defiance—toughness, if you will—is Mr. Duterte' withdrawal from the Rome Statute and consequently the ICC. This makes the probe, to be carried out through the cooperation of local authorities, much more difficult.

Certainly, the crimes he is accused of and the manner with which he has received these allegations are evidence of toughness.

The question is, is this the brand of tough we need for our nation to get out of the slump we are in, caused by the pandemic and by many other festering issues?

It is easy to be swayed by simplistic portrayals of leaders posing as heroes out to defeat their problems and enemies. The truth is that toughness is not always how it is perceived to be. It is firmness and consistency in making and implementing policy. It is engaging in civilized discourse with people who don't fully agree with you, and finding ways you can still work together for the good of the people. It is picking people for the job not for their loyalty but for their competence. It is resisting the temptation to stick around after your time is up. It is empathizing with the downtrodden instead of blaming them for the systemic ills that consign them to their lot.

It is giving and receiving criticism based on evidence and the desire for improvement, not for taking down an adversary or saving face.

There are many ways to be tough. We hav

Such travel shall be allowed for all ages, subject to RT-PCR testing before travel for those below 18 and above 65 and other restrictions imposed by the DOT and the local government unit of the destination.

Data from the Malay, Aklan Municipal Tourism Office revealed that a total of 9,066 tourists arrived in Boracay through Caticlan from June 1 to 13. Of this number, 890 are travelers aged 0 to 12 years old while 178 are aged 60 and above.

About 64 percent or 5,772 visitors to Boracay came from the NCR, followed by visitors from Region 4A (CALABARZON), with Rizal having 681 visitors, Cavite with 639, and Laguna with 462.

Accredited staycation hotels in all GCQ areas were allowed to accommodate leisure guests of up to 100 percent of their capacity. Other DOT-accredited establishments in GCQ areas may operate at 30 percent capacity only for guests coming from the same household and subject to the strict monitoring of the local government unit

Accountability on vulgar learning module; scrutiny of modules' quality assurance needed

Those who created and cleared a self-learning module with a vulgar description of the mythical Filipino creature "Aswang" should be held accountable, Senator Win Gatchalian said.

The Chairman of the Senate Committee on Basic Education, Arts and Culture was referring to a now recalled Department of Education (DepEd) module that was flagged in a hearing of the House committee on public accounts. The said module used an obscene word that means sexual intercourse when translated to English.

Since the meaning of the word is clear and obviously not appropriate for young learners, Gatchalian suspects that the inclusion of the word in the module was intentional. What's worse for Gatchalian, however, is how these materials still get through DepEd's quality assurance process. The lawmaker then reiterated that those involved in the creation and clearing of the said material should be penalized.


"Obviously the system failed. And we also need to investigate this matter and hold the quality assurance mechanism or those people who are implementing the quality assurance to account. But more importantly, look for that person who wrote that," said Gatchalian.

DepEd Undersecretary Diosdado San Antonio said that the module was recalled last February and already rectified by the division office concerned. Based on the DepEd data, the module was used by Grade 10 students in Pampanga for the second quarter.

According to DepEd, 155 errors were found in learning materials from October 2020 to June 2021, 104 of which were from locally developed materials, 25 were reviewed by DepEd's Central Office, 19 were from unknown sources, five from DepEd TV, one from a privately-developed material, and one from a DepEd textbook.

Gatchalian said he will look into DepEd's quality assurance process in the upcoming Senate inquiry on the preparations for School Year 2021-2022. Senate Resolution No. 739, which Gatchalian filed, aims to assess the capacity of basic education institutions to deliver quality education for next school year, whether through face-to-face classes or distance learning.

abide by the guidelines of the IATF.

Until June 30, outdoor tourist attractions in GCQ areas, including NCR and Bulacan, may operate at 50 percent capacity, while those in Cavite, Laguna, and Rizal may operate at 30 percent capacity with strict adherence to minimum public health and safety guidelines.

Indoor tourist attractions such as museums and historical sites will be allowed to operate at 50 percent capacity in GCQ areas, at 30 percent in the NCR and Bulacan. They are not allowed in Laguna, Cavite, and Rizal.

Essential meetings and events which include Meetings, Incentives, Conferences, and Exhibitions (MICE) activities, and social events such as weddings, birthday celebrations, are allowed in GCQ areas at up to 50 percent of the capacity, except for NCR and Bulacan where essential meetings are only allowed at up to 30 percent of the capacity and social events are allowed at up to 10 percent.

Establishments in NCR and Bulacan granted with the government's Safety Seal may have an additional 10 percent capacity in their operations. All these events remain prohibited in Laguna, Cavite, and Rizal.

"The amended guidelines from the Task Force also comes with the responsibility to strictly adhere to the minimum health and safety protocols when traveling," Puyat reminded the public. (PR)

Dominguez . . .

Finance Secretary Carlos Dominguez III assured the media on Tuesday that while the Philippines may be behind other regional economies at this time in bouncing back from the malaise of the global pandemic, the country's recovery will be stronger on the back of its sound economic fundamentals.

This optimistic forecast is anchored on the structural and tax reforms implemented and are being put in place on the watch of President Duterte, along with "what did not happen" to the economy, which is as important as what did, Dominguez said.

"We might appear to be behind our neighbors for now, but our recovery will be stronger because of our sound fundamentals," Dominguez said. He said the COVID-19 vaccination program, which "has been rolling out quite well gives us hope that we can now fully reopen our economy."

He called on economic journalists to help communicate "the complete picture of our economic recovery story and the reasons behind our optimism." The head of the President 's economic team told a gathering of these journalists that the country, for instance, did not suffer the kind of fiscal downturn that typically accompanies an economic crisis even with the massive expenditures that the government has incurred as a result of the Covid-19 global economic and health crises.

Dominguez pointed out that when the pandemic-induced crisis hit the country last year, the government "did not have to go back to the drawing board in order to plan for the country's economic recovery" because "much of the spadework was done" over the last five years of the Duterte administration.

"Clearly, we avoided a lot of trouble. All the strengths that became evident when the challenges were greatest are not due to a stroke of good fortune. This was not luck. This was readiness," said Dominguez in his pre-recorded speech at the virtual forum organized by the Economic Journalists Association of the Philippines (EJAP).

"They are the results of many years of fiscal discipline, forward-looking policy reforms, and continuing improvement in our administrative systems—especially through the adoption of new digital technologies," Dominguez added.

Although it is clear that the pandemic dealt the Philippines a "heavy blow," he said that is not the full context of the country's story.

To underscore his point on the importance for the media to communicate to the public about "what did not happen" as being equally important as what did, Dominguez cited other examples, among

As a result of the Duterte administration's aggressive push for the full digitalization of the revenue agencies before the pandemic, the government did not fail to collect revenues even when people could not go out of their homes to file their income tax returns and pay their tax dues.

A proof of this effort is that the total number of annual income tax returns (ITRs) filed electronically soared to 90 percent in 2020 and to almost 100 percent last April, from just 10 percent in 2015, Dominguez said.

The government achieved a two-decade high revenue effort at 16.1 percent of gross domestic product (GDP) in 2019 compared to only 15.1 percent in 2015. Dominguez said this 2019 feat helped bring down the debt-to-GDP ratio for that year to a historic low of 39.6 percent from 42.7 percent in 2015;

· The Philippines did not lose its high credit rating of 'BBB+' earned from S&P Global in 2019 up to this day because of the country's solid fundamentals even amid the pandemic;

The government never ran out of cash resources and has managed to meet the huge spending on its COVID-19 response despite the expected weakened revenue collection resulting from the on-and-off strict lockdowns.

Dominguez said that as a result of the pandemic, the government's total loss in terms of revenues amounted to P1.4 trillion in 2020, of which about P709 billion was sourced through the financ-

ing that it was able to access expeditiously and on very good terms through domestic bond offerings, official development assistance (ODA) and the international capital markets;

The government did not suffer constrained fiscal space despite the recent increase in borrowings as the affordability of the national debt remains manageable.

Dominguez noted that debt interest payments as a share of revenues increased slightly from 11.5 percent in 2019 to 13.3 percent in 2020, which is still better compared with 14.7 percent in 2015.

Moreover, interest payments as a share of expenditures even improved to 9 percent last year from 13.9 percent in 2015, which indicates that the government's additional debt is being beneficial to the country's recovery and development agenda rather than being a burden to growth, he said;

The interest payment burden did not rise in proportion to the increase in the country's debt stock, given that the average interest rate of the debt portfolio was reduced from 5.2 percent in 2015 to 4.2 percent in 2020; and

• The Philippine peso did not plunge in value as it did in 1997 during the Asian financial crisis.

Dominguez said the sound and prudent reserve management of the Bangko Sentral ng Pilipinas (BSP), allowed the country to sustain a healthy level of foreign reserves that could actually cover its total external debt.

"In the face of the many challenges that we confront today, compounded by the proliferation of fake news, our economic journalists have to deal with an even bigger responsibility," Dominguez said.

"We rely on you to provide perspective on the daily grind of reporting events. By underscoring facts and giving accurate pictures, you will help reassure our people. You will arm your audience with the means to deal with the test and trials that we face," he said.

Dominguez said that even while battling the pandemic, the government did not let up on the completion of its reform agenda.

To further strengthen the banking system, the economic team quickly pushed the passage in the Congress of the Financial Institutions Strategic Transfer Act (FIST) Law, which now allows banks to efficiently offload their bad loans and non-performing assets (NPAs). While it is similar to the Special Purpose Vehicles (SPV) law of 2003, he said the FIST Act is also different as it was implemented within the first year of the pandemic, unlike the former which was passed belatedly and took five years after the 1997 Asian Financial Crisis to be en-

Dominguez said the Duterte administration also lobbied the congressional approval of its tax reform proposals even amid a pandemic, as evidenced by the historic passage of the Corporate Recovery and Tax Incentives for Enterprises (CREATE) Act, which, with its hefty reduction in the corporate income tax (CIT) rates, has become the largest ever fiscal stimulus program for businesses in the country.

CREATE also opens the way for the government to rationalize the tax incentives system to ensure that fiscal and non-fiscal incentives are tightly targeted, performance-based, transparent, and time-bound, he said.


Alongside these reforms, Dominguez said infrastructure investments under President Duterte's signature program "Build, Build, Build" will proceed at full speed to drive up economic activity and create jobs.

Dominguez said infrastructure spending, which dramatically rose to an average of 5 percent of GDP from just around 2 percent during the previous four administrations, would not have been accelerated without "Build, Build, Build."

He said the Duterte administration is determined to maintain financial prudence and fiscal strength so the country can face the future with a deep war chest, knowing fully well that "living and dealing with COVID-19 is a multi-mile marathon, not a 100-yard sprint."

"The Duterte administration will not let up on its zero-to-ten point socioeconomic agenda. The completion of the reforms under this program will ensure that our economic recovery will be sustainable, inclusive and resilient," Dominguez said. (PR)

As Concepcion stated "We have been meeting with OCTA Research and Dr. Edsel Salvana who is one of the advisers of DOH to align with our strategies and proposals by giving vaccinated people more mobility and access. In domestic travel, no PCR required if fully vaccinated; for seniors, which was approved, no restrictions on movement; and for restaurants, additional capacity to be given to them, assuming 20 percent or above, but only for the fully vaccinated, this can be applied to other sectors as well. Areas of high-risk category like arenas, movie theaters, bars, and the like, either segregation where vaccinated can stay indoors and those unvaccinated outdoors. The U.S. is applying this now and some are not accepting those unvaccinated. These are some examples of what the private sector will propose."

Concepcion said the time was right to put in place new policies as the Philippines is getting closer to achieving the minimum requirement of population protection where 40-50 percent of Filipinos are vaccinated, particularly in the National Capital Region plus eight provinces that together account for more than 60 percent of the country's Gross Domestic Product.

"We have to give the vaccinated population greater mobility as soon as we achieve the minimum of population protection. Doing so will go a long way in reviving some of our battered sectors such as the tourism and hospitality sectors and the food and beverage industry," said Concepcion.

Finance Secretary Carlos Dominguez III, who also heads the Duterte administration's eco-



team, has expressed support for these policy proposals which will contribute to the rebound of the country's economy.

"These proposals are also a form of incentive to get even more Filipinos vaccinated so that we can reach our higher target of herd immunity, where 70-80 percent of Filipinos are vaccinated,"

Concepcion added, "Greater mobility is one reward for getting to at least our minimum target of population protection."

He stressed that the 40-50 percent population protection was backed by data, guided particularly by the experience in Israel where COVID-19 cases had started to drop dramatically once the vaccination level hit the 40-50 percent mark. And the cases remained low even as it opened up more of its economy.

Concepcion is also in favor of allowing the entry of tourists from countries where at least half of the population had been vaccinated against COVID-19 and also to those who have been fully

vaccinated, provided that they take an RT-PCR test upon arrival. No need anymore for the seven-day quarantine, which has deterred many potential tourists from coming over to the Philippines.

"These suggestions are proactive measures as we reach population protection and eventually, herd immunity. In reaching these critical points, a game plan with policies that have been

thoroughly discussed and debated shall be ready," he said, "Let us not wait for the time that we would only discuss measures for our economic revival upon hitting population protection. The

time to start talking about it is now."

"These are all still part of our overarching goal to reopen our economy safely and to keep it that way," said Concepcion, "We must proceed carefully and seek to find solutions that are acceptable and fair."


He expressed optimism that the Philippines will achieve the crucial milestone of population protection by the fourth quarter, raising hopes that the Christmas season this year will be much more festive than last year, thus putting the country on the path beyond the pandemic.

Not to say, however, that the health and safety protocols can be done away with, stressing that the virus will still be very much around, thus requiring continued vigilance and adherence to the most basic of safety protocols to prevent a return of a COVID-19 case surge.

However, at the level of population protection, Concepcion said the country can already confidently open up more sectors of the economy and perk up activity to shore up the

Philippines' GDP and rescue companies, particularly micro small and medium scale enterprises.

"Population protection is a way-point, a phase, on our way to herd immunity when we can already optimize the reopening of our economy. When we apply this, we can be more efficient in approaching this pandemic, safely ease into economic recovery, and have a better chance of winning through it," Concepcion said. (PR)

CARD e-Doctor marks Year One;served more than 30,000 individuals through online

CARD Mutually Reinforcing Institutions (CARD MRI) through its Microfinance and Health Protection (MaHP) unit launched CARD e-Doctor in April 2020 to continuously provide online medical access to clients during the COVID-19 pandemic.

Said MaHP Director Dr. Roderick Belen, "We started this online platform because we saw an opportunity to continuously reach CARD MRI clients and their families amidst the pandemic. We realized at the onset of community quarantines and lockdowns last year that access to medical support will be gravely needed as we face this health crisis."

After a year of conducting online consultations, the program recorded a total of 34,756 consultations. Further, a total of 11 partner doctors were tapped, specializing in internal and general medicine, obstetrics and gynecology, pediatrics, dentistry, ophthalmology, and orthopedic surgery.

"When they invited me to this program, I never hesitated to join because helping other people is my purpose in life. Being part of this initiative made it easier for doctors like us to reach

clients in the country and address their medical concerns," said Internal Medicine Physician Dr. Remedios Maligaya.

Aside from the online consultation, CARD e-Doctor also became a venue for CARD MRI to inform and educate the general public about current health issues and concerns. "Before the pandemic, we regularly conducted simultaneous weekly community health days (CHD) nationwide to provide medical, optical and dental check-ups. The CHD also allowed us to host physical forums to discuss various health topics. We decided to transform these forums online to continue our advocacy of raising awareness on health and wellness," Dr. Belen shared. He recalled that when CARD e-Doctor held its first live consultation, the viewers reached more than 2,500 viewers nationwide. The first topic discussed in this Live is COVID-19, its symptoms, and preventive measures.



President Rodrigo Duterte announced earlier this week that NCR Plus would remain under general community quarantine (GCQ) with varying degrees of

"This extended liberal movement of people will allow the DOT and local government units to revive the jobs of displaced tourism workers," Puyat said.

Resolution 121 of the IATF allows interzonal travel between areas under GCQ and MGCQ for leisure purposes. However, tourists coming from Bulacan, Cavite, Laguna, and Rizal may only undertake point-topoint travel to GCQ and MGCQ areas. Cont. on Page 2
