#### Still going the distance

Classes have started in some schools and universities in the country, and more, including public basic education institutions, are expected to begin the school year in the next few weeks. Given the situation we find ourselves in right now, holding face-toface classes remains a distant dream.

When the pandemic began a year and a half ago, nobody had any idea that it would last this long. At that time, the abrupt shift to online education was seen as a stop-gap solution, perhaps to run for a few weeks, until the COVID threat disappeared.

But it did not disappear. It only got more menacing, more paralyzing—and closer to home.

Over the past year, both students and teachers learned that there was nothing easy about learning and teaching from home. Only a small percentage of families had the optimal tools like computers, tablets, mobile, and a reliable internet connection, or even space in the house conducive to learning. Basic education teachers went out of their way to bring printed modules to the homes of their students.

This radically different mode of education did not guarantee effective learning, especially since the remote set-up is happening as students, teachers, or their family members are getting sick of COVID-19 or dealing with the economic consequences of the protracted lockdown.

And now we are starting another school year under the same arrangements.

It would be ideal if we could apply the lessons on the methods that worked—and didn't during the past year. What is the best way to assess how engaged the students are? How can we be certain students fail to show up online or submit requirements because they are truly having difficulties, not manufacturing excuses? How can we ensure it's the children who actually do the exercises—not their parents or other family members?

The truth is, we are as stumped as we were the first time, especially since the virus' new variant is threatening even children who are supposed to have stronger immune systems.

As before, we will make do with what we know and what we have, hoping that our individual and collective learnings from this whole experience would tide us through.

#### National . . .

In step with President Duterte's goal of financial inclusion for all Filipinos, the number of unbanked national ID registrants onboarded by the Land Bank of the Philippines (LANDBANK) to the formal banking system has grown to 4.47 million as of end-June.

A report to Finance Secretary and LANDBANK Chairman Carlos Dominguez III shows that the state lending institution has so far onboarded 4,468,249 new accounts or 47 percent of the 9,484,696 individuals who had already registered in the Philippine Identification System (PhilSys) from 884 sites in 32 provinces.

As of June 30, 2021, 1,225,675 or 27 percent of the onboarded applicants have already received their LANDBANK Agent Banking Cards (ABCs).

LANDBANK records show that Philsys registrants who were issued cards are already using these for various transactions.

As of June 30, 2021, a total of 4,338 Philsys registrants made 8.099 transactions overthe-counter (thru LANDBANK branches), or through mobile banking apps, point of sale and online. Majority of the transactions were conducted in the Visayas as well as in Central Luzon.

These cards are provided free of charge and with no initial deposit requirement to PhilSys applicants in areas where the LAND-BANK has co-located with the Philippine Statistics Authority (PSA) in PhilSys registration sites across the country.

LANDBANK said facilitating the opening of bank accounts for PhilSys registrants will help ensure the speedy and efficient delivery of future government assistance programs to unbanked beneficiaries.

LANDBANK's ABCs can be used by Philsys ID holders to withdraw cash at ATMs and pointof-sale (POS) cash-out terminals, shop online and perform other cashless transactions, as well as receive any government subsidy digitally.

The card is also contact-

less-enabled, which means it can be used for "tap" payments, such as for the Automated Fare Collection System (AFCS) that the government plans to roll out for public utility vehicles (PUVs).

As for the bank's other digital transformation initiatives, LANDBANK reported that since November 2018 up to end-June 2021, a total of 1,671,470 accounts were opened through the bank's Digital Onboarding System (DOBS), which includes accounts opened for clients of the Overseas Filipino Bank (OFBank), a LANDBANK subsidiary that is the first digital-only bank in the country.

For the month of June 2021, accounts opened reached 68,863, higher than the 67,889 accounts opened in the previous

LANDBANK also said there was a sustained increase in the number of transactions using the LANDBANK Mobile Banking App from 31.97 million transactions last June 2020 to 47.03 million in June 2021. (PR)

#### 'Not at this time', on calls allowing only fully vaccinated in malls and restos

Calls limiting to only fully vaccinated individuals access to malls and restaurants in Metro Manila should be put off until there's enough supply of vaccines, Senator Win Gatchalian said.

"Sa ngayon mahirap gawin 'yan dahil hindi sapat ang supply ng vaccines natin. Marami na ang gustong magpabakuna pero ang problema naman ay kulang ang supply," he emphasized.

"Until such time na marami na ang bakuna at mayroon pa ring mga taong ayaw magpabakuna, siguro maaari na nating pag-isipan ang panukalang 'yan para maengganyo natin ang lahat na maging bakunado," added Gatchalian.

In Valenzuela City, for instance, the senator said the local government has a backlog of almost 300,000. While 52% of the target population already received the first dose, only 34% have been administered with the second dose.

"Hindi sa ayaw ng mga taong magpabakuna, walang bakuna na makuha at maraming local government units (LGUs) na humihingi pa ng bakuna. Marami akong kausap na mga LGUs sa probinsya na namomroblema sa supply ng bakuna. Kulang na kulang pa talaga," Gatchalian said

Insofar as the National Capital Region (NCR) is concerned, Metro Manila Development Authority (MMDA) chairperson Benhur Abalos said the vaccination drive against COVID-19 have inoculated 43.5% of the eligible recipients or a total of 4,262,546 residents have been fully vaccinated as of August 22, 2021.

Seventy-five percent of the whole eligible population of the NCR have already been administered their first dose of the vaccine and full vaccination of 50% of the eligible population can be achieved by the end of the month, according to Abalos.

Some business groups supported the idea of allowing only those fully vaccinated in restaurants, within mall premises, and other commercial establishments in the NCR to create safer bubbles that could control the spread of the more transmissible COVID-19 variants.

Gatchalian said he supports the idea if it's meant to encourage more people to get themselves vaccinated.

"Aminin na natin, mababa na ang vaccine hesitancy rate ngayon. So kahit na may mga naeengganyong magpabakuna na, kung wala naman silang paraan para mabakunahan, mawawalan ng saysay ang pagsisikap na ito. Hindi rin naman madadagdagan ang kita ng mga malls at restaurants kung konti pa lang ang mga bakunado," he said.

# Locally sourced LGU revenues rise 5% to P169-B in Q2

Local government units (LGUs) have increased their collections from locally sourced revenues (LSRs) by 5 percent to P168.96 billion in the second quarter of 2021, compared to P161.49 billion in the same period last year, but continue to rely heavily on their internal revenue allotment (IRA) share to fund their operations and programs.

In a report to Finance Secretary Carlos Dominguez III, the Bureau of Local Government Finance (BLGF) said the current operating income of provinces, cites and municipalities reached P460.86 billion in the April-June period, representing an increase of P1.74 billion or 0.4 percent from the P459.12 billion posted in the same quarter last year.

BLGF Executive Director Niño Raymond Alvina traced this slight increase in collections to the IRA, which grew P273.21 billion over the April-June period, higher by P19.58 billion or 8 percent from the P253.63 billion that LGUs received during the same period in 2020.

"On IRA dependence, provinces showed the highest dependency at 79 percent, followed by the municipalities (75 percent) and cities (38 percent) in the second quarter of 2021," Alvina said.

The contribution of the IRA to the current operating income of LGUs in the second quar-

ter rose to 59 percent, from 55 percent in 2020.

The LSRs accounted for 37 percent of the current operating income of LGUs, an improvement from its 35 percent share last year. T ax revenues, mostly from local business tax (LBT) and real property tax (RPT), contributed the biggest share of the LSRs in the second quarter at P135.07 billion, which is a 4-percent increase from the P129.65 billion collected in 2020, Alvina said.

The share of non-tax revenues, which amounted to P33.88 billion in the second quarter, increased by 6 percent from the P31.85 billion collected in 2020.

Other income sources of LGUs were transfers from the national government that include donations, grants and other shares in the tax collections, which amounted to P18.69 billion in the second quarter of 2021.

This was a sharp decline from the P43.99 billion that LGUs received during the same period last year when the one-time Bayanihan grant to LGUs was released under Republic Act (RA) No. 11469 or the Bayanihan 1 Law.

Alvina said cities collected the highest LSR at P120.31 billion, which is 72 percent of the total LSR of LGUs, followed by municipalities and provinces, with P31.16 billion (19 percent) and P15.14 billion (9 percent).

"Based on the performance targets set by this Bureau to local treasurers for FY (Fiscal Year) 2021, the LSR of provinces, cities and municipalities as of Q2 FY2021 already accounts for 74 percent of the full-year collection target of P223.89 billion," he said.

Alvina said LBT collections, which account for 47 percent of the LSR, already reached 80 percent of the full-year target, while the collection efficiency for the RPT was at 75 percent.

Collections from fees and charges, and receipts from economic enterprises respectively a respective collection efficiency of 74 percent and 47 percent, based on the 2021 targets.

As in the previous years, the National Capital Region (NCR) posted the highest LSR collections, which reached P72.34 billion or 43 percent of the total LSR of all LGUs, Alvina said. This was followed by Region IV-A or CALABARZON (Cavite-Laguna-Batangas-Rizal-Quezon) and Region III (Central Luzon), with a respective P26.14 billion (16 percent) and P15.54 billion (9 percent) in LSR collections.

"On a per LGU basis, there were 375 LGUs or 22 percent of the total number of LGUs that experienced decline in LSR as of Q2 FY2021, namely 29 provinces, 56 cities and 290 municipalities," Alvina said. (PR)

#### Six textile ...

The value of tax credits granted to a half-dozen textile companies from 2008 to 2014 that were invalidated by the Commission on Audit (COA) have now ballooned to P1.6 billion, according to a

Capital-Roll Knit Corp. (CRC), Uni-Glory's Knitting Corp. (UKC), Primeknit Manufacturing Corp. (PMC), Tai-Cheng Integrated Resource Inc. (TICIRI), Miskhu Industrial Corp. (MIC) and Universal Pacific Knitting Mills Inc. (UPKM) were among the textile firms found to have secured illegal tax credit certificates (TCCs) from the One-Stop Shop Inter-Agency Tax Credit and Duty Drawback Center (OSS) from 2008 to 2014.

As of the first quarter this year, the COA-Special Audits Office (COA-SAO) reported that it has issued Notices of Disallowance (NDs) to these six textile companies for having secured illegal TCCs amounting to P1.195 billion.

A new set of NDs involving P389.27 million was issued by the COA in the second quarter to these same textile firms, bringing the total of their disallowed TCCs to P1.58 billion, based on a June 22, 2021 letter sent by the audit body to Dominguez.

This latest set of NDs covered TCCs that were issued mostly between 2010 and 2014, according to the letter sent by COA-Director Gloria Silverio. CRC tops the list with the largest amount of illegal TCCs at P664.92 million.

The COA-SAO reported that on top of the earlier disallowed TCCs granted to CRC in the sum of P567.2 million, a new set of NDs was issued to the firm totaling another P97.72 million.

MIC, which was earlier found to have been issued illegal TCCs worth P80.11 million, was issued a new set of NDs totaling P56.87 million, which brings the total of its illegal tax credits to P136.98 million.

The illegal tax credits of UPKM, Inc. grew to

P127.81 million after the COA found a new set of spurious TCCs issued to the firm worth P46.2 million. This is on top of the firm's TCCs totaling P81.59 million that were earlier invalidated by COA.

UKC, with TCCs totaling P170.8 million that were earlier disallowed by COA, also received NDs for a separate set of TCCs amounting to P70.88 million, according to the latest audit done by the COA-SAO.

Its disallowed TCCs now amount to P241.68

PMC's disallowed TCCs of P154.27 million increased to P214.31 million after the COA-SAO determined a new set of TCCs worth P60.04 million was illegally issued to the company.

The COA-SAO also found that P57.54 million

The COA-SAO also found that P57.54 million in TCCs granted to TICIRI should also be disallowed, on top of the earlier NDs that the audit body issued against the firm worth P141.27 million combined.

The total value of TICIRI's disallowed TCCs is P198.81 million.

Several past officials and employees of the Department of Finance (DOF), Board of Investments (BOI), Bureau of Customs (BOC) and OSS who were responsible for processing and approving the illegal TCCs between 2008 and 2014, as well as the recipients and claimants from the six companies, were held liable by

Approved applications meant tax credits on the duties and taxes that exporters supposedly paid, and they could then use the amount to pay other tax liabilities due the government. The practice of these alleged exporters who illegally obtained TCCs was to sell the certificates to other companies at a discount. The latter would then use the TCCs to pay their own tax liabilities.

The COA found that the OSS issued TCCs to either ghost exporters or real companies that were not in the export trade or did not deserve the tax credits issued to them, such as these six textile companies. (PR)

## DPWH, MHI lead inauguration of CALAX Silang East Interchange

DPWH Secretary Mark Villar led the inauguration with several top government executives including, Senator Christopher 'Bong' Go, Department of Transportation (DOTr) Secretary Arthur P. Tugade, Executive Secretary Salvador Medialdea, Cavite Governor Jonvic Remulla, and Mayor Corazon Poblete of Silang, Cavite.

Officials of the MHI who were in attendance were Metro Pacific Investment Corporation President Jose Ma. Lim, Metro Pacific Tollways President and CEO Rodrigo E. Franco, MHI President and CEO Robert V. Bontia, and selected members of the

project team.

"We are grateful for the trust and continued partnership with the government of the Philippines in providing the much-needed mobility infrastructure in the form of CALAX to help boost tourism and economic activity in the CALABARZON Region," said MPT South President and General Manager Roberto V. The 7.2 kilometer Subsection 5 connects Sta. Rosa, Laguna to Tagaytay Interchange going to Silang East Interchange.

As a result, the Laguna Segment with 17 kilometers long is estimated to service additional 5,000 vehicles per day. This would also cut travel time from Laguna from 2 hours to under an hour.

"CALAX is included in the Luzon Spine Expressway Network -- a master plan aimed at increasing the high standard highway network by three-fold. We are now closer to our dream of connecting the northernmost part of Luzon to its southernmost portion. We are confident that we will be able to deliver majority of this high-impact project within the term of President Rodrigo Duterte," said DPWH Secretary Mark A. Villar.

Based on the last development of the right of way acquisition, the whole stretch of CALAX would be operational by early 2023 according to Bontia. (PIA)

CAVITE CITY: The political atmosphere in the province Cavite is beginning to heat up one month before the filing of certificates of candidacy on October 1 to 8.

Several would-be candidates make notice of their intention to run for office by publicly posting campaign materials, which can be viewed by passing motorists and people on the street.

Liga ng mga Barangays Federation President Apple Paredes, daughter of incumbent Mayor Bernardo Paredes, and incumbent Vice Mayor Denver Chua are expected to clash for the top executive post of Cavite City.

Dino Chua, meanwhile, is seeking his third and final term as mayor of Noveleta. He is expected to be challenged by former mayor Boy Alvarez.

Chua's brother, First District Board Member Davey Chua, is eyeing for the Congressional seat of the first Legislative District of Cavite. Incumbent Rep. Boy Blue Aguinaldo Abaya has already completed his three terms in congress and said he would want his brother Dr. Paul Aguinaldo Abaya, former vice mayor of Kawit, to inherit his position.

Boy Blue Abaya will instead run against his second degree cousin, incumbent Kawit Mayor Angelo Emilio Aguinaldo, who is seeking reelection in the cradle of Philippine Independence.

In Rosario, Cavite, incumbent Mayor Voltaire Ricafrente, who is also seeking reelection, will be challenged by Vice Mayor Mao Luna.

Rizal.


This was after the National Task Force Against COVID-19 led Monday's symbolic vaccination to mark the country's 30-million mark in total jabs administered last August 23, at SM San Mateo.

The new CoVax process requires the registration and follow-up will be done directly with the barangay, thru the barangay secretaries who will be responsible for the submission of the lists to the Office of the Mayor.

[Most COVID-19 related deaths are unvaccinated, while those who are in critical and severe cases are not much different. Meanwhile, most of the asymptomatic patients are fully vaccinated.]

Considering that some of the coun-

try's major cities are found in the NCR, Abalos said smaller cities--such as San Juan, Pateros and Mandaluyong-- tend to complete their vaccination programs faster than their larger and more populous neighbors. (PB)

Diaz's triumph at the Olympics is predicted to attract more interest in weightlifting as a sport, which prompted talks of its inclusion in the Department of Education-led Palarong Pambansa.

Soon, Diaz will be neighbors with other Filipino Olympians--boxers Nesthy Petecio, Eumir Marcial, and Carlo Paalam--who witnessed the groundbreaking for the construction of their own homes in nearby Barangay San Jose.
