

DTI-Laguna grants livelihood kits to LSP-NSB beneficiaries



6 presidential aspirants, 3 VP ho fuls submit COCs











We call on first-time registrants for the May 2022 national and local elections as well as those whose status have either been deactivated or just plain inactive to take advantage of the extended registration period.

The House of Representatives and the Senate this week unanimously approved a measure seeking to extend the voter registration deadline for another 30 days.

There is logic in extending the registration period from the original September 30 deadline to avoid widespread voter disenfranchisement, considering the extraordinary circumstances caused by the coronavirus pandemic which reined in the people's mobility for months from the time voters registration began.

We share the hope of national legislators that the Comelec will use the one-month extension to ramp up voter registration and ensure that more people can vote next year and give more space to thousands whose reqistration was delayed because of the public health emergency.

Enough time

The Comelec has exceeded by 1 million its target new registrants of 4.3 million for the whole registration period, surpassing its target number of new voter registrants for the May 9, 2022 national and local elections.

At the same time, Comelec is looking to have at least 60 million registered voters for the 2022 national polls. The health crisis has been prolonged beyond the eye range of the authorities and many prospective voters, chiefly the first registrants and those who want to activate their inactive status or want to apply for change in voting precincts because of lockdowns, must not be disenfranchised.

This is why we encourage registrants to take advantage of the extension and go to the nearest Comelec registration areas in their barangays or towns to avail themselves of this political right conferred on them by the Con-

This right is intended to enable them to participate in the process of government to assure the elected leaders their powers are derived from the consent of the governed.

TRECE MAR-**TIRES** CITY. Cavite: Incumbent Cavite Gov. Juanito Victor "Jonvic" Remulla Jr. was the first to file for certificate of candidacy (CoC) on Friday at the Provincial Comelec Office in Barangay San Agustin, Trece Martires City.

Remulla, who is running under the National Unity Party (NUP) and local Partido Magdalo, was joined by his running mate and vice gubernatorial aspirant, Tagaytay Councilor Athena Tolentino.

Remulla vowed to continue his legacy program for Caviteños on his next term if reelected as provincial chief executive. He vowed to strengthen the internet connectivity for the entire province, maintain peace and order, and enhance the educa-

tional programs for the

youth. Remulla's programs for the province include the continuing infrastructure rehabilitation and the need to start the coastal road extension from Kawit to Tanza, to ease the traffic along Aguinaldo Highway. He aims to finish the Cavite-Laguna Expressway from Silang to Kawit and its extension project, targeted to be completed in two

years.

"Cavite is the biggest province in the whole country, we have a 4.5 million population based on the 2020 census. To further improve Cavite now, we need more vaccines to reach herd immunity in the province. As of now. we received 1.5 million vaccines but our infection rates are high. I have spoken with Secretary Vince Dizon. He responded by supplying more vaccines to Cavite," Remulla said in an interview.

"As of now, Cavite is already 38 percent fully vaccinated, 28 percent received their first dose. By October 15, Cavite will start vaccinating 12 to 17 years old, who have comorbidities. Hopefully, by February 2022, we can go back to face-to-face classes," Remulla added.

Other local bets who filed their CoCs on Friday were Tagaytay Mayor Agnes Tolentino for representative of the Eighth District, reelectionist Rep. Jesus Crispin "Boying" Remulla of the Seventh District, Board Member Reinier Ambion

Mendez Nuñez mayoral aspirant Francisco Mendoza Jr. of NUP and vice mayoral bet Joselito Baban also filed their CoCs on Friday as well as Ruby Lita Bay-Remigio, Roilan Ortiz, Alex Ocampo, Ediber Peñalba, Paulino Dimaranan,

Marvin Vidamo, Romulo Martinez and Renato Dimapilis who are all running for councilor.

In Tanza, reelectionist Mayor Yuri Pacumio and vice mavoral candidate Simon Matro and eight councilors filed their CoCs at the local elections office in Barangay Daang Amaya.

Alfonso Mayor Randy Salamat, meanwhile, is formally seeking a second term and Indang Mayor Perfecto Fidel is running for this third term. (TMTIMES)

Mobile Number Portability begins Sept. 30; ensure privacy of subscribers' data

Safeguard personal information of mobile subscribers, ensure cybersecurity policies in place, and provide proper consumer welfare mechanisms in the course of porting activities, Senator Win Gatchalian said in reminding telecommunications companies as they roll out the implementation of the Mobile Number Portability Act (MNPA) on September 30.

Gatchalian called on the National Telecommunications Commission (NTC) and the National Privacy Commission (NPC) to oversee the proper implementation of the law which allows subscribers to switch between telecommunications service providers without having to change their mobile numbers;

The senator urged the concerned agencies to ensure the promotion of subscribers' welfare and protect them against public exposure of mobile numbers;

The unauthorized disclosure of personal information, such as an individual's name and phone number, is punishable under the Data Privacy Act.

Gatchalian likewise called on the National Telecommunications Commission (NTC) and the National Privacy Commission (NPC) to oversee the proper implementation of the law which allows subscribers to switch between telecommunications service providers without having to change their mobile numbers and pay for interconnection fees for calling or texting across different networks.

The senator also urged these concerned agencies to ensure the promotion of subscribers' welfare and protect them against public exposure of mobile numbers.


Gatchalian cited the controversy now surrounding the popular Netflix's Korean series Squid Game where a supposed fictitious phone number used in the show turned out to be a real mobile number and the owner who has been using it for more than 10 years received a barrage of prank calls and texts from curious fans.

In one of its episodes, a business card with a phone number is given to a potential contestant to be able to be invited to a mysterious survival competition with a cash prize worth ₩45.6 billion.

The unauthorized disclosure of personal information, such as an individual's name and phone number, is punishable under the Data Privacy Act as Gatchalian warned the public against posting online phone numbers without the consent of the owner.

MANILA – Twenty-three aspirants for national positions filed their Certificates of Candidacy (COCs) while 18 party-list groups submitted their Certificates of Nomination and Acceptance (CONAs) during the first day of the filing period on Friday.

Commission on Elections (Comelec) spokesperson James Jimenez said the low turnout may not be related to the coronavirus disease 2019 (Covid-19) pandemic. "We don't think the pandemic is actually an issue

Finance Secretary Carlos Dominguez III has ordered the preparation and dissemination of a report highlighting the key findings of independent experts tasked by the Mining Industry Coordinating Council (MICC) to conduct a comprehensive review of largescale metallic mines across the country.

Underscoring the MICC's transparency in ordering the mining audit, Dominguez said the report should be reader-friendly and be made available not only to government officials, but also to the public.

The report would show that the MICC has done its job as mandated under Executive Order (EO) No. 79 and has made mining companies accountable for their lapses and inefficiencies, Dominguez said

Dominguez, who co-chairs the MICC with Environment and Natural Resources Secretary Roy Cimatu, said the report should be completed and released by the second quarter of next year.

He said the report should cover not only the two-phase audit recently completed by the experts, but also the upcoming review of mines in the Bangsam-

oro Autonomous Region in Muslim Mindanao (BARMM) that is set to begin this October.

"May I suggest that as this administration is ending its term in eight and a half months, that the MICC secretariat prepare a report of all the activities of the MICC, particularly in these reviews that were done," Dominguez said during the 41st meeting of the MICC held via Zoom on September 17, 2021.

Dominguez said releasing the report would enhance the public's trust and confidence in government, and demonstrate the capability of Filipino experts in conducting mining audits

He thanked the teams of independent experts, represented during the meeting by Dr. Gem Castillo, for its "very comprehensive report" and "for helping the MICC fulfill its mandate."

"This is the only administration that has actually done a serious review of the mining operations as mandated by the Executive Order (EO). So thank you for making this very comprehensive report," Dominguez told Castillo, in reference to EO 79

With the third audit focused on the BARMM mines sched-

uled to be completed by April next year, Dominguez said he expects the report on all the reviews to be done by May 2022.

"The report should be in such a form that can be used by the ordinary reader and the public, and that it be made widely available, not only to government officials, the legislature, maybe even in the judiciary, but also to the public in general," Dominguez said.

Dominguez said the publication and release of the report on large-scale mines will encourage the provincial/city mining regulatory boards, which are under the direct supervision of the Department of Environment and Natural Resources (DENR), to undertake similar audits on small-scale mining operations under their respective jurisdictions

Working from 2018 to 2020, the teams of experts conducted their audits in two phases and focused on the economic, sociocultural, technical, environmental and legal aspects of mining operations to ensure the "comprehensiveness and objectiveness of the review process."

The review, which covered 44 large-scale metallic mines across the country, revealed that the majority of

the mines passed the legal and technical aspects of the audit, but required major reforms in the environmental, social and economic aspects of their operations.

Mines and Geosciences Bureau (MGB) Director Wilfredo Moncano pointed out during the meeting that after the first phase of the MICC audit revealed that many metallic mines required major reforms, the DENR issued several administrative orders to address the deficiencies of the mining operations uncovered by the experts.

After the series of DENR directives, Moncano said most of the mines showed "marked improvements" in the conduct of their operations.

The review of mining operations is mandated by EO 79 issued in 2012, but it was only during the Duterte administration that the MICC undertook this task to ensure the compliance of mining companies with existing environmental standards, laws, rules and regulations, and to rationalize the management and utilization of minerals toward sustainable development.

A total of 29 experts forming technical review teams (TRTs) were involved in the first and second phases of the review ordered by the MICC. (PR)

here because this is exactly the pattern we see every time we have the filing. The first day really doesn't see a lot of filers," he said in an interview.

"But for the most part, candidates tend to cluster at the end of the period and this is especially true now that the end of the period is October 7 and 8, both of which are numbers that look fairly auspicious. We feel that is really a bigger factor than Covid," he added.

The others are Laurencio Yulaga, who claimed to be a Harvard University graduate; Leysander Ordenas, allegedly a former military officer, teacher, and migrant worker; Dave Aguila; Dr. Jose Montemayor; and Edmundo Rubi.

Three vice presidential hopefuls, led by former Manila mayor, Buhay party-list Representative and Pacquiao runningmate Lito Atienza, also filed their COCs. The two others are Yulaga's runningmate, Alex Lague, and Rochelle David.

S enator Risa Hontiveros will seek another term and filed her COC with 13 others, including two former senators, Antique Representative Loren Legarda and Sorsogon Governor Francis Escudero, who filed his documents through his lawver.

A total of 18 party-list organizations similarly filed their list of nominees and CONAs -- ACT-CIS, AGAP, Kabayan, An-Waray, DIWA, Pilipinas Para sa Pinoy, Alona, TODA, Cancer, People's Volunteer Against illegal Drugs, 1-Pacman, Marino, Ako Tanod, Ang Probinsyano, PBA, COOP-NATCCO, WACCAA, and 1-Rider. 

The renovation of what used to be the headquarters of the Land Bank of the Philippines (LAND-BANK) in Makati is part of the infrastructure works being undertaken by the Department of Public Works and Highways (DPWH) which started in 2019, Finance Secretary Carlos G. Dominguez said in a statement.

"The structure, located along Sen Gil J. Puyat Avenue will be transformed into a "green" building to house the organic personnel of the Office of the President (OP). Building works started almost two years ago, before the COVID-19 pandemic hit not only the Philippines," said the DOF chief.

Dominguez, who is also LANDBANK Chairman, pointed out that official documents show that the renovation project in the building has nothing to do with the institution of LANDBANK and its functions.

"The project was already included in the budget of the DPWH under the 2019 General Appropriations Act (GAA); this means that it was planned in 2018 or earlier," he

LANDBANK moved to its present main office at the LAND-BANK Plaza in Malate, Manila 20 years ago after it transferred the ownership of its previous headquarters in Makati City to the National Government in 2011.

Dominguez issued the statement to disprove claims made by former Bayan Muna Rep. Neri Colmenares during a recent House committee meeting that the renovation project on the former LAND-BANK building that was included by the DOF in the proposed 2022 national budget was a "deplorable misuse of public funds" amid a pandemic-induced crisis.

"Mr. Colmenares is, as usual, totally wrong. The budget for the project was requested by Malacañang long before the pandemic, and has nothing to do with LAND-BANK," Dominguez said.

Documents show that the OP and the DPWH have been in communication regarding the LANDBANK "structural retrofitting" project on the former LANDBANK building since October 2019 as this was already included in the DPWH budget for that fiscal year under its "Regular Agency Fund, Continuing Appropriations, Republic Act 11260, FY 2019 General Appropriations Act, Contingent Fund.

The Special Allotment Release Order (SARO) for the project was released by the Department of Budget and Management (DBM) in July 2020. (PR)



California 1st US state with Covid-19 vax mandate for schools

LOS ANGELES California became the first state in the United States to announce plans to require student vaccination for the coronavirus disease 2019 (Covid-19) by adding the vaccine to the list of vaccinations required for schools, such as the vaccines for measles, mumps, and rubella.

According to an order approved by Governor Gavin Newsom on Friday, students in the Golden State would be required to be vaccinated for in-person learning after those vaccines against Covid-19 get full approval from the Food and Drug Administration (FDA) for students.

Newsom's latest order, the first of its kind nationwide, will roll out in two phases, with the first taking effect for students aged 12 years and over following full approval by the FDA for that entire age group.

The FDA approved the

vaccine for children aged 16 years and over in Au-

Newsom California would apply the mandate for students aged 12 years and up as early as January 1 next year but possibly as late as July 1, depending on when the FDA authorization takes place and then would apply the mandate for students under 12 years of age in a second phase after the FDA gives the green light.

"The state already requires that students are vaccinated against viruses that cause mumps, measles, mumps, and rubella – there's no reason why we wouldn't do the same for Covid-19. Today's measure, just like our first-in-the-nation school masking and staff vaccination requirements, is about protecting our children and school staff. and keeping them in the classroom," a statement released by Newsom's of-

FINANCIAL INCLUSION AND SHARI'AH FINANCING

President Rodrigo Duterte delivered his last State of the Nation Address last week, but economists say poverty and unemployment will remain high even after his term ends. The National Economic and Development Authority (NEDA) projected the country's poverty rate to average between 15.5% and 17.5% this year, partly due to the coronavirus pandemic's adverse effects on the economy. NEDA also noted that joblessness will remain elevated at around 7% to 9% by 2022.

These projections highlight the need for financial inclusion – that state wherein everyone, especially the poor and vulnerable, have effective access to financial services that could help improve lives. Millions of Filipino families are poor, while economic and social inequality remains a challenge. This is especially true in the case of Muslim Filipinos, who comprise 10% of our population. The three poorest provinces in the country are predominantly Muslim.

We must strive to enable our Muslim brothers and sisters to lift themselves from the quagmire of poverty. One way of doing this is by giving them access to financial services that are in accord with their laws and traditions.

Most Impoverished

The poorest regions, based on PSA's 2018 Family Income and Expenditure Survey (FIES), are ARMM, Region 9, Region 8, CARAGA, and Region 12. Four of these regions are in Mindanao, but the most impoverished is the Bangsamoro Autonomous Region, which has a whopping 61.3% poverty incidence. This means that 3 out of every 5 persons in the region are poor. The situation is even worse in the provinces of Lanao del Sur, Sulu, and Basilan, where nearly 2 out of every 3 people are poor.

The situation is aggravated by the fact that many Muslim Filipinos do not have access to financial services which could help raise their productivity and standard of living. Islam prohibits interest charging, as this equates with usury (riba); forbids speculative transactions involving risks (gharar); and avoids transactions on sinful things (haram), such as pork, alcohol and gambling. With these tenets, Muslims' participation in the formal financial system remains low.

Shari'ah-Compliant Financing

Sharīʿah (also spelled sharia) is the Islamic religious law that governs the day-to-day life of all Muslims. As it covers all aspects of life, a truly inclusive financial system necessitates Sharia-compliant financial services for Muslim Filipinos.

In recent years, there has been much interest in Islamic financing in the Philippines. Conferences on the topic, initially led by civil society organizations, were held as early as 2015, followed up by forums sponsored by international financial institutions and government agencies. In 2018, the Bangsamoro Organic Law mandated the development of an Islamic banking and finance system in the country. This was strengthened by the passage of RA No. 11439 in 2019, which allowed the operation of domestic and foreign Islamic banking players, to facilitate the development of Islamic finance in the country.

Despite these laws, however, there remains only one Islamic bank in the country, the Al-Amanah Islamic Investment Bank. There are reports that foreign Islamic banks – including Qatar Bank and Malaysian institutions CIMB Islamic and City Credit Investment Bank — had expressed an interest in setting up operations here, but these are yet to come to fruition. In the meantime, a few microfinance institutions, such as the Peace and Equity Foundation, the ASA Philippines Foundation,

and the Center for Agriculture and Rural Development (CARD) are filling in the gap, making financial services such as banking, credit, microinsurance, remittance, and other services available to Muslim communities. The Paglambo Project

The Paglambo Project is a Sharia-inspired microfinancing program that CARD started in 2018. It was the product of a series of dialogues and learning visits between two Ramon Magsaysay awardees: the Dompet Dhuafa, an Indonesian non-profit organization, which won the Magsaysay Award in 2016, and CARD, which won the Magsaysay Award for Public Service in 2008. The Dompet Dhuafa ran a very successful Islamic microfinance and banking scheme, which inspired CARD to develop a similar Sharia-compliant program for Muslims in areas where they operate.

Initially, Paglambo only had two units in Marawi, Lanao del Sur and Shariff Aguak, Maguindanao. However, the program expanded quickly, proving the need for microfinance to serve Muslim communities. The project grew from only 56 Muslim families as members to 4,182 after only a year of operation. Following a visit by project staff to Dompet Dhuafa's offices in Indonesia, the project introduced an education loan program which uses the Murabahah concept of the Islamic financial system. The Murabahah concept allows the borrower to obtain money from the lender to buy goods for his or her business. The parties agree on the markup on the goods, thus, the lender gets a fixed profit based on the agreement, and eliminates the interest system which Islam prohibits. Since many Muslim families needed help to support their children's schooling, a Kafalah Islamic contract was added to the existing Sharia financing contract. This is just one of many ways by which CARD redesigned its financial products to respond to the needs of the community.

To date, the Paglambo Project has 35 units in Lanao del Sur, Maguindanao, Zamboanga City, Basilan and Tawi-tawi. Its client-members number 43,000, with a capital build-up of PhP76.5M. The average loan repayment rate is very high, at 96.54%. Notably, its unit in Kapatagan, Maguindanao had a 100% repayment rate despite the COVID pandemic.

Among the contributory factors are cultural sensitivity and respect for the community. CARD's staff made courtesy calls to Muslim elders to introduce the program. They also coordinated with village leaders and like-minded organizations in the area. Communication was key, as attested by the manager in Kapatagan, whose unit members grew because she was able to explain that the financial products under Paglambo is

halal or in accord with Islamic faith. When the pandemic hit the region, they had initial setbacks, but she created a viber group to keep communication lines open. This spelled the difference, as daily interaction in the group made the members feel a sense of unity and encouragement, which supported them through the challenges of the pandemic. She said that this was the key to their 100% loan repayment rate.

Call to Action

Islamic microfinance can deepen financial inclusion. Not only because it delivers Sharia-compliant products for Muslim communities, but also because it is specifically created to support the needs of the poor and underserved. The need for public and private financial institutions to offer Islamic banking and financing service is urgent, especially amid the pandemic that is wreaking havoc on the lives of the poorest and most vulnerable. Islamic financing can help micro, small and medium enterprises offering Halal products and services. With more providers, we can help our Muslim kababayans thrive even during this pandemic.
