SEC speeds up digitalization programs to improve ease of doing business

EDITORYAL:

Unwarranted panic

The global community is panicking in a knee-jerk reaction to the emergence of Omicron, the latest variant of the COVID-19 virus. The US and other developed nations this early are sounding the alarm while global financial markets are gyrating on fears that the spread of Omicron will derail the pace of the world economic recovery.

The first sector to suffer the brunt of this unwarranted agitation is the travel industry as nations attempt to close their borders from the sources of the mutation. More countries are rushing to impose travel curbs, with Japan quickly suspending all new flight bookings into the country.

But as the World Health Organization cautioned, blanket travel bans will not prevent the spread or entry of Omicron. The action may, in turn, discourage countries from sharing data about the evolving virus.

Travel restrictions will contain the spread of Omicron. In reality, however, they may be too late. Dutch health authorities discovered that Omicron had been present in their country even before South Africa reported its first cases on November

There is also talk in the medical profession that the new virus strain may be resistant against present vaccines. Again, such chatter has no bases yet. Scientists agree that clinical trials on the efficacy of current vaccines against Omicron will take weeks before any conclusive findings can

The Philippines for its part can limit the contagion through the tried-and-tested health protocols of wearing face masks, and of social distancing and hygiene. The country so far has managed to bring down the daily COVID-19 cases to below 600 in the past four days, following strict lockdown measures and an accelerated vaccination program, from a peak of over 26,000 in mid-September.

The real score on Omicron will surface soon after global scientists reveal their findings. But like the Delta strain, Omicron can be hopefully contained through vaccines or increased immunity. Reacting to a little-known virus variant with panic will do more harm than good.

The National Operations Vaccination Center (NVOC) reported at least 7,628,432 million Filipinos inoculated in the three-day National Vaccination Drive.

"For the three days, hindi pa kumpleto ang mga report. But we are very happy with the initial report kasi this is more than two times of the daily vaccination rate," NVOC Chairperson Myrna Cabotaie said in Laging Handa Public Briefing on Thursday, Dec. 2.

The NVOC chief stated that the breakdown of the total recorded vaccination for the first two days is 2,713,731 for Nov. 29 and 2.466.728 for Nov.

Meanwhile, the initial data gathered on the last day of vaccination drive is 2,447,973 doses administered as of 6 A.M.

Cabotaie said that the total first doses administered in the country reached around 55,415,753 individuals.

The NVOC cited that the three performing regions for this national vaccination drive were Region 4A, Region 3, and Region 7.

In a report to Finance Secretary Carlos Dominguez III, SEC chairman Emilio Aquino said among the commission's latest digital transformation initiatives are the Electronic Simplified Processing of Application for Registration of Company (eSPARC) that was launched last April and that has so far processed 26,875 applications of business registration on-

transaction fees online.

Such online applications are completed in just one day and as fast as less than 2 minutes under eSPARC, Aquino said.

Aquino said the fastest time recorded for processing an eSPARC corporations.

Aguino said eS-PARC currently caters to the registration of domestic stock corporations with a minimum of one incorporator and a maximum of 15 incorporators, board of directors and stockholders. The One-day Submission and E-registration of Companies (OneSEC) is a subsystem of eSPARC.

Since most of the company information are pre-filed under OneSEC, the application of companies applying for registrations require minimal encoding of data online.

"The OneSEC processing system is completely seamless. It's fully automated in the absence of human intervention on the part of the Commission—starting from the name verification of the proposed corporate name until the issuance of the Digital Certificate of Incorporation," Aquino said in his report during a recent executive committee (Execom) meeting called by Dominguez for other DOF-attached agencies.

Aquino said the Commission also launched last March 1 its Electronic System for Payments to SEC (eS-PAYSEC) to facilitate the payment of registration charges, penalties and other transaction fees with the SEC online using debit and credit cards, digital wallets and other cashless payment options.

The SFC also launched on March 15 the Electronic Filing and Submission System (eFAST) that allows companies to submit the Audited Financial Statement (AFS), General Information Sheet (GIS), Sworn Statement for Foundations (SSF). General Form for Financial Statements (GFFS). Special Form for Financial Statement (SFFS) and other reportorial require-

Aquino said the SEC has implemented its Company Investments and Financial Statistical System (CIFFS), which functions as the Commission's central database and processing software for all the data that it receives from all the corporations it monitors.

The SEC is also set to launch more digitalization programs, including the External Auditors and Auditing Firms Accreditation Registry System (EAAFARS), Integrated Compliance Monitoring, Evaluation and Enforcement System (ICMEES), Stress Testing for Capital Market Intermediaries. e-Media Hub, and Complaints Management Sys-

Aquino said the SEC will also employ digital technology for its Human Resource Management Information System (HRMIS), Online Strategic Performance Management System (SPMS), Integrated Learning Resource Management System (ILRMS), Asset Management Information System (AMIS), Procurement Monitoring and Tracking System (PMTS), Financial Management Information System (FMIS) and its Records Management Information System (RMIS).

The SEC is seeking a budget of P2.6 billion over a five year-period from 2021 to 2025 to fully implement these digitalization initiatives, Aquino said.

He said the SEC has also launched several new units, such as its PhilFintech Innovation Office in 2019 to ensure that the Commission keeps up with the fast-changing financial landscape in the country, supports financial technology innovations, and strengthens its protection of investors and consumers from scams and unfair financial practices.

It has also set up its International Affairs Office to facilitate cross-border regulation and the adoption of international best practices.

Aguino said the SEC will also establish the Office for the Advancement of Strategic Investments in SMEs (OASIS) to support the interests of small and medium enterprises (SMEs) and encourage them to undertake initial public offerings (IPOs).

The SEC will create additional also units to protect its systems from cyber attacks and data leaks, he said.

These include a Compliance Examination and Audit Unit, Cybersecurity and Risk Mitigation Unit, Cybercrime and Forensics Division, and a Corporate Communications and Investor Education Division. PR

Gatchalian seeks earmarking P10-M TESDA budget to address jobs-skills mismatch

Senator Win Gatchalian has proposed a P10-million allocation under the budget of the Technical Education and Skills Development Authority (TESDA) for the development of a skills demand forecasting model or strategy.

In a statement on Saturday, Nov. 20, he said the move was to help address jobs-skills mismatch Technical-Vocaamong tional Education and Training (TVET) graduates, Gatchalian stated that the proposed P10-million allocation, which was carried in the Senate's committee report on the 2022 national budget, is appropriated under TESDA's Promotion, Development, Implementation, Monitoring, and Evaluation of Technical Education and Skills Development Scholarships and Student Assistance **Programs**

Using TESDA's Individual Graduate Tracer Surveys for the years 2013, 2014 and 2017, the Asian Development Bank (ADB) estimates that mismatch rates among TVET graduates hover between 60 percent to 80 percent. For the year 2017 alone, 70 percent of the respondents were employed in jobs which were not the occupational expectations of their respective TVET

programs

"I would like to request from TESDA a strategy to address the jobs-training mismatch. This is a cause for concern because we are allocating P14 billion pesos for training but if those being trained will not end up getting a job that they are trained for, then that's a big problem," said Gatchalian during his interpellation on TES-DA's 2022 budget.

"We proposed earmarking P10 million to develop a skills demand forecasting model and this is to address the mismatch. I would like to request TESDA to take a look at this P10 million and see how to operationalize this," he added.

Gatchalian urged TESDA to increase enrollment enterprise-based TVET programs, which accounted for only four percent of total enrollment from 2014-2020. Enterprise-based TVET programs, which are conducted within companies, offer an edge because they align with Industry 4.0, as well as rapidly evolving workplace and workshop needs, said the ADB

No Omicron case yet in PH: DOH

MANILA – A health official on Friday said there are still no Omicron variant cases in the country.

During an online media forum, Health Undersecretary Maria Rosario Vergeire reported the government is performing intensive backtracing and re-testing of the individuals who arrived in the country from three African countries.

"We are doing our biosurveillance regularly and we're also doing backtracing, nagre-retrospective sampling din tayo (we're also doing retrospective sampling," she said.

For the period of Nov. 15 to 29, a total of 254 travelers came from South Africa.

Of the 254 individuals, only one tested positive for Covid-19 while 83 tested negative for the disease. Some 134 individuals still have pending test results while 35 persons did not require a swab test upon arrival.

Moreover, 183 individuals are still being contacted by the Bureau of Quarantine and the Department of the Interior and Local Government while the remaining 71 have been contacted and verified. Three of the 71 contacted and

Former House Speaker Alan Peter Cayetano on Monday said serving those in need can bring about positive change in the country in ways that political mudslinging can never do, especially as the 2022 national election approaches.

"Helping, being an example, showing people that you are Christ-like, is more important," Cayetano said in a Facebook livestream before the start of the Sampung Libong Pagasa program on November 29, 2021.

He said service and leadership are more important at this time when the country is beginning to emerge from the adverse effects of the pandemic.

This is the reason Cayetano and his allies in Congress are continuing the Sampung Libong Pag-asa program as it gives families a chance not just to survive the pandemic but to recover from it.

The 10K Ayuda Bill was filed in February and was consolidated into Bayanihan 3, but the provision of P10,000 for every family was not adopted.

When she received her cash assistance, she used P3,000 to start her own turon business.

(I sold bananacue, turon, and kamotecue. The income is good.)

With her small business, she is able to contribute to the family's budget for daily food and other necessities for the children.

"Nung time na natanggap ko yung ayuda ni Congressman Alan Cayetano, namuhunan ako kada araw ng P1,000. Kumikita iyon ng P500. Masaya ako, malaking tulong yan para sa amin." she said.

The media briefing will be held virtually on December 3 from 2:00 PM onwards.

The media briefing will be participated by the 16 new NPTE members, namely: Dr. Jihan Adil, Dr. Nathaniel Alibuyog, Dr. Zenaida Andrade, Dr. Wilfredo Campos, Dr. Gay Defiesta, Dr. Ramon Lorenzo Luis Guinto, Dr. Eduardo Mangaoang, Dr. Jimmy Masagca, Dr. Susan Mercado, Dr. Richard Muallil, Dr. Fmma Porio. According to data gathered by the DOF, the Philippines' total estimated losses and damages from 2010 to 2020 from climate hazards have already reached a staggering P515.51 billion (around US\$10.6 billion).

Despite being an insignificant contributor to Greenhouse Gas (GHG) Emissions globally—as the country accounts for only 0.3 percent of the global pollution—the numbers reaffirm the CCC's need to come up with more climate resilient action plans for a high risk developing economy like the Philippines.

Last October 13, the Department launched the newly reconstituted NPTE under the CCC.

In the following months, NPTE identified the Top 10 climate-induced risks in the Philippines and then presented action plans and strategies to the DOF.

Finance Secretary Dominguez adopted the actions and further instructed the CCC to integrate the NPTE's presentations with the National Climate Change Action

Dominguez is chairman-designate of the CCC and headed the Philippine delegation at the 26th United Nations Climate Change Conference of the Parties (COP26) in Glasgow, Scotland.

At the COP26 summit, Dominguez said "We realize that we are one of the most vulnerable countries to climate change and we have decided to take action on our own and we will not wait for international agreements on climate change. However, we hope that this COP26 will result in positive action and will start the flow of funds to help countries.'

As its Nationally Determined Contribution (NDC) to the Paris Agreement, the Philippines has committed to a projected greenhouse gas emission reduction and avoidance of 75 percent from 2020 to 2030 for agriculture, wastes, industry, transport, and energy sectors.
