Bridges are a critical link to the development of a modern city. They essentially ease traffic congestion in the cityscape by providing alternative routes and access to the rest of the bigger metropolitan area.

Metro Manila needs such bridges to connect major cities and municipalities, and improve travel time. The Asian Development Bank offered timely assistance the other day after approving a \$175-million (around P8.75 billion) loan to help the Philippine government build three new climate- and disaster-resilient bridges over the Marikina River to improve road traffic flow, amid the rapid urbanization of Metro Manila.

The new projects aim to connect motorists to the planned Marcos Highway–St. Mary Avenue Bridge. Homeowner's Drive-A. Bonifacio Bridge and Kabayani Street-Matandang Balara Bridge. The bridges, in the words of the ADB, will create jobs, improve the living conditions of residents near the river and provide them with better access to the rest of Metro Manila.700

tion that, in turn, causes "substantial loss of time and opportunities for commuters and businesses, respectively." The National Economic and Development Authority earlier estimated that the country lost P3.5 billion a day in 2017 due to Metro Manila's traffic. The loss is projected to reach P5.4 billion a day in 2035 if no action is taken.

The Philippines, perhaps, can learn from the Seoul experience. The South Korean capital supplemented its development as a modern metropolis through the construction of 31 bridges over the Han River linking metropolitan Seoul and some parts of Gyeonggi, the most populous province surrounding the capital city.

The Pasig River and the Marikina River are two of the major waterways that snake around Metro Manila. More bridges over these two rivers will certainly decongest the traffic along the cities traversed by the waterways. New business and livelihood opportunities will then emerge from these infrastructure projects and that's progress.

To continuously improve the competitiveness of micro, small, and medium enterprises (MSMEs) in Cavite and the entire CALABARZON region, the Department of Trade and Industry and De La Salle University - Dasmariñas (DLSU-D) partnered for the establishment of an Innovation Laboratory (InnoLab), a P24M Fabrication Laboratory funded under DTI's Shared Service Facility (SSF) Program.

Gatchalian inspects extent of Typhoon Odette's wrath; extends aid to affected provinces

As damage to property and number of casualties continue to climb days after Typhoon Odette struck Visayas and Mindanao, Senator Win Gatchalian flies to the calamity-stricken areas today, December 21, to extend assistance and to personally assess the situation in the devastated areas.

"Sa tindi at lawak ng pinsalang iniwan ng bagyong Odette, kailangang pagtulungan natin ang pagbibigay ng ayuda sa mga apektadong pamilya, maging sa mga lokal na pamahalaan. Makakatulong itong maibsan ang mga alalahanin nila sa kasalukuyan," the senator said.

The Senate Economic Affairs Committee Vice Chairperson is set to visit Southern Leyte, Bohol, and Surigao del Norte until December 23 to distribute aid.

The senator brings with him P26 million assistance in the form of cash and in kind from Valenzuela City, the senator's hometown. He will personally hand over the assistance to the local officials. The senator will be joined by Valenzuela Vice Mayor Lorie Natividad-Borja.

The Valenzuela City Council passed a resolution on Monday, December 20, authorizing Mayor Rex Gatchalian to release the said assistance from the quick response fund (QRF) of the Local Disaster Risk Reduction and Management Fund (LDRRMF) to Southern Leyte, Bohol, Surigao del Norte, Cebu, and Dinagat islands.

The senator will also donate sacks of rice to the local government units of the said affected areas. Gatchalian is likewise set to make rounds in

various evacuation centers to ascertain how the national government can step up the relief and rehabilitation efforts.

The Senate Energy Committee Chairperson has earlier urged the National Electrification Administration (NEA) to immediately tap the Electric Cooperatives Emergency and Resiliency Fund (ECERF) in order to provide relief to electric cooperatives affected by Typhoon Odette and assure that there will be electricity in affected areas come Christmas.

"Hindi natatapos sa pagbibigay ng pang madaliang ayuda ang ating pagtulong sa mga biktima ng nagdaang bagyo. Sisiguraduhin natin na mabibigyan din sila ng pang matagalang tulong upang maging mas masaya ang kanilang pasko hindi lang ngayong taon, kundi sa mga darating pa," he said.

Allowing overseas Filipinos to come home especially this Christmas is our sacred duty as a nation and our debt to our overseas heroes.

This is the earnest appeal of Presidential Adviser for Entrepreneurship and Go Negosyo founder Joey Concepcion, who is asking the national government to exercise flexibility in its caps on arriving passengers at the NAIA. Many overseas

Filipinos are flying home for family reunions this December and in January 2022 but arrival caps on arriving passengers might lead to stranded OFWs, and overwhelm Philippine embassies and diplomatic posts abroad, especially in OFW-heavy countries such as those in the Middle East.

"The pandemic kept families away from each other, but as rates of vaccination increase in the country and lower cases are being reported, it opens up opportunities for loved ones to reunite. We should at least give our kababayans this chance," Concepcion said.

The government had earlier imposed a quota of only 4,000 arriving passengers per day at the NAIA. The move was in response to fears of the spread of the Omicron variant and has led to forced cancellations of many inbound flights, and consequently prevented OFWs abroad from heading home this Christmas.

"We are not asking to lift the arrival caps," Dexter Lee, Philippine Airlines Senior VP for strategy and planning clarified. "What we are asking is some cooperation with the airlines to maximize the cap from where it is today. For example, we can exclude non-OFWs from the cap since they book their own hotel rooms anyway," he said.

The suggestion is in response to reports of a bottleneck resulting in a shortage of hotel rooms in the NCR meant specifically for returning OFWs. The shortage resulted in flight cancellations and affected OFWs who had already booked their flights.

Airlines are reported to be facing heavy fines should they exceed their individual quotas. This despite

earlier efforts by health authorities, airlines, local hotels and the OWWA to anticipate the influx of inbound OFWs, including planned increases in international flights from Middle East and Asian countries and calibrated adjustments to quaran-

tine requirements. "We have established solid quarantine and testing protocols for arriving passengers that effectively screen out any community transmission of Omicron and other COVID variants from arriving travelers," Concepcion said in a separate interview.

"We have the resources in place to guard against Omicron without afflicting our OFWs and other returning Filipinos, so we should have the confidence and foresight to increase our arrival quotas to enable our countrymen to fly home," he added.

PAL's One-Stop-Shop facility at the NAIA shows a testing positivity rate of only 0.54% as of December. The RT-PCR testing requirements before travel serve to identify positive cases, with these being isolated and resolved before release from quarantine.

Concepcion said that airlines can work with OWWA in sourcing more hotel rooms, saying that airlines like PAL can ensure that returning overseas Filipinos already have pre-arranged hotel reservations in Metro Manila. and they are offering to assist OWWA in finding hotel rooms for OFWs. The OWWA is in charge of finding OFW quarantine accommodations.

Moreover, other airlines would have their own arrangements with hotels that OWWA could tap. It is estimated that the OWWA will need to block 25,000 rooms during critical weeks for OFWs.

"Government can work with the airlines to increase the number of quarantine rooms so we can accommodate as many OFWs as possible," said Concepcion. "To airlines and hotels, we must have a partnership approach, not a punitive approach," said Concepcion. He also cited local efforts to increase vaccinations and speed up booster shots are helping drive down fresh cases of COVID in the coun-

LGUs

MANILA – Malacañang on Wednesday enjoined local government units (LGUs) in areas not affected by Typhoon Odette to ramp up their vaccination efforts, including on weekends.

This was after acting Presidential Spokesperson, Cabinet Secretary Karlo Nograles, said the national government is sticking to its goal of fully vaccinating 54 million Filipinos by yearend despite the postponement of vaccination in typhoon-hit areas.

"All local (vaccination operation centers) shall be provided with new targets to meet the goal of vaccinating 54 million and are enjoined to ramp up the administration of Covid-19 vaccines until Dec. 31, 2021, including weekends," Nograles said in a Palace press briefing.

He explained that changes in vaccination targets of LGUs were done to consider what is happening on the ground after the typhoon.

"Ibig sabihin (this means), we are mindful, aware, and sensitive to the realities on the ground, especially para du'n sa mga tinamaan ng (to those affected by) Typhoon Odette. And we know that local government units na tinamaan ng (hit by) Typhoon Odette will still be very busy in all their repair, rehab, recovery efforts para sa kanilang mga kababayan (for their constituents)," Nograles said. "Those na hindi masyado o hindi gaano apektado doon sa pananalasa nitong (not severely affected by) Typhoon Odette, we will call upon them to ramp up the vaccination efforts."

He noted that typhoon-hit LGUs could resume inoculation after prioritizing rehabilitation efforts.

"To those affected by Typhoon Odette, of course, the priority will be their rehab and recovery pero (but) if as soon as they're ready, if they're ready within the year, and makita naman po natin na makayanan din po natin na bigyan ng konting (if we see that we could give them a little) push for the vaccination efforts doon (there), we will do the same," he said.

The Philippines aims to fully vaccinate more than 54 million Filipinos by yearend through the second phase of its simultaneous vaccination drive against Covid-19, "Bayanihan, Bakunahan".

As of Tuesday, 58.71 percent of the country's target population or more than 45 million Filipinos are fully vaccinated.

The first "Bayanihan, Bakunahan" was held from November 29 to December 1 and was extended until December 3 in some areas.

Phase 2 of the vaccination drive kicked off on December 15, but typhoon-hit areas have yet to hold their "Bayanihan, Bakunahan" campaign. (PNA)



Hope on the Horizon: Amidst COVID, Microinsurance Protects the Poor by Jaime Aristotle B. Alip, PhD

With 2,643,494 recorded cases and 39,232 deaths as of October 8, 2021, COVID has wrought unprecedented hardship for the Philippines --despite the adoption of stringent lockdowns since the pandemic started in 2020. The spikes in COVID cases, especially the recent surge caused by the Delta variant, not only placed pressure on the national health care system, it also hampered plans to expand health insurance coverage due to the ensuing economic challenges. It highlighted the insurance dap in the Philippines, where penetration stands at around 1.71 percent of GDP.

But there is a silver lining. With the health crisis came an increase in insurance awareness and greater demand for health insurance. Even those from low-income groups understand now the need for financial protection against unexpected shocks, recognizing that an illness or death in the family could bring them deeper into poverty. Last May, the Insurance Commission (IC) reported that the number of lives covered by microinsurance products in 2020 hit 50.35 million, an 11.56 percent increase from 45.13 million in 2019. Amidst the COVID pandemic, microinsurance has become a lifeline for Filipinos, even those with low income and limited access to mainstream insurance services.

Clearly, the government needs to support microinsurance and facilitate protection coverage to the most vulnerable sectors. This is crucial, especially during this pandemic.

Microinsurance MBAs

Povertv alleviation is central to our development agenda, as outlined in "AmBisyon Natin 2040" and the "Philippine Development Plan 2017-2022." This involves building people's socioeconomic resilience through the provision of universal and transformative social protection, including insurance mobilization. Unfortunately, health insurance under PhilHealth, with its limited coverage and benefits, remains inadequate. while

mainstream insurance companies have failed to penetrate the low-income and poor market segment. Enter microin-

As the name surance. suggests, this pertains to affordable insurance products intended for the poor and low-income families. These are usually offered by mutual benefit associations (MBAs) which must register with the Securities and Exchange Commission (SEC) and apply for license from the Insurance Commission (IC) as a non-stock, nonprofit association and insurance provider in line with Sec. 404 of the Revised Insurance Code. The IC laid down the policy framework for microinsurance fifteen years ago, through Memorandum Circular 9-2006, which introduced Microinsurance Mutual Benefit Associations (Mi-MBAs). These are member-owned and governed microinsurance providers that offer insurance to members. pay claim faster (within a few days from the date of claims notice), and distribute products using the social distribution network of partner microfinance institutions (MFIs). This Circular regularized previously informal MFI and NGO arrangements in microinsurance provision, and Mi-MBAs eventually became key drivers of microinsurance development, providing simple, affordable, and accessible microinsurance products to low-income families.

The 2010 National Strategy and the Regulatory Framework for Microinsurance facilitated further growth of the microinsurance industry, with rural banks, thrift banks, and even mainstream insurance outfits and fintech companies becoming players. Within this ecosystem is a niche for Mi-MBAs, led by the Microinsurance MBA Association of the Philippines (MiMAP), which presently covers 62 per cent of the microinsurance market.

A total of eighteen Mi-MBAs under Mi-MAP have a combined outreach of 7 million individual members nationwide, majority of whom are micro-entrepreneurs, small farmers and fishermen. As microinsurance coverage is extended to members' families the (with 4 as average family size), MiMAP currently insures 28 million Filipinos. The Mi-MBAs provide basic life family microinsurance plans and a range of optional life plans that include coverage for health and retirement. In 2019, the mobilization of such membership accumulated a total of PhP 4.81 billion in contributions and premiums, paid PhP 1.43 billion in claims benefits, and reserved PhP 1.95 billion in refundable equity value to members. These Mi-MBAs have significantly contributed to greater financial inclusion and financial literacy for poor and low-income Filipinos. Tax Ex-

emption Mi-MBAs are crucial to financial inclusion, as they are community-based organizations able to penetrate hardto-reach and frontier areas where conventional insurance providers dare not go. During this period of pandemic. Mi-MBAs helped in alleviating the plight of the poor and those most vulnerable to economic shocks. Even as they suspended the collection of contributions and extended the grace period for payments, Mi-MBAs continued to pay claims benefits Under very difficult operational and business circumstances during the first five months of community guarantine from March to August 2020, Mi-MBAs paid a total of 27,657 death claims worth PhP 613.54 million, 667 of which are COVID-related

Since Mi-MBAs are non-stock, non-profit microinsurance providers that operate for the exclusive benefit of their members, they are exempted from paying tax on corporations, tax on life insurance premiums and documentary stamp tax under the Insurance Code and the National Internal Revenue Code. Unfortunately, not all Mi-MBAs are able to avail of these exemptions as tax authorities vary in their interpretation of the applicable provisions. MiMAP reports that some of their members have been issued notices of tax deficiencies, while others were denied tax exemption status. Many Mi-MBAs, in fact, are still waiting for the BIR ruling on their application for tax exemption.

This is sad, since

Mi-MBAs already operate on very thin margins because of their restricted capacity to spend only up to a maximum 20% of their contributions for administrative and operating expenses. The situation exacerbates their resource constraints, inhibiting them from optimizing or upgrading their management information systems. It behooves the

government to ensure that Mi-MBAs enjoy the tax exemptions granted to them under the law. Mi-MBAs, after all, are managed by grassroots organizations composed of low-income families. Their members and target clients are also poor, mostly belonging to the informal sector. They provide necessary financial services to the most vulnerable, contributing to poverty alleviation and financial inclusion. Mi-MBAs could serve more Filipinos if they can fully enjoy their tax exemptions, which could help them digitize their operations -- a necessity given that mobility and face-toface interaction are greatly limited by the pandem-

Tax Reduction for Non-Life Insurance

Tax rules also impede market development with respect to nonlife insurance. Usually, as the market matures, a more diverse range of products is expected, to serve broader customer

Let's grow your business, together, needs and to diversify insurers' risk portfolio. This is not the case here, because general taxation for the non-life insurance sector reaches as high as 27 percent, one of the highest in Southeast Asia. This discourages insurers from offering complex products, such as disaster and agricultural insurance, both highly relevant to the low-income population. The tax on nonlife insurance products, including crop insurance, should be reduced to 2

percent, or the current rate imposed on life insurance products. Cutting the tax on non-life insurance premium will significantly raise the number of private insurance offerings. There will be no need for government to subsidize agri-insurance because the regime will be market-driven.

Microinsurance has come a long way in the Philippines. From a coverage of less than three million low-income Filipinos in 2007, the number has surged to more than 50 million last year. Microinsurance MBAs, in particular, significantly contribute to poverty alleviation, financial inclusion and literacy by providing affordable and relevant risk protection to poor and underserved households. But millions of poor families remain unprotected and vulnerable. With natural disasters always a possibility given climate change, and the threats

posed by the COVID pandemic. we should find ways to support the growth of the microinsurance industry. As the 2022 election draws near, those who aspire to be the country's next leaders should champion financial inclusion for the poor, and include microfinance and microinsurance in their battle-cry. Their campaign to provide affordable and relevant risk protection to millions of Filipinos from low-income families would serve them well come election time.

Dr. Jaime Aristotle B. Alip is a poverty eradication advocate, with more than 35 years of experience in microfinance and social development.
