LGU GenTritightens quarantine protocols due to surge in 22 COVID-19 cases

Cavite Provincial Government in partnership with the Local Disaster Risk Reduction and Management offices of different LGUs in Cavite and in Batangas successfully conducted the simulation exercises for the Taal Volcano Eruption Evacuation Plan on Monday, March 15, 2021 amid drizzly weather and challenging routes.

Participating teams in the simulation mainly from the Philippine National Police headed by PMAJ Jonathan Asnan, Chief for Operations of the Cavite-Police Provincial Office, converged at two assembly areas, the Tagaytay City Evacuation Center in Brgy. Sungay West and at Amuyong-Alfonso Crossing early in the morning to receive final instructions prior to take off heading to the different pickup areas in the four municipalities of Batangas — Talisay, Agoncillo, Lemery and Laurel.

Pick up areas in Talisay were Banga Elementary School, Caloocan Covered Court and Old Sampaloc Barangay Hall while for Agoncillo is Barigon Elementary School. In Lemery, the pickup up location is Payapa National High School, and Montevideo De Tagaytay in Brgy. Dayap Itaas for the municipality of Laurel. Around 830 participants taking the role as Individually Displaced Individuals (IDPs) were transported to Cavite from all the pickup locations.

All the IDPs were initially taken to the COVID-19 swabbing stations, one at Tagaytay City Evacuation Center and the other at Pansin Elementary School in Alfonso. Sample swabbing using Antigen test kits were done on site by medical personnel from Cavite Provincial Health Office headed by Provincial Epidemiologist Dr. Nelson Soriano. Those with negative re-

Some LGUs bungled their job

They religiously wore face masks and face shields, practiced social distancing, washed their hands frequently, and shunned many of their previous routines in order to avoid COVID-19. Others worked from home.

The working class, or those who have no choice but to report physically to their workplaces, followed the health protocols mandated by authorities to survive and feed their families. They are the few lucky ones who have kept their jobs and stayed healthy despite the challenges.

Some LGUs bungled their job

Over a year into various forms of lockdown, a majority of the Filipinos have learned to live with the coronavirus. Others worked from home. The working class, or those who have no choice but to report physically to their workplaces, followed the health protocols mandated by authorities to survive and feed their families. They are the few lucky ones who have kept their jobs and stayed healthy despite the challeng-

But the spike in COVID-19 cases is threatening the interest of the working class and their only livelihood. Metro Manila mayors, for instance, have imposed longer curfew hours in their attempt to stem the tide of rising COVID-19 cases in the capital region. Selective lockdowns, longer curfew hours a stay-at-home order for all children are now being implemented to contain the virus spread.

Majority of the Metro Manila mayors, however,

should be held accountable for the virus spike. Local executives down to the barangay tanods were lax in enforcing the health protocols that many workers seriously followed.

Underage children can be seen roaming the streets of Quezon City, Manila, Caloocan, San Juan, Mandaluyong and the other urban capitals day in and day out right under the noses of barangay officials and policemen during the lockdown period. Many violated the health protocols, such as wearing of face masks and social distancing, and yet barangay authorities and the local police ignored the infraction.

The working class will suffer much from the new restrictions and the extended curfew ordered by Metro Manila mayors. Longer curfew hours mean reduced working hours in restaurants and malls, and fewer customers. These, in turn, will mean less sales and possibly retrenchment for some of the crews and staff of restaurants and other retail outlets.

Had some of LGUs done their job in curbing the infection over the past 12 months, they would have generated jobs and alleviated the plight of their poorer constituents.

Cayetano...

Former House Speaker Alan Peter Cayetano on Wednesday urged the government to act swiftly on implementing the vaccination roll-out program and social welfare measures to help Filipinos amidst the COVID-19 pandemic.

In an interview with RMN Nationwide on March 17, Cayetano said standard protocols such as handwashing and physical distancing are not enough to counter the virus's spread.

Cayetano made

the statement after OC-TA-Research, an independent research group, said daily new infections could reach 20,000 by April. The Department of Health (DOH) had reported 5,404 new cases last Monday, the highest daily tally of cases since August last

"One year na since the lockdown and siguro ay natuto tayong maging mas madasalin. Having said that, the government should not only be responsible, dapat ay hindi sila balat-sibuyas

kasi ang government dapat accountable sa tao," he said.

(It's been a year since the lockdown and we have learned to be more prayerful. Having said that, the government should not only be responsible, it should be more receptive to criticism because it is accountable to the people.)

"So kailangan 'yung plano ng gobyerno ay clear and kailangan 'yung accountability. So 'yung mga ospital nagcocomply ba na 30 percent ay COVID ang beds? 'Yung vaccination ay nahuli tayo, so ngayon ba ay namemeet 'yung daily na pagbakuna sa frontliners?" he added.

(So we need a

clear plan from the government, as well as to hold it accountable. Are hospitals able to comply with the 30 percent requirement for COVID-designated beds? We lagged behind in our vaccination roll-out, but is the daily target now being met for frontliner vaccination?)

Cayetano also stressed that there should be no VIPs in the vaccination, especially since many local government units are still worried that they might not be given or might not be able to afford the vaccines.

He said the government has the responsibility to uplift the lives of those gravely affected by the pandemic through decisive and resolute action. Cayetano also made a push for the 10K Ayuda Bill which he and his allies filed on February 1.

"Kung titignan mo lahat no, maraming not in our control, katulad nung bagong variation. Pero 'yung pananalapi ng ating bansa, at 'yung kalagayan ng ating kababayan, we are not only responsible for that, we are in a position to help dahil may pera naman ang gobyerno. So itong P10,000 kada pamilya ay itinutulak namin at hinihingi namin sa Kongreso na aksyunan na ito," he said.

(As we see it, there are many things outside our control, such as the new variants of the virus. But as far as

our fiscal capacity and for the state of our fellowmen are concerned, we are not only responsible for that -we are in a position to help because the government has the funding for it. This is why we are urging Congress to act on providing P10,000 per family.)

The 10K Ayuda Bill (House Bill No. 5897) aims to provide Filipino families, especially the poorest of the poor, with P10,000 in cash aid that would help them through the pandemic while the country waits for the full implementation of the COVID-19 vaccination plan.

The Committee on Social Services, however, has yet to tackle the proposed measure. (PR)

Gen. Trias Mayor Antonio 'Ony' Ferrer issued Executive Order no. 08 S. 2021 for the implementation of a more rigorous public health protocols to curtail the further spread of the pandemic in the city.

The local chief executive together with Vice Mayor Morit Sison conferred with the Chief of Police of the General Trias Component City Police Station and all Sub-Station Commanders for the strict and immediate implementation of said executive order.

This developed due to the alarming surge in the number of CoViD-19 cases in the city in the past four weeks

According to the GenTri City Epidemiology and Surveillance Unit (CESU), from the total of 21 active cases in February 16, 2021 the number of active cases ballooned to 126 from the latest addition of 16 new cases as of March 16, 2021.

EO 08 s. 2021 states that curfew hours in the city will be enforced from 10pm-5am while curfew for children aged 10-15 years is 6pm to 7am. Residents aged between 16-65 years are allowed to leave their residence while Authorized Persons Outside of Residence (APOR) are exempted provided they show proper identification in control/checkpoints.

Liquor ban in the city will be implemented from March 15 - April 15, 2021

All forms of public, mass or social gatherings including weddings, birthdays, funerals, entertainment activities are limited to 10 persons or fifty percent (50%) of venue capacity which also applies to restaurant dine-

in services.

In the observance of the Holy Week, Visita Iglesia by non-residents will be prohibited and only designated churches can be visited on Maundy Thursday. These are the historic St. Francis of Asisi Church in the town proper, St. Vincent Ferrer Parish in Manggahan, Our Lady of Guadalupe in Barangay Javalera, San Gabriel Arkangel Parish in Barangay San Francisco, and The Annunciation Parish in Barangay Pasong Camachile.

Meanwhile, mourning rites or funeral wakes will be regulated to five (5) days if the cause of death is not CoViD-related, while immediate internment is mandatory for CoViD-related deaths.

Entry to all returning residents and OFs will require coordination with the Barangay Health Emergency Response Team (BHERT) upon arrival at the city for recording and initial medical evaluation.

Only symptomatic individuals are required to undergo the 14-day facility-based quarantine and the RT-PCR swab test while asymptomatic returning residents and OFs are exempted from the swab test.

Moreover, violation of the mandatory wearing of face mask and face shield in public places, and in private and public transportation and inside establishments at all times will be subject to commensurate penalties according to the law.

According to local authorities, at least 19 individuals were arrested on the first night of the implementation of the order that took effect Monday, March 15 on violation of curfew hours and liquor ban. (PIA)

Sustained psychosocial support to learners needed amidst surge in suicide cases

Following the Philippine Statistics Authority's (PSA) report that deaths related to suicide are up by 25.7 percent in 2020 compared to 2019, Senator Win Gatchalian seeks the continued provision of psychosocial support to the country's K to 12 learners.

According to the PSA, cases of intentional selfharm recorded in 2020 increased to 3,529 from 2,808 in 2019. The past year also saw an increase in the number of calls to the National Center for Mental Health (NCMH). From May 2019 to February 2020, the center received 400 monthly average calls, which increased to 953 calls from March to May 2020. From March 17 to October 6, 2020, the monthly average calls were 907. The monthly average calls related to suicide were 53.

Gatchalian pointed out that the country's learners are especially vulnerable because they had to bear the brunt of a yearlong school shutdown and home confinement. Prior to the pandemic, the Filipino youth was struggling with mental health woes. A 2015 survey by the World Health Organization (WHO) showed that 16.8 percent of 8,761 student-participants aged 13-17 attempted suicide one or more times a year before the survey.

In an advocacy brief, the United Nations Children's Fund (UNICEF) warned that containment measures and school closures make children feel isolated. Among the consequences of these are anxiety and sleep problems, which are also caused by increased gadget usage, irregular eating habits, and reduced physical activity. Aside from isolation, other stressors include health-related fears and financial losses.

"Dapat nating bigyan ng prayoridad ang kapakanan at mental health ng mga kabataan, lalo na't isang taon na nilang hindi nakakasalamuha nang personal ang kanilang mga guro at kamag-aral," said the Chairman of the Senate Committee on Basic Education, Arts and Cul-

Gatchalian proposed that psychosocial support programs train both teachers and learners in identifying risky behavior, including those related to suicide, so they can be addressed or reported to proper authorities.

The lawmaker also pointed out that under Republic Act 11036 or the Mental Health Act. educational institutions are mandated to raise awareness on mental health issues, provide support and services for individuals at risk, and facilitate access, including referral mechanisms, to treatment and psychosocial support.



Dominguez: Furth reforms to let PHI build back better nost-Covin

Finance Secretary Carlos Dominguez III said Wednesday the Duterte administration's steadfast resolve to undertake further reforms to rebuild a strong and inclusive economy--and set the stage for a "sustainable, greener and healthier future" for the Filipino people--will enable the Philippines to thrive in the post-pandemic era.

Dominguez said among these reforms are improvements in the country's information and communications technology (ICT) infrastructure to expand the use of digital tools, enhance revenue collection performance and achieve greater financial inclusion for Filipinos.

The government should also pursue sustainable policies targeted towards bolstering the healthcare system and keeping a strong fiscal position to withstand future adversities, Dominguez said.

Dominguez underscored in an Asian Development Bank (ADB) event the need to intensify global collaboration and redefine the challenges that confront the world today as it reemerges from a debilitating COVID-19 pandemic, so that countries can be better prepared to deal with future outbreaks.

On the part of the Philippines, Dominguez expressed confidence in its capability to emerge stronger from the pandemic.

"We are very optimistic about the near future. That optimism is based on our willingness to undertake the reforms necessary to rebuild a strong and inclusive economy that thrives in the 21st century. We are also doing our utmost to provide a sustainable, greener, and healthier future for our Filipino people," said Dominguez in his keynote address at the opening plenary of the ADB-hosted Southeast Asia Development Symposium (SEADS).

Infrastructure modernization through President Duterte's signature program "Build, Build, Build, Build" will remain the cornerstone of the Philippines' recovery plan, complemented by tax reform and other economic stimulus measures for businesses, and investor-friendly legislation being pushed by his economic team in the Congress, said Dominguez, the governor of the Philippines in the ADB.

The virtual SEADS led by ADB President Masatsugu Asakawa was expected to gather over 3,000 participants from ADB's member-economies and partner-institutions during the two-day gathering.

With the theme "Innovation through Collaboration: Planning for Inclusive Post-COVID-19 Recovery," the ADB said SEADS will provide governments in Southeast Asia "with a unique opportunity to interact directly with each other, and with leaders from industry, academia, and the development sector, to discuss innovative approaches and solutions to the COVID-19 crisis and other development challenges."

Dominguez noted that despite supply challenges, most countries--including the Philippines--have begun rolling out their vaccination programs, a development that has "inspired market optimism" and "a sense that the worst is over and our economies can be fully functional in a matter of months."

"The availability of vaccines, however, should not lead us to neglect equally urgent concerns. We still need to do the tough things we must undertake to cope with the severe weather conditions induced by global warming or with the possible emergence of new viruses," he said.



Dominguez said the Philippines will strive to ensure the sustainable growth of its economy over the long term by adopting climate-resilient and adaptation strategies, knowing fully well that unlike COVID-19, for which vaccines have been produced in a matter of months, there is no quick solution to the climate crisis.

"We need to act now with the same sense of urgency that we have for the ongoing pandemic," he said.

Dominguez, who is chairperson-designate of the Climate Change Commission (CCC), reiterated his strong push for a legislative measure that will ban single-use plastics as a way to jumpstart the country's fight against climate change and encourage all Filipinos to do their part in helping save the environment on a daily basis.

Learning from the Philippine experience in dealing with the COVID-19 pandemic, Dominguez said this global health crisis exposed the country's weaknesses in providing emergency aid to low-income families as it does not have a national ID system in place to speed up the delivery of cash assistance to the intended beneficiaries.

While the pandemic experience showed the need to accelerate the rollout of a unified national ID database, Dominguez said it also taught the government to adapt quickly by embracing a digital-only mindset, which was what happened with the successful implementation by the Department of Finance (DOF), Bureau of Internal Revenue (BIR) and Social Security System (SSS) of the Small Business Wage Subsidy (SBWS) Program for displaced workers in small businesses.

The limitations forced by the pandemic also underscored the importance of rapidly upgrading the country's digital financial transaction systems, including the use of electronic means to improve tax collection performance, which resulted to revenue agencies overshooting their respective adjusted collection targets in 2020, he said.

He said digital tools to broaden financial inclusion were also launched amid the pandemic, among them the Digital PERA (Personal Equity Retirement Account) and the Bonds.PH mobile application for the country's domestic bond offerings.

Dominguez said that amid these developments, the government came financially ready to meet the challenges of the pandemic, given the President's policy of fiscal prudence and discipline, and the implementation of his Comprehensive Tax Reform Program (CTRP).

"From a fiscal standpoint, the health crisis and the economic contraction it precipitated posed a most difficult challenge. The crisis meant additional unplanned spending. The economic downturn meant a reduction in revenue flows to the government. Despite all these, we did not abandon the judicious financial management set by President Duterte



when he assumed office," Dominguez said.

"Through the darkest times of the pandemic last year, we were never under the illusion that this challenge would be short. We were prepared to fight a long battle, exercising prudence over the use of our fiscal resources. The worst we could have done was to run out of water before the fire went out," he said.

As the Philippines begins to recover from the COVID-19 crisis, Dominguez said the government will remain focused on reforms to foster the revival of enterprises and restore consumer activity.

These pending reforms include the Corporate Recovery and Tax Incentives for Enterprises Act (CREATE), which is the biggest stimulus program ever for businesses in the form of hefty reductions in corporate income taxes and other benefits to aid in their recovery, Dominguez said.

The Financial Institutions Strategic Transfer (FIST) law, on the other hand, will allow banks to efficiently offload their soured loans and non-performing assets (NPAs) so that they can extend more credit to micro, small and medium enterprises (MSMEs) in need of assistance.

Dominguez said the Duterte administration is also pushing the congressional passage of the Government Financial Institutions Unified Initiatives to Distressed Enterprises for Economic Recovery (GUIDE) bill to help save strategically important companies by aiding them to address their solvency issues, along with the final packages of the CTRP on improving property valuation and simplifying the tax system on passive income and financial intermediaries.

To further open up the economy and bring in foreign investments, the Congress should also pass doable reforms such as the amendments to the Foreign Investment Act, the Public Service Act, and the Retail Trade Liberalization Act, Dominguez said.

"We also aim to take full advantage of the demographic sweet spot the Philippines enjoys. A much younger population profile means we will have the workforce ready for rapid growth. We have invested heavily in our human capital and hope to reap the rewards further down the road," he added. (PR)

Aguinaldo birth anniversary a special holiday in Cavite

KAWIT, Cavite: President Rodrigo Duterte thru Executive Secretary Salvador Medialdea signed on March 17, 2021 Proclamation 1117, declaring March 22 as a special non-working holiday in the whole province of Cavite.
