### Unnecessary irritation

"It seems clear that there is no intention on the part of the Palace to stand firm on this issue."

In a prime example of gunboat diplomacy, China on Monday denied allegations that maritime militia manned more than 200 Chinese fishing vessels spotted near the Julian Felipe Reef in the West Philippine Sea, and bristled at the "unnecessary irritation" caused by such claims.

The denial issued by the Chinese embassy in Manila was in reaction to a March 20 statement from the National Task Force for the West Philippine Sea (NTF-WPS) that it received a confirmed report from the Philippine Coast Guard (PCG) that about 220 Chinese fishing vessels believed to be manned by Chinese maritime militia personnel were sighted moored in line formation at the Julian Felipe Reef, which is well within the Philippine exclusive economic zone (EEZ).

The task force released photos of the vessels—and an Air Force patrol of the area on March 22 confirmed the presence of the ships.

But in an official statement released on the same day, the Chinese embassy in Manila merely said it took note of statements made by the Philippines on the matter, denied the presence of its maritime militia and described the massing of 220 ships near Julian Felipe Reef (Whitsun reef) as a "normal practice" of fishing vessels.

The embassy referred to Julian Felipe Reef by its Chinese name, and insisted it was part of China's territory.

It then defended the presence of 220 Chinese vessels moored near reef, saying it was a "normal practice for Chinese fishing vessels" to take shelter due to "rough sea conditions."

This was in contrast to the government task force monitoring the contested waters, which said "despite clear weather at the time, the Chinese vessels massed at the reef showed no actual fishing activities."

The US government said it shared concerns over the presence of the 220 Chinese militia vessels in the West Philippine Sea, noting that such vessels have been mooring in the area "for many months in increasing numbers, regardless of the weather."

"We share the concerns of our Philippine al-

lies. The [People's Republic of China] uses maritime militia to intimidate, provoke, and threaten other nations, which undermines peace and security in the region," the US embassy in Manila said.

The Palace, which in the past has bent over backwards to appease Beijing in the name of better relations, simply said President Duterte would meet with the Chinese ambassador at an unspecified date to discuss the issue.

Since both countries are "close friends," they can talk everything out, the President's mouth-piece said.

It was hardly a ringing endorsement of the observations of the Philippine military, but we have learned to scale down our expectations where China is concerned.

We are all for speaking softly and carrying a big stick—but it seems clear that there is no intention on the part of the Palace to stand firm on this issue, even if just to dress down an obnoxious envoy who himself is an unnecessary irritation.



## More efficient roll-out of DepEd Computerization Program needed

Though the Bureau of Customs has repeatedly donated seized gadgets to the Department of Education (DepEd) to support distance learning, Senator Win Gatchalian said the education department should also ensure a more efficient implementation of its own computerization program.

The DepEd Computerization Program (DCP) aims to respond to the computer backlog of public schools and provide these schools with appropriate technologies to enhance the teaching-learning process and "meet the challenges of the 21st century." The DCP also aims to provide computer laboratory packages to secondary schools, e-classroom to elementary schools, and laptops for mobile teachers.

Under the 2021 General Appropriations Act, the DCP has an allocation of P5.9 billion. The program, however, is hounded by implementation woes, which should be immediately addressed, said Gatchalian. In its 2019 audit, the Commission on Audit (COA) said that from 2015 to 2019, the DCP only met 59.43 percent of its target. This means that only 8,523 out of 14,342 targeted schools nationwide received ICT packages. The COA also flagged that more than P3.2 billion in payments to suppliers in 2019 were not supported by documentary requirements.

An inspection by the audit body revealed that some schools were not ready to receive the packages because they lack multi-media or computer rooms, proper electrical groundings, wirings and circuit breaker, and window grills.

ICT coordinators also reported that some suppliers did not provide after-sales services. Some of them could no longer be reached through contact details provided. This prevented schools from availing warranty privileges and let suppliers escape liability.

"Nakita natin ngayong panahon ng pandemya na hindi na natin maaaring paghintayin pa ang modernisasyon para sa mga mag-aaral at mga guro. Gatchalian is also eyeing to file a bill that aims to provide laptops and internet allowances to the country's K to 12 learners.

The House Committee on Social Services has finally decided to act on former Speaker Alan Peter Cayetano's 10K Ayuda Bill after mounting pressure from various sectors.

10K Ayuda Bill ...

In a media statement on Thurday morning (March 25), committee chair Quezon City 5th District Rep. Alfred Vargas said the bill will be referred to the Committee on Economic Affairs and will be read in plenary today (Thurday).

He explained that when the bill was referred to his committee, the plenary had already finished discussing the extension of Bayanihan 2 while Bayanihan 3 was already being discussed by the economic affairs committee.

"I suggested the consolidation of this bill with similar measures and its referral to economic affairs. This is more practical since all these bills have similar legislative intent. By doing so, we can facilitate congressional action on these bills. Isang talakayan na lang, sa halip na isa-isa," he said.

Vargas' sudden change of heart came as Cayetano and his allies launched a stronger push for the bill's passage and as other officials, including Senator Christopher Lawrence "Bong" Go, joined the call

Filed by Cayetano, Taguig Rep. Lani in the House of Representatives on February 1, 2021, the 10K Ayuda Bill seeks to give each Filipino family P10,000 or P1,500 per family member, whichever is higher, that they can use for their daily needs or to start their own businesses as the country waits for the full roll-out of the COVID-19 vaccination program. It had been referred to

the Committee on Social Services led by Vargas but languished there for almost two months. (PR)





# Senate approves DITO franchise

MANILA – On the last day of the session before the Holy Week recess, the Senate on Monday approved the franchises of DITO Telecommunity Corp., another telecommunications company, and four broadcast firms.

Senator Grace Poe, the chairperson of the Committee on Public Services, steered the passage of the measures.

The franchise of DITO Telecommunity Corp got the approval of 17 senators, with Senators Risa Hontiveros and Francis Pangilinan voting against it and Senator Panfilo Lacson abstaining.

Previously, the telecommunications sector was being dominated by SMART/Philippine Long Distance Company and Globe Telecommunications.

Poe said the entry of DITO Telecommunity as a new major player in the Philippine telecommunications market would spur the competition for more affordable and better internet and mobile services available to more Filipinos.

House Bill 7332 seeks to renew DITO's franchise for another 25 years. DITO holds a congressional franchise via Mindanao Islamic Telephone Company, Inc., which is set to expire in 2023.

DITO, which was launched commercially last March 8 in various areas in Visayas and Mindanao, was selected as the new major player in the Philippine telecommunications market. It was given a five-year network rollout to realize its commitment to provide at least 55 mbps (megabits per second) of mobile data connectivity to at least 84 percent of the country's population.

The Senate also approved on third and final reading House Bill 7615, under Committee Report No. 207, which seeks to grant the franchise of Instant Data Inc.

Other approved

on third reading were four broadcast franchise applications. These are:

-- House Bill 7488, under Committee Report No. 212, seeks to grant the franchise of Davao City Radio Broadcasting Station. In light of the priority agenda of the Davao City government on disaster risk reduction, they plan to set up a community radio for emergency response and preparedness. The broadcast station will also be used to disseminate advocacy campaigns, as well as the city's programs and projects.

House Bill 7616, taking into consideration Senate Bill 1462. under Committee Report No. 214, seeks to renew the franchise of the University of the Philippines System. DZUP 1602 is the official radio station of the University of the Philippines which airs in Mega Manila, Central Luzon, and Southern Tagalog. Its radio programs are the collaborative effort of the different colleges and units of the University.

--House Bill 8553, under Committee Report No. 217, seeks to renew the franchise of Palawan Broadcasting Corp. At present, Palawan Broadcasting Corp. has radio stations in Taytay and Coron, Palawan, and in Catbalogan, Samar. In its early days, the company operates specifically for urgent personal messages known as 'panawagan.' After being shut down during martial law, it continued its broadcast services in 1986 and has been incorporating news, education, and entertainment formats.

-- And House Bill 8860, taking into consideration Senate Bill 2059 under Committee Report No. 221, seeks to grant the franchise of Highland Broadcasting Network Corp. which will provide broadcast services in Northern Mindanao, in unserved and underserved areas specifically the agricultural towns. # Gov't taps P58.4 billion from multilateral lenders for COVID-19 vaccines

The government will soon require cigarette manufacturers planning to set up shop in the country's special economic zones (SEZs) to register with the Bureau of Internal Revenue (BIR) before they can be allowed to operate, in line with the Duterte administration's sustained drive against tax evasion and the illicit tobacco trade.

Finance Secretary Carlos Dominguez III said the alleged illicit activities in SEZs of certain locators registered with the Philippine Economic Zone Authority (PEZA) is "alarming" because on top of enjoying tax breaks granted by the investment promotion agency (IPA), these errant firms have been depriving the government of unpaid income taxes, excise taxes, value-added tax (VAT) and customs duties whenever their illicit products are sold in the local market.

In a letter to Department of Trade and Industry (DTI) Secretary Ramon Lopez regarding this concern, Dominguez said the BIR is now drafting these revised rules covering the operations of cigarette makers inside SEZs.

Dominguez traced the alleged illicit activities of certain PEZA-registered locators in SEZs to "lackadaisical" monitoring and weak enforcement of laws.

Existing PEZA registration requirements do not mandate compliance and submission of secondary licenses or authorization from agencies like the BIR for locator-applicants engaged in the manufacture of regulated products such as cigarettes, medicines, oil and alcohol.

As a result of this loophole, two enterprises which are both PEZA-registered locators, were able to allegedly manufacture unregistered cigarettes inside an SEZ and supply these illicitly to the domestic mart

The BIR Strike Team seized these unregistered cigarettes and several cigarette-making machines from the companies' warehouses and filed a complaint against the firms for violating the Tax Code and incurring deficiency excise taxes.

" The fact that the alleged illicit activities occurred inside the PEZA Ecozone is alarming. Not only did PEZA provide tax breaks to the alleged perpetrators, the government has lost billions of pesos in income taxes, excise taxes, VAT and customs duties when these illicit goods entered the local market," said Dominguez in his letter to Lopez.

Lopez, as Trade Secretary, supervises over the DTI-attached PEZA.

"It appears that these manufacturers took advantage of the lackadaisical monitoring inside the Zone to perpetrate their schemes under the cover of the laws, rules and policies enacted to favor them," Dominguez said.

The BIR raid on the warehouses of the PE-ZA-registered locators was the subject of a recent hearing conducted by the House ways and means committee chaired by Albay Representative Joey Salceda.

Dominguez said he agrees with Salceda's proposal during the hearing that PEZA should also "reinvigorate its police force to patrol the zones against illicit activities" so that the BIR, Bureau of Customs (BOC) and other regulatory agencies can easily avail of its services to enforce laws and rules against violators inside the economic zones.

"Moreover, keeping a close watch on those engaged in manufacturing regulated goods from the moment the raw materials enter the Zones up to the



removal from warehouses is consistent with best practices employed to monitor excisable products and goods," Dominguez added in his letter.

He informed Lopez that the BIR is also reviewing Revenue Regulations (RR) No. 9-2015 after Salceda called on the revenue agency to "uniformly affix stamps on all cigarette packs whether for export or local consumption."

Under RR 9-2015, cigarettes manufactured for exports are required to strictly comply with all existing BIR rules and regulations relating to the registration of brands, manufacture, import, utilization and withdrawal of raw materials; work in process and finished products; labels and posting of export bonds, among others.

"Meanwhile, the interagency meeting (among DOF, BIR, BOC and PEZA) resolved to require secondary licenses, i.e., BIR registration to manufacture cigarettes secured from the Excise Tax Division, prior to issuance of the locator's Certificate of Registration (COR) by the PEZA," Dominguez said.

"We expect the completion of the revised rules by the BIR soon after the PEZA and other stakeholders have provided comments thereon," he added in his letter.

Dominguez told Lopez that the "collaboration among DTI, DOF and the agencies mentioned, is therefore, necessary in order to address the illicit trade both in and out of the Zones."

"We strongly believe that the strong commitment towards this endeavor will further improve investor confidence in our country," Dominguez said. (PR)

# **CONCEPCION: THE VACCINE IS THE SOLUTION TO SAVE BOTH LIVES AND LIVELIHOODS**

## In the recently concluded vaccine forum organized by Go Negosyo and the

Office of Presidential Adviser for Entrepreneurship, PA Joey Concepcion stressed how the vaccines are the solution to the country's dilemma of how to save both lives and livelihoods. The forum, entitled, "Bakit Bakuna: Forum on Why We Need to Get Vaccinated" was held live via Zoom Webinar and simultaneously broadcasted on Facebook through Go Negosyo's official page. The vaccine forum was attended by over 2,000 participants from more than 1,200 companies and was moderated by Josephine Romero, A Dose of Hope Vaccine Program Lead.

"We have been always trying our best. For the private sector, I am glad that many of you have purchased these vaccines for the sake of your employees and of our frontliners. Moving forward, this is where the real war begins and ends. To who will win it, if we can execute well all the way from purchase to actual vaccination, and if we can convince all our employees and our citizens to take the vaccine, then we win the war. Winning the war, we can then open the economy, then we can save lives. This is the solution of saving both lives and livelihoods and nothing else, the vaccine is that solution." Concepcion forwarded.

Through a panel of experts from Rep. Janette Garin, District Representative of Iloilo's 1st District and Private Sector Chief Implementer of ARK-PCR Initiative, Dr. Manuel Dayrit, Former DOH Secretary and Dean at Ateneo School of Medicine and Public Health, Dr. Rontgene Solante, Head of Adult Infectious Diseases Tropical Medicine San Lazaro Hospital and DOST Vaccine Expert Panel Member, Dr. Minguita Padilla, President and CEO of Eyebank Foundation of the Philippines and Project ARK Medical Team Lead, and Dr. Gerardo Gap Legaspi, Director of Philippine General Hospital, numerous questions were answered mostly concerning the effectiveness of the vaccines, contraindications, populations that can or cannot be vaccinated, and what can be improved on to better execute the national vaccination program, among others.

"These are our expectations of a COVID-19 vaccine. One, it should prevent an infection, so once it enters our body, our body should put an antibody and it will not bind to our cells so we would not be transmitting the virus. Second, if it's in our body, then it will not also produce the symptoms, so you will not be admitted. At the same time, since you'll not be admitted, you will be prevented from getting to the hospital because the antibodies are there to protect you and not develop the infection. More importantly, for those who are vulnerable...you prevent them from getting into Intensive Care Unit admission, and obviously, you will prevent death among this population," Dr. Solante expressed.

"I'm confident that the vaccines that have been approved by various regulatory agencies all over the world, that has been tested by their inventors and manufacturers, I'm confident that it's worth taking the chance to get vaccinated for my personal safety, for my family's safety, for my friends' safety, and of course, for the community at large. So I encourage everyone to get vaccinated," Dr. Dayrit promoted.

"Believe in our scientists, listen to our experts, they know what they are doing. They will not risk your life and they all have one desire, the dream to bring back our country, our work, and businesses to where it should be," Rep. Garin affirmed.

"I think we should stop making these vaccines fight each other, [rather] make them work for us by taking them as early as we can...the hope that it has brought to our healthcare workers has given us another extra mileage to go through this pandemic again...Just continue with our four pillars of strategy in fighting this pandemic; one, to fight the fear; two, believe in good science; three, never let our guard down, and; four, we take care of each other—these vaccines are allowing us to do that," Dr. Legaspi advised.

"Kaya nagpabakuna rin kami, not just because to protect ourselves and our loved ones, pero para ipakita rin sa tao na it is safe...The more people who are vaccinated, the more confidence there would be," Dr. Padilla expressed.

"Now we have a solution to this pandemic. Within less than a year, great scientists out there have really engineered these vaccines, and there are so many of them that have been developed. This is where the real war starts, and this is why we have this webinar "Bakit Bakuna." We purchased the vaccines, we have the back-end which is the delivery and the vaccination implementation, then the most important component, convincing our employees to be vaccinated. The success of winning this war is not just buying the vaccines, it's being able to convince every Filipino out there that it is your duty, being called as a soldier in this war, to be vaccinated to protect yourself and others," Concepcion advocated.
